Dear Sr. Alegria:

Attached hereto is a copy of a letter I sent to you on October 15, 2006, whereby, pursuant to Section 76.64(f)(4) of the FCC's Rules, CMCG Puerto Rico LLC ("CMCGPR"), permittee of commercial television station WMEI(TV) ("WMEI"), Arecibo, Puerto Rico, elected **must carry** status for WMEI on its over-the-air broadcast channel, Channel 60.

The letter pointed out that WMEI, subsequent to signing on the air on September 17, 2006, pursuant to automatic Program Test Authority, went off the air. On October 5, 2006, the FCC dismissed CMCGPR's covering license application and allowed the construction permit to lapse. I informed you that CMCGPR was appealing that dismissal and would be back in contact in the event that the FCC were to reinstate operating authority for WMEI.

On October 31, 2006, the FCC's Media Bureau issued a letter-decision reinstating WMEI's construction permit and extending the deadline for the construction of the station by 30 days (until November 30, 2006). On November 29, 2006, WMEI filed a license application with the FCC and signed on the air pursuant to automatic Program Test Authority.

This letter supplements our letter under date of October 16, 2006, and reaffirms CMCGPR's election of **must carry** status.

This letter also constitutes a demand for carriage on Channel 60 of your system. WMEI's over-the-air channel. In the event you are unable to accommodate WMEI on channel 60, CMCGPR will be willing to discuss other channel placement that is at least as favorable to WMEI as its' over the air channel, in CMCGPR's business judgment. CMCGPR also commits to delivering a usable signal to your head-end and will bear the cost of such delivery in the event that you are unable to receive a usable signal (as defined pursuant to FCC rules) from our over-the-air signal at your head-end using similar equipment to that used to receive other over-the-air stations on your system. Pursuant to Section 76.64 (f),(4), we expect you to begin carrying WMEI no later than January 16, 2007 (90 days following our notification letter of October 16, 2006).

If you have any questions concerning WMEI, please contact me. If you have technical questions concerning the WMEI Channel 60 signal, you may contact David Cox at (787) 428-1431, but only after first acknowledging receipt of this letter to the undersigned, along with a willingness to carry WMEI in the event that any perceived technical deficiencies in the signal can be addressed.
