The purpose of the EEO Public File Report (“Report”) is to comply with Section 73.2080(c) (6) of the FCC’s 2002 EEO Rule. This Report has been prepared on behalf of Mifflin Country Communications, Inc., the Station Employment Unit that is comprised of the following stations: WCHX/WVNW/WKVA, and is required to be placed in the public inspection files of these stations (now online), and posted on their web site, if they have a web site.

The information contained in this Report covers the time period beginning April 1, 2017 to and including March 26, 2018. (The “Applicable Period”).

The FCC’s 2002 EEO Rule requires that this Report contain the following information:

Please note that the numbers listed on Appendix 2 under the column entitled “Full-time Positions for Which This Source Was Utilized” refer to the number of the full-time job positions listed on Appendix 1.

For the purposes of this Report, a vacancy was deemed “filled” not when the offer was extended but when the hiree accepted the job offer. A person was deemed “interviewed” whether he or she was interviewed in person.

EDUCATIONAL EVENTS

Brief Description of Activity and Station Participation

From August 15, 2016 to May 25, 2017, a senior student from the Mifflin County School District was enrolled in the District's "cooperative education program" with the stations. The student spent 15 hours per week on-site gaining insight, knowledge, and experience in the business operation of the Radio Stations.

On August 3, 2017 approximately 20 students from the Panda Pre-School in Burnham, PA, toured the radio stations, during which they were exposed to the various positions and duties within a broadcast organization.

On October 23, 2017, General Manager Scott Richards spoke to the Communication classes 501-506 at Susquehanna University in Selinsgrove, Pa, about various positions available in the Radio Industry, items they can work on to improve their chances of obtaining a position upon graduation, and the value of networking with those in the broadcasting business.
