Co-Host Howard Dayton and Steve Moore talked about the dangers of falsified tax returns. 25% of all Identity Thefts are involved with fake tax returns, the average tax refund is \$3,000. A victim of identity theft may receive a letter from the IRS stating that more than one tax return has been filed with their Social Security number. Identity theft victims can file a complaint with the IRS asking for a refund but it could take $1-1\frac{1}{2}$ years for the IRS to do a complete investigation. Lowering tax exemptions is one way to reduce the risk because the return is lower.
