Plan for e-cigarette rules reaches Senate floor

ST. PAUL, Minn. (AP) - A plan to classify electronic cigarettes in the same fashion as the conventional kind has survived its toughest committee test and now awaits a Senate floor vote.

The bill cleared the Senate Commerce Committee after an attempt to weaken the proposed regulations failed Monday on a 7-6 vote. It would add so-called vaping to state indoor air laws that bar tobacco use in public places and most businesses.

The e-cigarette devices heat a liquid nicotine solution. Users inhale a vapor but they don't emit the chemicals, tar or odor of regular cigarettes. Product advocates say it sends the wrong signal to treat them equally before scientific studies determine health risks.

No one spoke against provisions that would impose criminal penalties in cases where the devices are sold to minors.

Dayton splits with health commissioner on e-cigs

ST. PAUL, Minn. (AP) - Gov. Mark Dayton has broken with his Health Department commissioner over the extent of regulation needed on electronic cigarettes.

Dayton told the Minneapolis Star Tribune (<http://strib.mn/OUflRq>) that he is uncomfortable with legislative efforts to put e-cigarettes in the same category as conventional cigarettes when it comes to prohibition of use in public spaces. His comments published Wednesday directly contradict testimony from Health Commissioner Ed Ehlinger.

Dayton says he would sign a bill to restrict children's ability to buy e-cigarettes, but he would likely oppose proposed restrictions on their use indoors.

In a Senate committee Monday, Ehlinger described the vapor-emitting devices as "a threat to the health of the public" that could undermine the state's law barring tobacco use in public buildings and most businesses.

Minn. Senate panel to consider Sun. alcohol sales

ST. PAUL, Minn. (AP) - Minnesota state senators are ready to reveal a wide-ranging liquor proposal expected to allow some Sunday alcohol sales.

The legislation before the Senate Commerce Committee on Wednesday is unlikely to allow liquor-store owners to open for business on Sunday.

Two bills have been making headway that would loosen the state's Sunday alcohol-sale ban. One would allow the sale of 64-ounce beer containers called "growlers." The second would open small brewers' taprooms.

Supporters of the changes say they would benefit Minnesota's burgeoning craft-beer brewing industry.

Gov. Mark Dayton said earlier this year that he'd sign a bill that completely repealed the Sunday prohibition. But that idea never gained enough traction among lawmakers.

Many small liquor store owners oppose being open on Sundays because they say costs would outweigh profits.

MN to Offer Enhanced DL at Some Locations

Minnesota is the fifth state in the U.S. to begin offering enhanced driver's licenses and identification cards, making traveling to some destinations a little more convenient. The dual-purpose cards allow Minnesotans to re-enter the U.S. by land or sea from Canada, Bermuda, Mexico and the Caribbean without a passport.

The enhanced cards allow border patrol agents to verify cardholder identity and citizenship through Radio Frequency Identification that points to information in a Department of Homeland Security database.

Applications will be accepted beginning next Monday at 14 Driver and Vehicle Services stations, which include: Anoka, Arden Hills, Austin, Bemidji, Detroit Lakes, Duluth, Eagan, Hastings, Mankato, Plymouth, Rochester, St. Cloud, St. Paul and Virginia.

Applicants must be at least 16 years old, and both a U.S. citizen and Minnesota resident.

The cost is \$15 in addition to the regular license fees. Applications are expected to take 2-4 weeks to process.

Other states offering enhanced driver's licenses and ID cards are New York, Vermont, Michigan and Washington.

Dayton drops out of NFL trip to focus on propane

ST. PAUL, Minn. (AP) - Gov. Mark Dayton will not be part of the Minnesota group traveling to New Jersey this weekend to lobby NFL officials for a Minnesota Super Bowl in 2018.

Dayton's office said Tuesday the governor is staying in Minnesota to deal with a propane shortage. Dayton plans to convene an emergency meeting of the state's Executive Council, which he will ask to extend a five-day emergency order that he implemented Monday.

Dayton had planned to join business and community leaders pitching Minneapolis as a 2018 Super Bowl site to NFL officials gathered for the Super Bowl in East Rutherford, N.J. Dayton's spokesman says the rest of the group is still going.

Dayton's order authorizes a number of steps by Minnesota's Public Safety Department and Adjutant General to respond to propane shortages.

Demand for skilled workers will be high

MINNEAPOLIS (AP) - Demand for skilled workers to build the new Minnesota Vikings stadium has already begun, even though the old Metrodome is far from demolished.

Summit Academy OIC is a nonprofit education and vocational training center that's assisting in the hiring process. CEO Louis King says the Sports Facility Authority, Mortenson Construction and the Vikings have provided \$800,000 for worker training.

The Sports Facilities Authority expects employment to peak at 1,000 between April and August of 2015. King tells KSTP-TV (~~<http://bit.ly/111cAvS>~~) the stadium isn't the only large scale project in the area, so demand for skilled workers will be high. Projects underway, or about to begin, include the St. Paul Saints stadium, the St. Croix (kroy) River bridge and light rail construction.

King says his center has an initial job order for 100 skilled trade workers.

Minn. Supreme Court dismisses Vikings stadium suit

ST. PAUL, Minn. (AP) - Minnesota's Supreme Court has dismissed a lawsuit challenging the funding plan for a new Vikings football stadium.

The decision Tuesday clears a late obstacle that threatened to hold up construction and delay a planned 2016 opening. Minnesota finance officials postponed a \$468 million bond sale while the case was pending.

It was filed Jan. 10 by a former Minneapolis mayoral candidate who argued the stadium funding was unconstitutional.

The stadium will be built on the Metrodome site.

State lawmakers authorized construction in 2012. Taxpayers are footing about half the cost.

New warehouse sales tax gets another look

ST. PAUL, Minn. (AP) - New guidelines on a state warehouse sales tax are adding fuel to a campaign to repeal it.

Minnesota lawmakers passed the tax seven months ago. It applies to any businesses buying storage or warehouse services from another entity. A business would not be taxed for using its own warehouse.

The Department of Revenue has now issued guidelines on the tax, which is expected to raise more than \$95 million over the remainder of the current budget cycle. Taxable services include the storage of documents, coal, hazardous waste, lumber and liquor.

Minnesota Chamber of Commerce tax director Beth Kadoun is working to repeal the tax before it goes into effect April 1. Kadoun tells Minnesota Public Radio News (<http://bit.ly/1di7a1B>) the chamber has heard from companies that won't do business in Minnesota if the tax goes into effect.



Casselton chief says force's response saved lives

WASHINGTON (AP) - The fire chief of an eastern North Dakota town says "about everything went right" with his force's response to a fiery train derailment because they had properly planned for disasters.

Casselton Fire Chief Tim McLean says the Dec. 30 derailment could have been a deadly incident and credits training and federal financial support. He spoke to a Senate subcommittee on Tuesday at the invitation of Sen. Heidi Heitkamp.

An oil train collided with a grain car outside of Casselton on Dec. 30 sparking explosions and a smoke plume that hung over the town of about 2,400 residents. There were no injuries, but about 1,400 people voluntarily evacuated.

Many have since expressed concerns about shipping oil by rail and what would happen if an accident occurred in a more populated area.

Woman dies in Dakotas with no propane to heat home

FORT YATES, N.D. (AP) - A woman has been found dead in her home with an empty propane tank on the Standing Rock Reservation in the Dakotas.

Tribal and Sioux County authorities told ~~The Bismarck Tribune~~ and ~~KXMB-TV~~ that Debbie Dogskin was found dead on Tuesday morning in a Fort Yates mobile home. She was in her early 50s.

Authorities haven't specifically tied Dogskin's death to a lack of propane, but the overnight low temperature dropped to about zero that day. A cause of death was not announced and the Bureau of Indian Affairs declined comment.

The tribe has declared a state of emergency because about 5,000 homes on the reservation that straddles the North Dakota-South Dakota border are heated by propane. The fuel has more than doubled in price because of a nationwide shortage.

Farmers encouraged to sell excess propane

ST. PAUL, Minn. (AP) - Minnesota's agriculture commissioner and propane industry officials are encouraging state farmers with a surplus of the fuel to sell it back to suppliers.

Commissioner Dave Frederickson says farmers could help minimize the impact of the critical shortage of propane by selling their excess supplies.

Minnesota Propane Association executive director Roger Leider says some propane suppliers in the state have been contacted by farmers and members of the commercial grain industry who want to help. Leider says pumping of farm storage tanks has already started.

Meanwhile, Gov. Mark Dayton has expanded the state's income eligibility for heating assistance from 50 percent to 60 percent of the state's median income. It's expected to help more Minnesotans gain access to financial assistance for the purchase of propane and other heating fuels.

Keystone XL waiting list grows for US oil shippers

BISMARCK, N.D. (AP) - TransCanada Corp. says it has a waiting list of U.S. oil shippers who want to use an onramp to the proposed Keystone XL pipeline from Canada to the Gulf of Mexico.

The Canadian company announced three years ago that it secured contracts to move crude from the oilfields of North Dakota and Montana. The proposed \$140 million Bakken Marketlink pipeline would meet with the Keystone XL in eastern Montana.

TransCanada says oil producers in North Dakota and Montana have turned to trains while the Keystone XL has been debated. The company says the domestic oil shippers still have contracts and are committed to moving their product by pipeline.

The proposed Keystone XL cleared a big hurdle last week when the State Department raised no major environmental objections to its construction.

ST. PAUL, Minn. (AP) - Minnesota agencies are getting ready to respond should any households run out of fuel as propane supplies are stretched during this persistent cold weather.

The state Homeland Security and Emergency Management Division says there are currently no requests for state assistance. But officials held a conference call Tuesday with emergency managers from all 87 counties to make sure authorities are ready.

Gov. Mark Dayton declared a State of Peacetime Emergency on Monday, after propane prices have drastically increased.

Meanwhile, Commerce Commissioner Mike Rothman says crisis payments for those who qualify for assistance are increasing from \$500 to \$1,000.

The Salvation Army has also added \$100,000 into its heating assistance program to help those in need. The Salvation Army says requests for aide have increased, threatening to drain its reserves.

Dayton declares emergency over propane shortage

ST. PAUL, Minn. (AP) — Minnesota Gov. Mark Dayton has declared a state of emergency because of a severe shortage of propane and other home heating fuels statewide.

Dayton issued the emergency order Monday. The order calls on the state Division of Homeland Security and Emergency Management to activate the Minnesota Emergency Operations Plan.

State agencies also will be directed to help local governments respond to and recover from the emergency.

~~Minnesota's adjutant general also will be able to order any military forces to active duty to provide emergency relief.~~

Dayton also instructed Minnesota's commerce commissioner to use his consumer protection authority to help guard Minnesotans from price gouging.

The governor plans to meet with propane industry suppliers Tuesday to discuss the shortage and how to improve Minnesota's propane supply.

TACONITE MINE EXPANSION

Court: Minn. mine expansion doesn't need new study

ST. PAUL, Minn. (AP) — The Minnesota Court of Appeals says one of the state's largest taconite mines does not need a new environmental study to expand and keep operating for another 16 years.

The Star Tribune reports a three-judge panel ruled Monday that a lengthy environmental impact study is not needed for U.S. Steel to add 483 acres to its Minntac iron ore mine.

The mine and its processing plant began operating in 1967 and have expanded twice before. The latest proposal would allow the mine to expand again and maintain its current rate of production until 2031 instead of closing in 2015.

The Department of Natural Resources said last April a longer environmental impact statement was not necessary.

An environmental group argued a more comprehensive study was needed to protect nearby waterways.

Crystal CEO says rail slowdown could cost millions

FARGO, N.D. (AP) - American Crystal Sugar Co. officials say they're worried that a slowdown in rail service could cost the company millions of dollars if it continues to disrupt production.

The cooperative says it plans to scale back on output at three of its plants because it's running out of storage space waiting for rail cars.

BNSF spokeswoman Amy McBeth says service is being impacted by "extreme cold and winter weather conditions" in the Midwest, and the railway has put a priority on serving Crystal Sugar.

Crystal CEO David Berg says he understands that weather can be a problem but adds that it's not a "new phenomenon" in the Northern Plains and increased oil traffic has made it a "bigger pinch."

Berg says Crystal does not have another viable transportation option.

Dakotas tribe opens shelters amid propane shortage

FORT YATES, N.D. (AP) - The Standing Rock Sioux Tribe has opened shelters for people without adequate heat due to a propane shortage exacerbated by recent cold weather.

The reservation straddles the North Dakota-South Dakota border. The tribe has opened shelters in Fort Yates on the North Dakota side and in Wakpala on the South Dakota side.

The American Red Cross is providing meals at both locations, along with cots and blankets.

Tribal Chairman Dave Archambault (AR'-sham-boh) II says it's a potential life-or-death situation. He says about 90 percent of the 5,500 homes on the reservation are heated by propane.

Tribal Emergency Management Director Elliott Ward says only a handful of people have used the shelters so far, but both he and Archambault expect the number to increase. About 10,000 people live on the reservation.

Plains oil shipments disrupting Amtrak trains

* CHICAGO (AP) - An increase in rail shipments of oil crude from the northern Plains is being partly blamed for disruptions to an Amtrak route linking Chicago and the West Coast.

The National Association of Railroad Passengers wrote to U.S. Transportation Secretary Anthony Foxx this week urging him to intervene.

Amtrak's Empire Builder service runs along a BNSF Railway route that has seen an increase in oil shipments from the Bakken region of North Dakota and Montana.

Winter weather has exacerbated several months of disruptions. Westbound Amtrak trains this week have had to bypass stops across much of North Dakota. Delays have reached up to 10 hours.

A BNSF spokeswoman could not be reached.

Amtrak spokesman Marc Magliari says BNSF has said disruptions could continue for months.

BLM oil, gas leases in North Dakota fetch \$17.5M

BISMARCK, N.D. (AP) - The Bureau of Land Management says its most recent sale of oil and gas leases in North Dakota totaled more than \$17.5 million.

BLM says 40 federal leases were sold Wednesday.

The agency says Williston-based Diamond Resources Company submitted a record high bid of \$34,000 for each acre in a 53-acre parcel in Mountrail County.

Diamond Resources also purchased the highest single-parcel bid at more than \$5 million for a 152-acre parcel in Mountrail County.

Competitive oil and gas lease sales are conducted at the BLM's Montana state office in Billings. Money from the sales is shared with states and counties. All leases are issued for a 10-year term.

ND state agencies monitoring natural gas situation

BISMARCK, N.D. (AP) - Gov. Jack Dalrymple says state agencies are monitoring natural gas supplies in eastern North Dakota.

Xcel Energy is asking customers in North Dakota, Minnesota and Wisconsin to conserve natural gas after a Saturday pipeline explosion in Manitoba.

Dalrymple says state officials are working with local officials, health care providers and utilities in eastern North Dakota on contingency plans should there be heat shortages. He says the National Guard and Highway Patrol are ready to respond if needed.

Xcel says one of three pipelines that have been out of service is being returned to service and should reach full capacity by Monday afternoon. But spokesman Kent Larson says things won't be back to normal until the gas is delivered to the region, and demand remains high due to subzero temperatures.

MANKATO, Minn. (AP) - Rising propane prices are worrying many rural Minnesota residents who count on the fuel to heat their homes amid a bitterly cold winter.

~~KTOE~~ News in Mankato reports Monday ~~that~~ suppliers in the area were quoting propane prices of \$4.75 a gallon by the end of last week (<http://bit.ly/1b0UQHo>). That's compared to \$1.59 a gallon a year ago.

That means a bill of about \$1,000 to fill a 200 gallon tank. One customer ~~tells KTOE~~ a tank that size only lasts about three weeks in current weather conditions.

Minnesota Commerce Commissioner Mike Rothman says Texas recently opened its borders to propane trucks from a number of states including Minnesota. Federal and state lawmakers have been seeking answers in recent weeks for propane price spikes and supply problems.

A fleet of dump trucks has been running up and down Highway 200 supplementing coal deliveries that can't be met by rail shipments.

Basin spokesman Curt Pearson says trucks are making up to 250 trips daily to keep up with what can be normally delivered in two train loads.

Cris Oehler Vice President of Public Relations for Otter Tail Power Company says, "We have been receiving enough coal to keep the plants operating but are watching the situation very closely. BNSF is having delivery difficulties throughout their northern system, which affects Hoot Lake Plant. The cold weather is adding to problems with frozen coal being difficult to unload. The derailment at Casselton also contributed to delayed train movements in the region. But BNSF is working with Hoot Lake Plant staff and, so far, the plant has been close to keeping up. In addition, Hoot Lake Plant has an emergency coal stockpile to help manage situations like this."

BISMARCK, N.D. (AP) - Some North Dakota Republican lawmakers say they're disappointed in comments made by the state party chairman calling for a slowdown in oil drilling in the western oil patch.
