Krista Lockyear, the attorney for the property owner, says the proposed development has been well thought out, and it will provide growth and an added tax base in the western part of the county. The Plan Commission votes to recommend the County Commission approve the rezoning.

Description: Vanderburgh County Commissioner Marsha Abell sent a letter to the Area Plan Commission indicating she believes the University Parkway rezoning is a good idea. She says the west side needs the growth and the added tax base, and she said the road, "was not a glorified driveway for the University of Southern Indiana." GROUP spokesperson Michael Lockard says the letter was a slap in the face of USI, and it would not help grow the west side. USI spokesperson Kendra Strupp says the county is not making any effort to remedy the traffic problem the development will create, and the university is still willing to fund a study of how the entire Parkway corridor should be developed.

Description: The environmental group Valley Watch asked the state to put a moratorium on permits for any fertilizer plants. The request came shortly after an explosion at a Texas fertilizer plant. Valley Watch President John Blair said the plant is dangerous, and the state should not be giving incentives for such companies to locate in Indiana. Greg Wathen with the Economic development Corporation of Southwestern Indiana said the process the Posey facility may use is much different than the process used at the plant in Texas.

The Governor says he is concerned because the Fatima Group, which wants to build the plant, is based in Pakistan, and the State Department has concerns that the company is not doing enough to keep explosives out of the hands of terrorists. The manufacturing of some fertilizers uses the same ingredients contained in many explosives. John Taylor with the Economic Development Partnership says he believes the plant is safe, and the company is doing its part to keep explosives out of the wrong hands. Taylor says the county will look into the possibility of moving forward with the plant without the state's help.
