08/02/98 "Whose Chemical Weapons?"- tons of 30 to 40-year-old chemical weapons, including rockets, bombs and projectiles, are stored in eight depots in locations across the U.S. Despite the fact that the Pentagon is aware that some of them are beginning to leak, little or nothing has been done to protect the people in neighboring communities. (C: Steve Kroft - P: Tom Flynn) (OAD: 03/08/98)
 "Stephen King"- an interview with the author and his wife Tabitha (C: Lesley Stahl - P: Jay Kernis) (OAD: 02/16/97)
 "Traitor or Hero?"- an interview with Ward Connerly, a wealthy California businessman, whose support of the anti-affirmative action law in his state has inspired mixed reviews. 08/09/98 "Back to My Lai"- Larry Colburn and Hugh Thompson, members of an American helicopter crew, were recently awarded medals for risking their lives, 30 years ago, to save Vietnamese civilians during the My Lai massacre. The men returned to My Lai to relive bitter memories and revisit some of the people they rescued. (C: Mike Wallace - P: Tom Anderson) (OAD: 03/29/98)
 "The Disaster That Wasn't"- a report on class-action lawsuits following a minor chemical spill at the General Chemical Company in Richmond, California. Despite the fact that few people suffered serious consequences, the chemical company still settled several class action suits for \$180 million, \$50 million of which went to the lawyers (C: Morley Safer -P: Deirdre Naphin) (OAD: 02/29/97)

- 08/16/98 **"Starr Wars"**- during his investigation, Special Whitewater Prosecutor Ken Starr has targeted a number of people, including some whose names have never been in the headlines. Sarah Hawkins, former officer at the now-defunct Madison Savings And Loan and Professor Steve Smith of the University of Arkansas are among those who claim that they were subjected to crude and abusive tactics (C: Morley Safer - P: Catherine Olian, Alden Bourne) (OAD: 05/03/98)
"To Be Or Not To Be"- a report on the problems faced by young people who tell their parents that they are homosexuals and the controversy over whether homosexuality can be reversed. Includes interviews with parents of gay children; John Paulk, a former gay male prostitute who claims that counseling he received at Exodus International, enabled him to change his lifestyle; and Doug Upchurch who says that he is still a homosexual despite efforts to change. - 08/23/98 **"Taliban"**- on September 27th the Taliban, a group of religious extremists, took control of Kabul, the capital of Afghanistan and are attempting to impose their version of a true Islamic state. Under Taliban strictures a thief can have a hand cut off; an adulterer can be stoned to death and women must cover themselves from head to toe and are prevented from educating themselves or working outside the home (C: Christiane Amanpour - P: Scott Bronstein, Dominic Robertson) (OAD: 11/03/96)
"Suicide Bomber"- an interview with Hassan Salameh, a military commander of Hamas, the Islamic militant organization, about how he orchestrated suicide bombings in Jerusalem which left 45 dead and 91 wounded. "Nixon On Nixon" - last part of the three part interview of ex-President Richard Nixon by his former speech writer Frank Gannon (P: Robert G. Anderson) (OAD: 04/15/84)

- 08/30/98 **"Freedom Fighters Or Terrorists?"**- examines claims that weapons supplied by the U.S. to Afghanistan to fight the Russians in the '80s are being used in anti-American terrorist attacks such as the U.S. Embassy bombings in East Africa. Includes an interview with former Congressman Charlie Wilson who spearheaded legislation granting billions of dollars to the Afghan freedom fighters. (C: Steve Kroft - P: Leslie Cockburn)
"Experimental Prison" - 27 years ago Dr. Philip Zimbardo of Stanford University set up an experiment testing what would happen in a prison environment where one group of normal people had complete power over another group of normal people. Dr. Zimbardo and two student volunteers who took part in the experiment talk about their experiences. (C: Lesley Stahl - P: Jay Kernis)
"Evelyn Glennie"- an interview with Evelyn Glennie, a 30-year-old Scotswoman who overcame deafness to become the world's first full-time solo percussionist (C: Ed Bradley - P: Jeanne Solomon Langley) (OAD: 11/17/96)

- 08/03/98 **"Fatal Mistake"**- 48 HOURS explores the issue of young women who conceive children and hide the pregnancy. They secretly give birth and then abandon the baby, some claiming that their babies were born dead. Includes interviews with law Professor Michelle Oberman; defense attorney Tom Cushman; Dr. Margaret Spinelli, an American psychiatrist; Dr. Barbara Kirwin, a psychologist and expert witness for the prosecution in neonatal cases; Channi Kumar, and a British psychiatrist. Also included is a profile of Debbe Magnusen, a California woman who runs Project Cuddle, an organization set up to help arrange adoptions for young women with unwanted pregnancies (C: Erin Moriarty, Susan Spencer, Dan Rather - P: Gail Zimmerman, Alec Sirken, Sophia Kim, Jay Pedinoff) (OAD: 03/05/98)

"Celebrate"- someone is putting pink flamingos on lawns in the Disney planned community of Celebration (C: Bill Geist - P: Richard Rosen)

- 08/20/98 **"Target: Terror"**- Report on the U.S. military strike on terrorist-related facilities in Afghanistan and Sudan, focusing on the President Clinton's stated objectives for launching the strikes and critics' claims that his action was motivated by a desire to draw attention away from his current problems involving Monica Lewinsky. Includes interviews with: Lt. Gen. Buster Glossom, U.S. Air Force, retired; James Kallstrom, former FBI Director; Elfatih Erwa, Sudan's Ambassador to the UN and Dennis Bradley whose sister was killed in the bombing of the U.S. Embassy in Nairobi. 08/31/98 **"Princess Diana: Fatal Decisions"**- on the anniversary of the death of Diana, Princess of Wales, 48 HOURS focuses on the sometimes conflicting accounts of the events leading up to the fatal crash and the possibility that the fatalities were preventable. Includes a report on bodyguard Trevor Rees-Jones, the sole survivor of the accident who has received death threats and interviews with: Christian Curtil and David Crawford, Rees-Jones' attorneys; Laurie Mayor, spokesman for Mohammed Al Fayed; Rene Delorm, Dodi Fayed's butler and confidant and crash investigators Brian McHenry and Casey Herbert. 08/12/98 **"A Footprint On Everest"**- follows the attempt of Tom Whittaker, a man whose left foot was amputated, to become the first disabled person to reach the summit of Mt. Everest. Five members of HOGS (Handicapped Outdoor Group), an organization founded by Whittaker, also struggled to reach Everest's base camp. Whittaker became seriously ill during the climb but recovered enough to reach his goal (C: Bryant Gumbel - P: Liza Finley, Steve McCarthy)

08/19/98 **"Clean Kill?"**- an alarming number of civilians in L.A. County have either been shot to death by the police or died while in police custody. In most cases no criminal charges were filed against the police. The family of Michael Shinaia, 23-year-old man killed in a police raid is suing the Bell Gardens, California Police Department. (C: Bernard Goldberg - P: David Fitzpatrick)
"What In the World?"- a powerful cannon using heavy wooden 2-by-4's fired against a special high-tech wall. The object -- to test a high-tech tornado-proof wall. (P: Tom Forman)
"Stroke By Stroke"- an interview with Mick Bird, a 41-year-old man who set off from Hawaii to row around the world (C: Maggie Cooper - P: Lisa Freed)
"Everybody has A Story"- a visit with Dr. Alfred Moscarella, a retired cardiovascular surgeon (C: Steve Hartman - P: David Wald)

08/26/98 **"Hurricane Bonnie"**- a report on Hurricane Bonnie, as the storm comes ashore in North Carolina (C: Byron Pitts, Maggie Cooper, Peter Van Sant, Derek McGinty P: Tom Forman, David Wald, Lee Solomon, Karen Benfield, Jamie Kraft, Chuck Stevenson)
"Medical Mystery"- CJD (Creutzfeldt-Jakob disease), an ailment that strikes the brain, has been linked to the outbreak of mad cow disease in Great Britain. Includes an interview with Dr. James Ironside, chief neuropathologist of the CJD Unit, in Edinburgh, Scotland (C: Peter Van Sant - P: Nanci Ross)
"What's Brewing?"- thousands of Americans order decaffeinated coffee, many times what they get is regular coffee. Includes interviews with Ken Davids, Coffee Review and Sandy Levine, owner of the Carnegie Deli (C: Maggie Cooper - P: Chris Riback)

"Anthem"- profile of 10-year-old singer Jamie Lynn Bence whose goal is to sing the national anthem in every major league baseball park (C: Derek McGinty - P: Dana Roberson Johnson)
"Public Eye Q"- Question: What was the nation's most destructive natural disaster? Answer: It was a tie. Both Florida's Hurricane Andrew in 1992 and the 1994 Northridge earthquake in California caused more than \$30 billion in damage (P: Christopher E. Martin)
"The Weather Channel"- interviews with three videographers who sell videotapes of storms (C: Alison Stewart - P: Karen Benfield)

BEFORE YOUR EYES

08/24/98 "Don't Take My Daddy"- focuses on three American women facing the choice between raising their children alone in America or staying with their husbands (Noel Gaynor, Gabe Megahey, Matt Morrison), natives of Northern Ireland who are being threatened with deportation because of ties to the Irish Republican Army. Explores the question of whether a man who serves time in prison for a crime and following his release, leads a respectable life, should be threatened with deportation more than a decade later. (Narrator: Roma Downey - E.P. Mary Murphy)
