
Dear Sir or Madam,

Although individual retransmission consent election letters have been sent to the individual headends of each of the systems owned by AT&T Services, Inc. ("AT&T") with respect to television stations listed on Exhibit A hereto (the "Stations"), in order to avoid any doubt with respect to the elections by the Stations, pursuant to the provisions of Section 614 of the Cable Television Consumer Protection Act of 1992 and Section 76.64 (f) of the rules and regulations of the Federal Communications Commission, this letter shall serve as written notification that each of the licensees set forth on Exhibit A hereto, elects retransmission consent for carriage of the digital signal of the television stations listed together with their licensee names, for the digital channel and virtual digital channel listed together with the licensee's name, licensed to the city of license, and serving the designated market area (DMA), all as listed together with such licensee's name. This election shall apply to all communities located wholly or in part of each such DMA, including all headends of AT&T serving such communities, for the period beginning on January 1, 2012, and ending on December 31, 2014.
