1<sup>st</sup> QUARTER 2023

The first quarter of 2023 was relatively uneventful, with winter weather being the exception. Globe-Miami rarely experiences snowfall. As expected, the February and March storms had little impact locally but their effect on travel was significant. Ice and snow at Top of the World made driving to the Valley hazardous on several occasions. And nearby rain produced sufficient moisture to return the Roosevelt Reservoir to pre-drought conditions. In fact, water levels are higher than they've been in years.

In addition to its unique blend of music, comprised primarily obscure soul and R&B from the 1950s and 1960s mixed with sambas, pop standards, instrumentals and early rock and roll chosen for its local appeal without regard to national popularity; KJAA airs public service announcements around the clock along with hourly weather, news items and immediate updates when dangerous conditions exist, as well as at least one full length morning drive local newscast each weekday morning including local job openings. KJAA does not attempt to compete with national news sources. Using a need-to-know approach, KJAA focuses exclusively on local events and concerns. KJAA is heard on 1240 AM, and on 106.1 FM via translator K291CU.

Nothing exceeds **Mining** for impact on the local economy, so attention is paid to periodic reports from companies with a local presence. Freeport McMoRan (FMM) released its 4Q22 report in January with a healthy profit of \$697 million dollars. Consolidated sales included a billion pounds of copper, 1.8 million ounces of gold, and 75 million pounds of molybdenum. Average price of copper sold for the quarter was \$3.77, with cost to produce at \$1.53. 2022 prices for copper sold from FMM ranged from a high of \$4.87 in March 2022 to a low of \$3.18 in July.

Vancouver BC based Capstone Mining, owner of the Pinto Valley open pit mine near Miami released its 2022 financial report. From their four mining operations including Pinto Valley, Capstone's total profit was \$136.1 million (US). But the 4Q22 results showed a \$28.4 million loss. Fourth quarter production at Pinto Valley was 15,000 tons of copper sold at \$3.74 a pound at a cost of \$2.48 a pound to produce.

Grupo Mexico, with its Asarco mine and smelter nearby, in addition to a Texas refinery, copper mines in Mexico and South America, and the majority of Mexican railroads, reported consolidated revenue from all sources for 2022 to be \$13.87 billion (US). The mining division was responsible for \$10.96 billion in revenue, which was a 9.3 percent drop from the previous year. Grupo Mexico attributes the drop to higher costs of operation due to inflation. Copper production at 1,006,934 tons was down 7.2% compared to 2021, and the cost of production was up 22% from 2021 at \$1.02 a pound. The cost to produce at Asarco showed a 41% increase from 2021, at \$2.91 a pound. Asarco produced 112 tons of copper in 2022, a drop of 11.4 compared to the previous year. Grupo Mexico, which continues to have the largest copper reserves worldwide,

reported its 2023 focus will be on addressing inflation and the labor environment in the US.

BHP currently has no producing mines in Globe-Miami, but they remain one of the largest land owners in the area with over 4,000 acres. Drilling exploration on recently acquired property is ongoing. Their six-month report as of 12/31/22 showed a net profit of \$6.46 billion (US) worldwide, which is down from \$9.44 billion during the same period a year earlier when strong prices boosted the bottom line. That in addition to current inflation accounts for the drop. But BHP is positive that the outlook for copper demand will be strong in 2023. That's actually a mixed statement when looking at BHP reasoning: the Chinese projected economic recovery along with strong expectations in India should counterbalance a slowdown in the US and Europe.

Locally, the big mining question is unchanged: what will happen with Resolution Copper? The giant underground mine in nearby Superior should have been at full employment by now, but its development was halted by the Biden administration. There was no news in the first quarter of 2023 as to its ultimate fate. This continues to be a major concern for the region's **Economy**.

Like everywhere else, the big economic issue here this past quarter was inflation. Rapidly rising prices impacted quality of life significantly. And as driving to the Valley is more of a necessity than a luxury, rising gas prices were an issue. Gas was routinely well over \$4 a gallon locally. Statewide, the lowest price this quarter was \$2.55 in Golden Valley, with the highest prices exceeding \$5.00 in several areas.

Also on the rise nationally this quarter was the cost of postage when the US increased the price of the first class Forever stamps to 63 cents. Post cards are now 48 cents.

But a looming price increase that worries many local residents is the cost of water. Homeowners served by Globe Water will not be affected, but for everyone else—Miami, the unincorporated local areas, and parts of the City of Globe—the rate hike requested by Arizona Water Company is steep. If the Arizona Corporate Commission approves the request (which won't be known until the fall at the earliest), the current rate of \$39.66 for 5400 gallons of water a month, will jump to \$52.96.

The Arizona Office of Economic Opportunity released good news in March with non-farm employment increasing by 98,400 jobs compared to a year earlier. The unemployment rate decreased statewide in January to 3.8%, slightly higher than the national average of 3.4%.

Continual job alerts were featured on KQSS, with perhaps the most interesting being the call for extras by Fox Sports. Arizonans were invited to apply. Hundreds of extras were hired for Superbowl week events.

Addressing both **Blight** and the local economy, the project to convert the former Hill Street School into a senior apartment complex in Globe is ongoing. A pre-bidding conference was held this quarter with offers due on March 31<sup>st</sup>. (At this writing no details are available on what was submitted.)

**Infrastructure** enhancements this quarter ranged from water system upgrades in Globe to a new sidewalk (thanks to federal grants) for Central Heights. The Miami Town Council held a public hearing on how to spend the \$196,000 Community Block Grant money it

received. An elevator for Bullion Plaza, Keystone stairs rehab, solar panels at the wastewater treatment plant and several street repairs are expected.

Creating interest and participation in **community meetings** is the often-elusive goal of local community leaders everywhere. To facilitate wider-reach and easier-access, the Chairman of the Gila County Board of Supervisors, Tim Humphrey uses KQSS as the origination point of his monthly meeting. Listeners and residents are invited to participate, but for those who miss the live meeting, it is replayed the following weekend on KJAA, and is available as a download on KQSS.net, though scheduling and illness resulted in only one such meeting this quarter:

The Russell Gulch Landfill extension was discussed in depth. Over \$2.7 million is being spent to create more space for the local dump adjacent to the current site. A new sedimentation pond, weigh station, and metal buildings will be installed. Plans are being considered to be able to have composting in the future, which would further extend the life of the landfill. Dollar a Day Dump Days continue on the second Saturday of every month for Gila County residents. Work is ongoing on the new Tonto Bridge. State representative Wendy Rodgers is introducing a bill to fund state transportation projects. It includes money for Gila County, but providing transportation to the area remains an elusive goal. Even within the county, with so much land separating various communities, it's not feasible to provide public transit. There's better news on the local level, with Copper Cities Transit serving Globe-Miami with fixed routes and dial-a-ride, but widening it to other areas under county direction is not yet feasible.

KJAA enhances its public service presence with two long-form nationally produced shows chosen for their coverage of issues impacting the local area. Unlike stations that choose to bury required public interest programs, KJAA is proud to offer an hour long block of this information in morning drive on Sundays.

Health Care is an issue of critical importance to all Americans.
