2nd QUARTER 2023

The second quarter of 2023 brought long awaited news that the pool is now open. Due to the failure of the Globe & Miami pools several years ago, residents have been without a public pool for the last few years. When plans for a new aquatic center fell apart, it was thought that rehabbing the Globe pool would be possible in a relatively short time frame. That turned out to not be the case. Residents were told the pool would be open last summer, but delays ensued. Now the pool is open! But not without a hitch. No one thought about the need for public transportation to it. That is now being addressed, but it will not be this year that a direct route is offered.

In addition to its unique blend of music, comprised primarily obscure soul and R&B from the 1950s and 1960s mixed with sambas, pop standards, instrumentals and early rock and roll chosen for its local appeal without regard to national popularity; KJAA airs public service announcements around the clock along with hourly weather, news items and immediate updates when dangerous conditions exist, as well as at least one full length morning drive local newscast each weekday morning including local job openings. KJAA does not attempt to compete with national news sources. Using a need-to-know approach, KJAA focuses exclusively on local events and concerns. KJAA is heard on 1240 AM, and on 106.1 FM via translator K291CU.

Mining continues to be the economic mainstay in the area, so close attention is paid to news releases from the various companies. This quarter saw 1st quarter releases including Freeport McMoRan's report that production and sales were impacted by weather events in February but achieved full recovery in March. Net income totaled \$663 million, with consolidated production totaling 965 million pounds of copper, 405 thousand ounces of gold and 21 million pounds of molybdenum. Consolidated sales totaled 832 million pounds of copper, 270 thousand ounces of gold and 19 million pounds of molybdenum. Average price of copper was \$4.11, with a cost to produce of \$1.76.

On the other hand, Vancouver based Capstone Mining released its 1st quarter 2023 report with another net loss: \$29 million US. Over its four mines (including Pinto Valley in Miami, Cozamin in Mexico and two properties in Chile), Copper production in the quarter was 40.7 thousand tons at a cash cost to produce of \$2.96. Copper production was lower than expected at Pinto Valley because of unfavorable weather. At Capstone's annual meeting in Vancouver, shareholders voted in favor of all the items of business.

BHP, a huge land owner in Globe Miami with no producing mines here currently, continued its exploratory drilling locally this quarter.

Resolution Copper remains at a standstill. The long-awaited project, which will be one of the largest underground copper mines in the world, has the potential of being the largest copper producer in North America. It was anticipated to be in full production by

now, as the required land-swap to build it was approved by congress, but work was halted over disputes with the Apache Indians who claim it as a sacred site. No official news on its fate was released this quarter.

It is not an overstatement to claim that the Resolution mine will be the single most important factor to the **Economy** in the region, once it is up and running, particularly in Superior, which has been counting upon the mine to create an economic turnaround. Job opportunities are expected to be plentiful, and easily commutable for Globe-Miamians.

Inflation continues to be a large issue for local residents, particularly with regard to gas prices, since travel to the valley is often necessary, whether for goods and services, or work. The 2nd quarter closed with some encouraging news on gas prices, when Globe was tied for the cheapest gas prices in the state at \$3.25 a gallon, compared with \$5.99 in parts of the Phoenix metro. \$3.25 was .53 cents a gallon less than May and over \$1.25 less than a year ago.

Statistically **Crime** continues to be higher in Globe-Miami than most of the state, and while incidents of 'shots fired' are fairly routine in daily police reports, what happened at a home on Russel Road in the Golden Hill neighborhood was nothing short of a shootout in the old west. It began at 4 PM on Friday May 12th when the US Marshals Service tracked a suspect with warrants for murder and weapons violations to the home. It sounded like a television crime show when neighbors heard, 'US Marshalls, come out with your hands up,' followed by the sound of a flash-bang device. Within seconds, police were shouting the familiar 'shots fired'. (After shooting at officers, the suspect barricaded himself in his home.) A hail of bullets ensued, with surrounding residents evacuated from the area for their safety. Eventually, the suspect surrendered. But while this incident was over-the-top to neighbors, it wasn't entirely unexpected. The week prior, state police blocked off the street to arrest someone else.

Local **Infrastructure** projects continue here. Golden Hills Road is a windy and relatively narrow stretch that has long been a hazard for pedestrians. Now the sidewalk project for the Central Heights street is complete. Residents like the safety and convenience of a sidewalk, but are dismayed at the loss of front door mail delivery, which has been replaced by a mail pod at the beginning of the long street.

The Tonto Creek Bridge should be completed in the 3rd quarter of this year, and not a moment too soon. Lives have been lost crossing the creek when flash flooding occurs, and it does, particularly when facing the **Weather** events like those that occurred in the 1st quarter of this year. The result this quarter was the opposite of the drought conditions usually found here. Water was everywhere, and the Tonto Creek crossing saw a deadly water flow of 2400 cubic feet per second.

Flooding problems were not confined to road conditions. Roosevelt Reservoir, for instance, developed a rattlesnake problem. But the 2nd quarter ended with an all too familiar concern: **Fire**. Though major fires have yet to break out, a house fire in Central Heights in June punctuated the problem. Fortunately, only the structure was affected, but it was a tense several hours as helpless neighbors worried about conditions ripe for fire.

The problem comes from another issue vexing to the area: **Blight**. Homes are abandoned, and yards are not kept up. Weeds and dry grass six feet high are not unusual, and with a fire nearby, fears escalate over what could happen if a cinder were to fall on a dry overgrown yard. Creating interest and participation in **community meetings** is the often-elusive goal of local community leaders everywhere. To facilitate wider-reach and easier-access, the Chairman of the Gila County Board of Supervisors, Tim Humphrey uses KQSS as the origination point of his monthly meeting. Listeners and residents are invited to participate, but for those who miss the live meeting, it is replayed the following weekend on KJAA, and is available as a download on KQSS.net. Tim Humphrey Community Meeting

April 16, 2023 8-8:30 AM

Normally when it comes to water, the subject is drought. But due to excessive rain this winter, water levels are up everywhere. That's both good and bad news. Particularly at Tonto Creek where crossing is always dangerous, waterflow is up to 2400 cubic feet per second, making the crossing deadly. Construction of the bridge over that crossing to finally alleviate that long-standing situation is ongoing, on schedule. Roosevelt reservoir has developed a rattlesnake problem with water levels up to 106%, dislodging the reptiles. Meanwhile close to Globe-Miami, Central Heights residents are dealing with a traffic problem that will continue through the Spring. The construction of a sidewalk along the long, windy Golden Hill Road, funded by a long-ago received grant is closing it entirely in one direction through first week of July. Other projects were discussed in addition to the reasons behind the greater number of scheduled work sessions. Procedurally, supervisors can not discuss agenda items among themselves before voting, due to open meeting laws. By scheduling work sessions, discussions that might otherwise cause meetings to be long and arduous, can be dealt with openly ahead of a vote.

State regulations are not only contributing to blight, in Globe-Miami they are a major cause of it. When properties are abandoned but someone is paying the taxes, there is no way to force the taxpayer to be accountable for upkeep, as they are not the owner of record. And when investors, usually major corporations, pay the taxes and file liens on the property but do not follow through and acquire it, they're not responsible either. The obvious result is many properties in disrepair and blighted condition, but what's less known is the county is prohibited from taking them over. Supervisor Humphrey is working on convincing state lawmakers to change the regulations. Updates were provided on various street projects, the Youth Summer Jobs program, which provides excellent opportunities not only for well paying teen jobs, but the ability for participants to gain skills and contacts that can pave the way for careers.

Fire season is upon us. Just this week a house in Central Heights burned to the ground. Fortunately, no other structures were involved but there were tense hours in the neighborhood due to the overgrowth surrounding the home, common to the neighborhood, especially with the large number of abandoned properties. Code enforcement works solely on responding to complaints, and the fear surrounding this fire highlighted the need to report offenses. The timely nature of this event caused quite a bit of discussion. Supervisor Humphrey offered to act as a go between for individuals uneasy leaving a complaint in their own name for fear of retaliation. On the very good news front, the long-awaited Globe Pool is now open, but one issue remains. How to get there? For families without cars (not uncommon here), and for kids below driving age, the pool location is virtually inaccessible. Why this issue wasn't addressed during the past few years as residents patiently waited for the pool is a wonder, but how to resolve it as not. Public transit exists, and though there are no direct routes, it is possible to use it. Plans are underway to revise the transit

routes so quicker access is available next year. For the remainder of this season, there is also the option of paying \$1.50 each way (per rider), for door to door service providing reservations are made in advance. Updates on ongoing projects such as the Tonto Creek bridge were also featured.

KJAA enhances its public service presence with two long-form nationally produced shows chosen for their coverage of issues impacting the local area. Unlike stations that choose to bury required public interest programs, KJAA is proud to offer an hour long block of this information in morning drive on Sundays.
