3<sup>rd</sup> QUARTER 2023

As is usually the case in Globe Miami, summertime brought wildfires. This year, however, the impact locally was minimal beyond a full closure of Highway 60 between Globe and Show Low for several days. Reminding residents of wildfire danger and how to mitigate fire damage, particularly by cleaning up property yards to avoid spreading, was an often-heard message on KJAA this quarter.

In addition to its unique blend of music, comprised primarily obscure soul and R&B from the 1950s and 1960s mixed with sambas, pop standards, instrumentals and early rock and roll chosen for its local appeal without regard to national popularity; KJAA airs public service announcements around the clock along with hourly weather, news items and immediate updates when dangerous conditions exist, as well as at least one full length morning drive local newscast each weekday morning including local job openings. KJAA does not attempt to compete with national news sources. Using a need-to-know approach, KJAA focuses exclusively on local events and concerns. KJAA is heard on 1240 AM, and on 106.1 FM via translator K291CU.

Discussion of the local **Economy** would be impossible without reviewing the current state of **Mining**, as the two are inextricably linked here. 2<sup>nd</sup> quarter 2023 reports were released this summer from all the mining giants. *Freeport McMoRan*, which as they always do, hosted the mega 4<sup>th</sup> of July fireworks display here, and their 2<sup>nd</sup> quarter results gave them much to celebrate: a profit of \$343 million, consolidated copper production of 1.1 billion pounds at an average price received of \$3.84 a pound and an average cost of production of \$1.47 a pound.

Australia-based *BHP*, which is a large landowner locally (over 4,000 acres), but not currently an active mining concern here, finished their fiscal year (ending 6/30/23) with a strong quarter. Inflationary pressure impacted business, but gains were still impressive.

Vancouver BC-based *Capstone Mining*, with its Pinto Valley mine near Miami, continued to experience losses: a \$33.9 million loss in the 2<sup>nd</sup> quarter of 2023, due in part to lower production levels (including unplanned downtime in the crushing circuit at Pinto Valley resulting in the loss of 12 production days), and lower cost per pound of copper. On the positive side, the construction of the company's Mantoverde mine in Chile is on time, on budget, and ahead of schedule.

*Grupo Mexico* reported \$7.43 billion (US) in 2<sup>nd</sup> quarter 2023 revenue, 5% higher than a year ago. \$5.6 billion came from the mining division. Copper prices were 10.6% lower this quarter than the 1<sup>st</sup> quarter of 2023 (a year ago, copper was selling at \$4.34 a pound, this past quarter it brought \$3.85 a pound), and the cost of production was higher: \$1.60 a pound (which is a 10.2% year over year increase). Even so, consolidated profits were \$668 million for Grupo Mexico, the fifth largest copper producer in the world with 30,000 direct employees and 110,000 contractors globally. (The strike at nearby Asarco has never been resolved.)

Declining copper prices affected all mining concerns this quarter. In July, Reuters proclaimed copper prices to be going through deflation. China is part of the problem. The communist country has been a core driver of copper pricing over the last two decades, both from in-country expansion with new cities and infrastructure, and from exported product, where China has been seen as the world's workshop. Higher inflation and lower demand have taken their toll. In September, after a sharp rise in copper inventory worldwide and weak imports from China, copper prices dropped again.

Meanwhile, Russia has started production at the country's largest undeveloped mine, sitting Russia's largest copper deposit: an estimated 26.7 million tons, originally discovered in 1949. The Udokan project is expected to product 150,000 tons of copper in the form of cathode and concentrate.

Like the rest of the country, **Inflation** continues to be a jaw-dropping problem here, evidenced particularly in gas prices. The first two months of the 3<sup>rd</sup> quarter, July and August, brought relatively good news when gas prices across the state were under \$4.00 (for regular unleaded), as low as \$3.09 in Bullhead City at the end of July. It seemed like Saudi Arabia's attempts this quarter to increase gas prices by decreasing oil exports was having no effect. Whether it was a factor or not, the undeniable truth is that by the end of the 3<sup>rd</sup> quarter, prices across the state crossed the \$5.00 mark. For an area such as Globe-Miami, which virtually requires driving long distances regularly, the impact of high gas prices is notable.

The best news about the local **Infrastructure** was not confirmed at the end of the quarter, but expected to be soon: The Tri-City Sanitary District (TRSD) has found a wastewater processing site. If that is the case, it's expected that construction on Phase One can start next year. Getting the area off cesspools continues to be a 'beat the clock' proposition. As it is illegal to repair a failed cesspool and as most property lots are not sufficient to accommodate a septic system, properties are routinely abandoned, increasing the significant **Blight** problem here. The TRSD project will be constructed in three phases, so for many property owners this is far from a quick fix, but the start of construction would end what has been a well over a decade wait for any sign of progress.

Statewide, a telephone infrastructure change occurred this quarter. Approved in 2021, but in effect this quarter, Valley residents must use 10 digit dialing if they are in area code 602 (at one time the state's only area code), 623 or 480. Previously the three area codes served specific portions of the Phoenix metro. Now, all three area codes are available to anyone there. Numbers will not change, but new subscribers will have their pick of the three area codes. (To a great extent, the impact will be minimal beyond needing to dial the area code even if you're calling the home next door, as landline usage is continually decreasing, and cellular and VoIP customers already have their choice of area codes.) No rate changes are involved.

While the local **Environment** was spared extensive wildfire damage this quarter, a week didn't go by without the announcement of a wildfire reasonably close by. None involved thousands of acres, but their frequency was a stark reminder of what can happen with virtually no notice. Fire danger remains a concern as the quarter comes to a close. And flooding, while not of the amount that normally accompanies rains on sites with massive burn scars, is already in evidence. Numerous Flash Flood Warnings were broadcast this quarter in conjunction with Severe Thunderstorm Warnings.

The big **Education** news this quarter did not involve the lackluster K-12 public school districts which continue to be a detriment to attracting new residents. This quarter saw what many considered a misstep by the local community college. Gila Community College (GCC) for 50 years has been operating under an agreement with Safford's fully accredited Eastern Arizona College (EAC), enabling it to offer accredited courses, certificates, and degrees. With little fanfare (and absolutely no notice to EAC), GCC announced in May that they were terminating that agreement, effective in June 2024, in order to pursue independent accreditation. EAC responded this quarter by accelerating the end date of the agreement to September 30<sup>th</sup> to avoid students and teachers facing an unknown future at a time when immediate answers are integral to career planning.

After much several meetings, EAC agreed to extend the operating agreement through the Spring 2024 school semester. What will happen after that remains to be seen, but GCC has several months to figure it out. The quarter came to a close without a hint of what they'll do.

Creating interest and participation in **community meetings** is the often-elusive goal of local community leaders everywhere. To facilitate wider-reach and easier-access, District Two Supervisor Tim Humphrey of the Gila County Board of Supervisors uses KQSS as the origination point for his local monthly meeting. Listeners and residents are invited to participate, but for those who miss the live meeting, it is replayed the following weekend on KJAA. Here's a review of this quarter's meetings heard on KJAA:

#### Supervisor Humphrey Community Meeting

Sunday July 16, 2023 8-8:30 AM

Globe Mayor Al Gameros joined Tim for this on-air meeting. He provided the details of the Globe Pool that is now open and is free to residents throughout this year. The swimming hours for the general public are currently noon until five PM. That leaves mornings free for swim team practice. Occasionally, events after 5 PM necessitate the cut off, but most evenings, the pool is idle. With daylight in the area until after 7:30 in the summer months, and hotter temperatures earlier in the day, keeping it open later is desirable. The problem however is staffing, including lifeguards. Mayor Gameros agreed to look into ways to extend the hours. He, like Supervisor Humphrey is working on public transportation to the facility. The Mayor also gave updates on infrastructure projects including bridge construction, expansion at the dump, federally funded sidewalks; and an upcoming visit by US Rep Eli Crane at the Miami Memorial Library.

#### Supervisor Humphrey Community Meeting

Sunday August 20, 2023 8-8:30 AM

The meeting focused on infrastructure updates. There was a delay on the expansion of the landfill. It's expected approval will be gained from the state at the end of the month. Much confusion ensued over the new rules governing hazardous waste. Many residents interpreted them as including general household waste. The language has been clarified to state it does not. Dollar Dump Days will likely return in October. Tim's new assistant Christine Hake is now on the job, and a new events coordinator for the fairgrounds has been hired. She's Bianca Arrellin. A company has been hired to conduct an assessment of the fairgrounds, including bringing the electrical system up to code. The upcoming fair highlights the need for power availability as many portable generators will be used for that event.

#### Supervisor Humphrey Community Meeting

Sunday September 17, 2023 8-8:30 AM

The Gila County Fair begins next week. Events and infrastructure needs were reviewed. The local area transportation system is under revision. The contract with the Town of Miami has expired and

ascertaining the needs of the municipalities and unincorporated areas in Southern Gila County are ongoing. The Tonto Creek Bridge is now 50% completed and on schedule to open next Spring. ADOT is doing a study on reopening SR88. The 7-mile segment between Milepost 222 and 229, which is still closed to through traffic. Horseback and bicycle traffic is currently permitted. The NRA Youth Association did very well at the competition shoot. This is a fairly new group, and they exceeded everyone expectations.

After joining Supervisor Humphrey's July meeting, City of Globe Mayor Al Gamos requested we also give him time on KQSS for a community meeting. We were happy to oblige. Mayor Gamos' meeting followed Tim Humphrey's in August and September and replayed the following Sunday on KJAA. Here's what was discussed:

#### Mayor Gamos Community Meeting Sunday August 20, 2023 8:30-9 AM

Globe is getting Grant money! The city council had a public hearing last month. The fiscal budget for 2023-24 was adopted for the city of Globe last month at 65,334,122. That's an increase of \$23 million, \$21 million of which is earmarked for possible unfunded grants. This is necessary as the money must be allocated in order for the city to accept a grant. If a grant is awarded and the contribution needed from the city has not been approved, the grant must be declined. The \$21 million will ensure the city can take advantage of grants it receives. Economic Development continues to be a focus, but in order to successfully attract new entities, the infrastructure must be better than it now is. Quality of life, recreational opportunities and housing are vital, but infrastructure is the starting point, and Globe is not where it should be in a number of categories including broadband. Upload speed, in particular, is lacking. The Community Center Pool is complete and evening hours are now available. The Community Center is no longer on septic. The public sewer line is now connected. WIFA funds helped pay for it. The project has enabled many homes near the center to connect as well, allowing them to avoid the possibility of condemnation in the event of cesspool failure.

#### Mayor Gamos Community Meeting Sunday September 17, 2023 8:30-8:45 AM

The Annual Citizens Academy class #5, a 7-week program for citizens to learn about each city department including Council, Administration, Finance, Public Works, Police, Fire, and Library begins this month. There's no charge, meals are included and prior graduates are now filling many volunteer roles in the community, with one hired as a paid employee. The mayor will give the 3<sup>rd</sup> annual State of the City address later this month at Veterans Park including entertainment, a live band and food trucks. The rural policy forum organized by the state and Local First was held in August in Globe-Miami, focused on capacity building, sharing best practices and networking. The event has been held in various communities over the past sixteen years, and this year's Globe-Miami location, representing all 15 Arizona counties, brought a record number of attendees and widespread praise for the area.

KJAA enhances its public service presence with two long-form nationally produced shows chosen for their coverage of issues impacting the local area. Unlike stations that choose to bury required public interest programs, KJAA is proud to offer an hour-long block of this information in morning drive on Sundays.

Health Care is an issue of critical importance to all Americans. Not only is cost a factor for most people, in rural areas like Globe-Miami in particular, availability is an issue, from where to find care to what treatment options exist. **Radio Health Journal** is a weekly
