4<sup>th</sup> QUARTER 2023

In Globe-Miami, the fourth quarter of 2023 was dominated by the same holiday spirit found throughout the nation and most of the world. October's Halloween events kicked off an active Autumn with Thanksgiving celebrations and a myriad of Christmas festivities. The woes of the world, and even concerns closer to home, took a back seat to the buoyancy of the Season with reasons to celebrate the progress of multiple projects underway to improve the local standard of living including bringing sewers to a large swarth of the area, the promotion of commerce and tourism, and an assault on blight.

In addition to its unique blend of music, comprised primarily obscure soul and R&B from the 1950s and 1960s mixed with sambas, pop standards, instrumentals and early rock and roll chosen for its local appeal without regard to national popularity; KJAA airs public service announcements around the clock along with hourly weather, news items and immediate updates when dangerous conditions exist, as well as at least one full length morning drive local newscast each weekday morning including local job openings. KJAA does not attempt to compete with national news sources. Using a need-to-know approach, KJAA focuses exclusively on local events and concerns. KJAA is heard on 1240 AM, and on 106.1 FM via translator K291CU.

**Mining** has always been a mixed blessing to the region. While detractors quickly point to the environmental fall out from mining, and proponents are equally eager to recount its economic benefits to the area, regardless of emotional opinions, mining remains the lifeblood of Globe-Miami. Continual effort has been made to diversify from mining, but as yet, the closest contender to the economic impact of mining here, would be the county government, a major employer based in Globe.

It's more likely than not that every resident has at least an indirect connection to someone who worked in mining. And for many of them, the pensions arising from a long-term mining career form the bulk of their retirement income. For this reason, much attention is paid to mining news and KJAA features mining related reports frequently. This quarter saw the release of third quarter 2023 reports from most of the mining giants with a local presence here. Stories included:

Copper price reports: Prices were relatively steady this quarter. The highest one-day price was \$3.85 a pound and the lowest was \$3.73. While these are healthy numbers, they pale compared to copper's 2023 high of \$4.25 reached on January 23<sup>rd</sup>.

Freeport McMoran (FMM)'s 3Q23 results: The Phoenix-based mining giant had a net profit of \$454 million dollars including consolidated sales of \$1.1 billion pounds of copper. Average price sold for each pound of copper was \$3.80, with a cost to produce of \$1.73 a pound. Copper output at FMM's Arizona mines was 146 million pounds at Morenci, 47 million pounds at Green Valley, 39 million pounds at Bagdad, 6 million pounds at Safford, and 3 million pounds here in Miami where the massive smelter is located. Another report featured FMM's declaration of a dividend this quarter, payable in February.

News was not as rosy for Vancouver BC based Capstone Mining which has its largest open pit mine west of Miami, in addition to the Cozamin mine in southern Mexico, and mines in Chile including Mantos Blancos and Monte Verde. Stories included: Capstone's 3Q23 report revealing a net loss of \$42.3 million US dollars compared to a net income of \$37.5 million US dollars last year at this time. (The blame was laid in large part on the impact of eight days of unplanned downtime at Pinto Valley related to secondary jack shaft replacement and counter shaft repair.) Total copper sold was 38.7 thousand tons, down from 44.2 thousand tons a year ago. Capstone also released operational details in its upbeat 2022 sustainability report, required by the Canadian government.

BHP, the Australian multinational mining and metals company based in Melbourne, Australia, which is not actively mining in Globe-Miami but maintains a huge presence here as the owner of 5,000 acres of land including the old Dominion Mine which is now a Globe park, announced 3Q23 results. Copper production was 457 kilotons, which is an 11% increase in copper production this quarter compared to a year ago. Average price realized per pound of copper was \$3.63. BHP continued to actively explore drilling potential on their land here, but their focus this quarter was on their \$6.4 billion investment in stage 2 of their potash project in Saskatchewan.

Once again, lacking this quarter were stories about the progress of the giant underground Resolution Copper mine in their quest to begin operations. Coverage concerned the underlying issue. Inarguably, the mine would be a giant boost to the local **Economy**, restoring viability to the town of Superior and enhancing the financial picture of surrounding areas such as Globe-Miami. But the holdup lies in the claims of the San Carlos Apache tribe which believes the federal land swap previously approved by congress did not properly address the history of Oak Flats, a swath of land the tribe is calling sacred. Hostilities remain as other people, including some tribe members, see the area as not more than 'a great place to drink beer'. The current political administration favors rescinding the land swap, which resulted this quarter in furthering the ongoing idling of what was expected to be nothing short of an economic windfall to the impoverished area.

Coverage was given to a community working group focused on the mine's benefit. A meeting was held in Superior on November 8<sup>th</sup> with an extensive ADEQ report highlighting the ways in which the mine's operation is planned to protect the environment, and the efforts to enhance the good neighbor agreement between the mining company and the community. But the year ended with Resolution Copper no closer to an opening date than it was when the year began.

**Inflation** continued this quarter, as it did throughout the country, but seemingly at a more modest rate. At least, that's how it appeared in the gas price reports, which air weekly. For the most part prices everywhere remained under \$4.00 a gallon throughout the quarter, with some areas, including a handful of towns in the counties surrounding Gila (where Globe-Miami is located) reporting prices as low as \$2.50 a gallon. Pinal County, next to Gila, is revealing. Areas such as Casa Grande had prices at the lower end of the spectrum, while Apache Junction, also in Pinal County, regularly saw prices in excess of \$4.00. Globe-Miami generally registered prices around \$3.50 a gallon. The figures were of particular interest this quarter as holiday travel undeniably increased fuel usage. A survey of 3,000 Arizonans at Thanksgiving revealed the average travel time for state residents was 5.9 hours over the holiday weekend.

In an attempt to increase **Tourism** as well as local interest, the Copper Corridor Economic Development Coalition based in nearby Superior launched the "Copper Corridor Crawl Adventure Passport" in conjunction with the [www.discovercoppercorridor.org](http://www.discovercoppercorridor.org) website. The program was the subject of several reports this quarter, as it highlights area attractions and businesses in a three-pronged approach. "Diverse Destinations" gives passport holders insight into historic towns, scenic vistas, cultural landmarks, restaurants and more. "Cultural Enrichment" immerses passport holders in the unique aspects of the Copper Corridor's history and traditions. And "Prizes and Rewards" provides perks for involvement ranging from prize packages to exclusive discounts from local businesses and organizations.

But no matter how good a program is to entice people to the Globe-Miami area, the largest problem to overcome is the overwhelming **Blight** here. There were multiple reports on the progress made this quarter, albeit at an almost glacier-like pace. Most visible was the Pinal Cemetery, previously reported as abandoned. While internments continued, there was no one responsible for the Central Heights cemetery's upkeep, save the preservation of a few culturally ethnic sections. This quarter's news included details on the newly formed Gila County Memorial Foundation, a partnership of Gila County Public Works, the Tonto National Forest, and the previous Globe Miami Memorial Foundation. Members include Gila County government, City of Globe, Lamont Mortuary, Gila County Historical Museum, Bullion Plaza, Globe Elks Club and Gila County 4H. The group meets every third Tuesday of the month at the courthouse. Among their missions is cataloging biographical records and assisting with the planning and upkeep of local cemeteries.

Forward motion continues at the Tri-City Sanitary District. Reports highlighted the group's new website that reflects their efforts; the IGA that has been signed with the city of Globe; and the appointment of a new board member. Most importantly, residents can finally rely on the news that a sewer system is coming. Without it, properties which have outdated cesspools will continue to be abandoned when cesspools fail and legally sanctioned replacements are not possible due to the small lot sizes.

The Tonto National Forest released its latest long-term management plan this quarter (every national forest is required to have one and update it regularly). The Tonto's goals include active landscape management to support plant and wildlife habitations. Prescribed burns were announced, and the smoke impact on Globe-Miami was reported. Also announced was the Tonto joining forces with the Muledeer Foundation to restore the wildlife habitats on 3300 acres affected by wildfire. The ever-present **Wildfire** danger underscores the importance of public/private partnerships to combat what often becomes a crisis.

A perfect example of that partnership is the Freeport McMoRan Foundation. It was announced the mining giant provided \$295,000 in **Infrastructure** grants for Globe-Miami projects this quarter including \$160,000 to Globe for Besh Ba Gowah restoration; \$100,000 to Miami for downtown revitalization (the importance of which can not be overstated—a drive through Miami aptly displays the shocking need for attention); and \$35,000 for the new Gila Community College to help fund the nursing and allied health programs.

Road construction had minimal impact on the community this quarter, though reports centered on Hwy 70 delays in November. Unfortunately, vehicular accidents were more to blame for highway closures this quarter than planned events.

Higher **Education** continued to dominate the scholastic news this quarter as Gila Community College (GCC)'s misstep in May (unilaterally announcing the end of the 50-year partnership with Eastern Arizona College (EAC) for accreditation), continued to reverberate. Exactly what GCC will do for accreditation in the future remains unknown, but this quarter brought multiple reports on how EAC will be winding down its involvement to serve already enrolled students: Two-year programs that began this Fall will be accredited through the Spring of 2025. No new students will be accepted. Final enrollment for programs one year or less in length will be accepted in the Fall 2024, with no enrollment after that date for any student. The contract between the two schools will end on 6/30/25. What GCC will do to gain accreditation on its own will likely be the subject of robust reports next year.

Creating interest and participation in **community meetings** is the often-elusive goal of local community leaders everywhere. To facilitate wider-reach and easier-access, *District Two Supervisor Tim Humphrey* of the Gila County Board of Supervisors uses KQSS as the origination point for his local monthly meeting. Listeners and residents are invited to participate, but for those who miss the live meeting, it is replayed the following weekend on KJAA. Here's a review of this quarter's meetings heard on KJAA:

#### Supervisor Tim Humphrey Community Meeting

Sunday October 15, 2023 8-8:30 AM

Robert Jacques, Tri City Sanitary District Board President, provided a thorough overview of the project, which when completed will finally give the unincorporated areas between Globe and Miami a much-needed municipal sewer system. BHP Copper has donated the site where the wastewater treatment plant will be located. It is two miles north of Highway 60 on the west side of Highway 188 at the north end of Phase III of the project. Work on construction of the collection system will begin in the 1<sup>st</sup> quarter of 2024, with an estimated online date, if all goes as anticipated, at the end of the 3<sup>rd</sup> quarter 2025. Financing for Phase I was previously obtained, and the board is working on obtaining grants for Phase II and III. Loans for all three phases total \$32 million, which is a fixed amount, but full construction costs could reach \$77 million given inflation and other factors, so grants totaling \$55,000 are being sought. Jacques hopes to have information on that by the end of this month. Property owners (through taxation) will be responsible for the repayment of the \$32 million in loans. Paying the portion of grant money that the district will need to provide to satisfy the terms of various grants will come from the Operations & Management budget, with payment by connected users reflected in the monthly sewer bills. However, Jacques stressed that there is also a significant income stream expected from the sale of the effluent, which BHP has the first right to buy.

#### Supervisor Tim Humphrey Community Meeting

Sunday November 19, 2023 8-8:30 AM

Globe-Miami is tremendously blighted. A big contributor to the problem is arcane state regulations governing properties. Entities (be they individuals or businesses) can buy the tax lien on a property in default. And they can continue to pay the annual taxes. But they have ten years to actually transfer the property into their own names. What that means is the taxpayer is not necessarily the owner, and if the taxpayer is not the owner, the taxpayer is not liable for the upkeep of the property. In this situation, there is generally no owner to be found. The result is blighted properties, with no one responsible to the county for fines. Supervisor Humphrey's goal is to change the regulations. He wants to make the taxpayer on a property liable for that property, just as an owner is. He discussed the issue at length in this meeting and revealed he's enlisted other counties in the state with the same problem, as well as the county attorney. Additional topics were the ongoing upgrades to the County Fairgrounds (permanent bathrooms have been installed); progress on the Tonto Bridge (it should be open to traffic by April 2024 and completed in June); and the status of the county landfill, which should see the return of Dollar Dump Days in January. He also reviewed some of the dump rules including the acceptability of large deceased animals and the limit on the number of tires a resident can dump annually.

Supervisor Tim Humphrey Community Meeting  
Sunday December 17, 2023 8-8:30 AM

Short Term Rentals are a growing source of income for some Globe-Miamians. With online ease through sites such as Airbnb and VBRO, it makes sense for absentee landlords to utilize their properties in this manner. But without any oversight, it also has the potential of creating numerous problems for full-time residents. In this monthly meeting, Gila County District 2 Supervisor Tim Humphrey reported on actions taken by the Board to codify requirements and obligations of property owners who wish to rent out properties in this manner. He also reviewed the issues behind declining the permit for a new cell tower at Jake's Corner, in his district. He explained that the other two supervisors voted against it, and his lone vote was not enough to carry the measure to the disappointment of Vertical Bridge and T-Mobile. And among several other things, he reviewed the success of "Discover Gila County", a program and website to lure tourists to the area.

*City of Globe Mayor Al Gameros'* monthly update follows Supervisor Humphrey (live on KQSS at 6PM, replayed on KJAA the following Sunday at 8:30). Here's what was discussed this quarter:

Mayor Al Gameros Community Meeting  
Sunday October 15, 2023 8:30-9 AM

Mayor Gameros reviewed his State of the City address, given to the public recently. The theme was "Globe Forward" with a strategic action plan focused on updating aging infrastructure; economic development for business and tourism; and improving the quality of life for area residents including increasing housing option. The mayor emphasized his awareness of additional staffing responsibility, saying that as the city grows, it comes with greater demands and higher expectations for service, which means an increase in capacity of departments to manage resources and services. Gameros followed up on last month's discussion of obtaining grants, noting that it is very positive for Globe that the scope of grant funding is moving more toward helping rural communities than urban areas. Federal, state and private grants are being sought. In order for the city to prosper, protection of the current business community and cultivation of new entrants demands updated codes and strong enforcement. Gameros said the fire and building codes are currently under review, with an eye toward eliminating the widespread blight here. He mentioned the abandoned historic property known most recently as the Oyo Motel, which flooded out a few years ago, has been purchased and will be rehabbed, and that the Economy Inn, which burned beyond repair earlier this year has been demolished with expectations for a replacement to be constructed. Schools continue to be a vexing issue, and perhaps with the retirement of Globe Superintendent Jerry Jennix, unification of the Globe and Miami districts can again be considered.

Mayor Al Gameros Community Meeting  
Sunday December 17, 2023 8:30-9 AM

Mayor Gameros had reason to be proud at this month's meeting as he outlined numerous grants the city has been successful in obtaining including \$160,000 to stabilize the walls and roof at Besh Ba Gowah, a major tourist attraction here; \$25,000 towards the construction of a concession stand at the community pool, \$25,000 from APS for a storage trailer to be used in conjunction with the popular First Friday events, monthly in historic downtown Globe, and more. Through an IGA, the state of Arizona will be providing Globe and the Globe Unified School District \$420,000 over three years for three resource officers to be deployed to Globe's three local schools. Water, an increasing issue throughout the country, got a boost from a three million dollar grant from the federal government for upgrades, but it requires \$750,000 in matching funds which the city is budgeted to provide. Beautification and codes (building and fire) were also discussed, as was progress on the conversion of the old school on Hwy 60 into senior housing. There will be 64 units, however, only 35 parking spaces are allocated, an amount too small, but within the code requirements.

KJAA enhances its public service presence with two long-form nationally produced shows chosen for their coverage of issues impacting the local area. Unlike stations that choose to bury required public interest programs, KJAA is proud to offer an hour-long block of this information in morning drive on Sundays.

Health Care is an issue of critical importance to all Americans.
