IN 2012, NEARLY ALL THE BIGGEST CORPORATIONS IN MINNESOTA DECLINED TO SIGN A STATE REFERENDUM BANNING GAY MARRIAGE. NOW, TARGET HAS SIGNED A COURT BRIEF SUPPORTING MARRIAGE EQUALITY, A MOVE SIMILAR TO STARBUCKS, INTEL, AND APPLE.
