**Topic:** Carter County Drug Prevention Coalition and Bridge to Shore Recovery

**WBEJ's Involvement:** 9:35am: David Miller did an on-air interview with Nash Acuna, Opioid Prevention Coordinator with the Carter County Drug Prevention Coalition and Tia Hughes with Bridge to Shore Recovery. Bridge to Shore Recovery provides a path for women in recovery to heal, rebuild self-esteem, and repair relationships through connecting them to 12 step recovery, partnered resources, and housing. Bridge to Shore Recovery believes that every woman deserves the opportunity to be lifted up and provided resources to help achieve long term recovery. The drug crisis continues in the Northeast Tennessee region. Resources were discussed such as drop-off locations for unused or expired prescription drugs as well as prescription drug lock boxes. Listeners were also given location where prescription drug lock boxes are available.
