RE: Retransmission Consent Election Notice

Dear Ladies and Gentlemen:

Tribune Broadcasting Company (“Broadcaster”) provides Windstream (aka Montezuma Mutual Tele) (“Operator”) with this notice pursuant to Section 325(b) of the Communications Act of 1934, as amended, and Section 76.64(f)(2) of the Rules and Regulations of the Federal Communications Commission. Broadcaster is the ultimate owner of the television stations identified in Attachment A hereto (each, a “Station”).

For the period January 1, 2015 through December 31, 2017, Broadcaster and each Station hereby elect RETRANSMISSION CONSENT with respect to each such Station’s digital signal on each of Operator’s multichannel video programming distribution systems (each, a “System”) in each such Station’s respective market, as identified in Attachment A, including, but not limited to those Systems identified in Attachment B. Accordingly, your MVPD system(s) may not retransmit the broadcast signal of any Station, or any portion(s) thereof, until you obtain Broadcaster’s express written consent.
