### **Section II. Responsive Programs**

### A. EDUCATION:

"News Story"—Broadcast on January 5<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Indiana's minimum teacher salary would increase by 50-percent, if a new law proposed by local State Representative Sheila Klinker passes the General Assembly. Klinker wants to increase the base salary to 60-thousand dollars a year. The current minimum is 40-thousand. Klinker says raising teacher pay is the start of recruiting new educators. A salary hike has been recommended since Governor Holcomb's "Next Level Teacher Compensation Commission" report in 2020.

- "News Story"—Broadcast on January 10<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Lilly Endowment is committing 100-million dollars to Purdue University. Grants include 50-million dollars to the Daniels School of Business and the Purdue Computes program. Funding will support construction of a third building at the business school. Construction is set to begin in July. The money will also go toward computing departments, artificial intelligence, semiconductors and quantum projects.
- "News Story"—Broadcast on January 17<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A local high school coach is currently on paid leave. Seeger High School Girls' Basketball coach, Chad Wetz, has been suspended with pay for the remainder of the season. At this time, he is accused of sexual misconduct. Wetz took over the program last year. Right now, the Lady Patriots are under the leadership of Kevin Peterson. No one has been able to comment at this time.
- "News Story"—Broadcast on January 22<sup>nd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Long-Time Teacher and Coach Betty Bolyard was honored during half time of the Harrison Raiders Basketball game. Bolyard coached and taught at Harrison for thirty seven years. During her time at Harrison, Bolyard was the head coach of the girls swimming, volleyball, gymnastics, and track and field teams where she led her team to the first state championship. The Tippecanoe School Corporation unanimously approved to name the school track in Bolyard's honor.
- "News Story"—Broadcast on February 16<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Lafayette Jeff student has been arrested for allegedly making threats of a school shooting. Lafayette police got a tip around 4:30 Wednesday afternoon of a 15 year-old student making school shooting threats on Snapchat. The tip led investigators to a home in the 800 block of Eastwich Drive where they arrested the female student around 7:20 Wednesday night. Lieutenant Justin Hartman says there's no ongoing threat, but L-P-D increased its presence at the school Thursday.
- "News Story"—Broadcast on February 16<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Lindberg Road between Klondike Road and U.S. 231 was shut down for hours yesterday morning after a three-vehicle crash involving a school bus. West Lafayette police say a T-S-C bus hit a passenger car around 7 yesterday morning. Police say the drivers of the school bus and one of the cars were taken to the hospital with unknown injuries. TSC spokesperson Sue Scott says the bus driver was starting her route with no children on board.

#### **B. COMMUNITY INVOLVEMENT:**

- "News Story"—Broadcast on January 3<sup>rd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Two local counties will use state grant money to improve their elections. Secretary of State Diego Morales stopped to hand out money to 6 Indiana counties including Benton and White Counties. The money is part of the Federal Help America Vote Act grant and will go toward security improvements, poll worker training and outreach and education initiatives for voters. A total of 2 million dollars is being awarded to more than 60 Indiana counties.
- "News Story"—Broadcast on January 4<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. An audit of Taletha Coles is revealing how much taxpayer money the former trustee misused. The report by the Indiana State Board of Accounts shows Coles wrongfully spent more than 138-thousand dollars. Auditors say she spent the money on things like motivational courses, salon trips, restaurants and gym equipment. As we've reported, the more than two-year-long audit began in 2021 as whistleblowers came forward.
- "News Story"—Broadcast on January 11<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Democrat Joe Mackey is filing to run for an at-large seat on the Tippecanoe County Council. The window to file for the May primary election opens today until February ninth. A spokesperson for the county election board confirmed Mackey's entrance into the race. At-large Republican incumbents Kevin Underwood, John Basham and Barry Richard haven't filed for reelection yet.
- "News Story"—Broadcast on January 12<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Days after being sworn in as Monticello Police Chief...Curt Blount (Blunt) has reportedly resigned. A press release is expected to be sent from the Mayor's office regarding the new police chief's resignation. On Monday Curt Blount was sworn in as police chief of the Monticello Police Department, resulting in the resignation of two officers at the meeting.
- "News Story"—Broadcast on January 12<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A high rise development is being planned in West Lafayette near Purdue University's campus. The project is being called The Standard at West Lafayette at 2-10 West Wood Street behind Chauncey Hill Mall. The 13-story proposal includes 254 multi-family apartments, additional green space and an above-grade parking garage. Construction could start in the spring of 20-25. The APC will consider the plan during an upcoming meeting.

- "News Story"—Broadcast on January 16<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The future of a controversial housing development in a rural part of West Lafayette depends on a vote tomorrow night. The Tippecanoe County Area Plan Commission will consider rezoning a 23-acre plot of land on South River Road west of U.S. 231. The rezoning would make way for a multi-family housing complex by Trinitas Development. Land owners near the project wrote letters to the APC voicing their opposition and suggesting even more people are against the development.
- "News Story"—Broadcast on January 17<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Purdue University is asking for blood donors as the American Red Cross continues to face a nationwide blood shortage. The Red Cross says the number of people giving blood is at its lowest level in 20 years. This week's blood drive will take place on Thursday at the Armory Building on Purdue's campus in room 106 from 10 a.m. to 3:30 p.m. That address is 812 3rd Street in West Lafayette. To schedule an appointment, please visit red-cross-blood dot org.
- "News Story"—Broadcast on January 19<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Tippecanoe County has seen high numbers of opioid deaths in the last few years. But right now, opioid deaths in the county are down 5 times compared to the rest of the state. Recovery Cafe in Lafayette held an event to discuss the drop in numbers. Tippecanoe County Health Officer Dr. Greg Loomis credits this decrease to partnerships with the county coroner and local assistance programs.
- "News Story"—Broadcast on January 22<sup>nd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Volunteers are needed for the annual Point-In-Time Count of Tippecanoe County's homeless population. The count happens on Thursday from seven in the morning until seven at night. Volunteers are meeting at 515 Columbia Street in downtown Lafayette. The data is used assess the problem in our community and an eight-county region.
- "News Story"—Broadcast on January 24<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Six new officers have joined the ranks of West Lafayette police force. That's also the largest hiring class in the department's history. Officers Parker Lorch, Joseph Przybylowski, Brendon Cheever, Owen Walbaum, Alex Alge, and Nicholas Jordan were sworn in yesterday at Margerum City Hall. Four officers will attend the Indiana Law Enforcement Academy during the spring, while two officers will be released to solo patrol after completing field training.
- "News Story"—Broadcast on January 26<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Homelessness continues to be an issue in Greater Lafayette. Volunteers and non-profit employees are assessing the issue as part of the annual Point-In-Time Count. The count happened all day yesterday at LTHC, LUM, local food pantries and other locations across Tippecanoe County. Volunteers also walked local streets, trails, and parks in an effort to find people who need services. The numbers help the state decide how to distribute money for homeless services and programs.

- "News Story"—Broadcast on January 30<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Purdue University Airport's new terminal will be named after one of the most famous aviators of all time. The terminal will be named after Amelia Earhart... who worked for Purdue and famously embarked on a record-setting solo flight across the Atlantic Ocean. Construction on the 8-thousand-square-foot, 12-million dollar terminal will begin in May and will be done by May of next year. As we've reported, a new commercial airline service will come to the airport in the early second quarter of 2024.
- "News Story"—Broadcast on January 31st, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Several firefighters are advancing their careers with the Lafayette Fire Department. 5 promoted firefighters were joined with their families and colleagues at Lafayette City Hall as they climb the department's ranks. Lafayette Fire Chief Brian Alkire and Mayor Tony Roswarski are congratulating...Deputy Chief Jamason Blacker... Captain Scott Guinn ... Lieutentant Ben Bumgarner... and Sergeants Jared Faust and Xavier Passement.
- "News Story"—Broadcast on February 5<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Celebrating Black History Month, the N-A-A-C-P Greater Lafayette Branch held their Freedom Fund Banquet yesterday evening. At the banquet, they swore in newly elected officers, a national advisor, as well as the Governance and Policy Director. President of the Greater Lafayette Branch Sadie B. Harper-Scott was in attendance, and spoke at the event. In part, she spoke about how she wants to help make a difference in the Greater Lafayette Area.
- "News Story"—Broadcast on February 5<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Indiana Senator Mike Braun officially filed signatures to officially qualify to run for governor on Friday. He filed over twelve-thousand, six hundred signatures with the Indiana Secretary of State. So far, five people are running in the Republican primary for governor. Brad Chambers, Lieutenant Governor Suzanne Crouch, Eric Doden, Curtis Hill, and Jamie Reitenour are running as Republicans.
- "News Story"—Broadcast on February 26<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Thousands of flags have covered Memorial Mall at Purdue over the past week. There are approximately 14-thousand flags on the mall, each representing a child killed in Gaza since October 7th. A sign posted at the demonstration says that at the time of printing, over 14-thousand, two-hundred children have been killed by Israeli airstrikes. This flag vigil was organized by Purdue University Students for Justice in Palestine.
- "News Story"—Broadcast on February 26<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The annual Polar Plunge at Purdue took place outside of Lambert Fieldhouse over the weekend. People from all over the greater Lafayette area gathered to dive into a pool of water in support of the Special Olympics. Over 50 thousand dollars was raised this year with the biggest donation being over eight thousand dollars. Now if you missed the Purdue Polar plunge you do still have three chances to participate. The final plunges will take place in Indianapolis next weekend.

- "News Story"—Broadcast on February 27<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The City of Lafayette and Lafayette Parks and Recreation are excited to announce the improvement plans for the S-I-A Playground in Columbian Park. The upper portion of the existing playground will be replaced with new equipment. The revamped area will feature poured-in-place rubber surfacing, three climbing towers that are about 24 feet tall, a rope bridge, interactive panels, and tunnels. The improvements will be finished in time for the peak of the summer season this year.
- "News Story"—Broadcast on February 28<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. People living in Battle Ground have a chance to share their thoughts on a new long-term plan for the town. The Area Plan Commission staff will host an open house to share the updated Battle Ground Area Land Use Plan to the public. It's the culmination of a year of work between APC staff and the Battle Ground Steering Committee. The draft plan is done and ready for feedback. The open house happens from 4-30 to 7 tomorrow evening in the cafeteria at Battle Ground Intermediate School. "News Story"—Broadcast on February 28<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Construction on the Wea Ridge Water Tower is behind schedule. That's costing the City of Lafayette tens of thousands of dollars. Weather, concrete shortages and defective valves caused delays. Now, the city must pay engineering firm BF and S an additional 42 thousand dollars to observe and inspect the work. Lafayette Water Works Superintendent Steve Moore plans to recoup the additional costs from the contractor. The water tower should be done by late May or early June.
- "News Story"—Broadcast on March 5<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Multiple Purdue student groups held a sit-in at last night's City Council meeting in West Lafayette. Several students and residents spoke in front of the council demanding members to pass a resolution calling for a ceasefire in Gaza. Cities across the nation have joined the call for a ceasefire amid the Israel-Hamas conflict. Council members say they will discuss the possibility of a resolution.
- "News Story"—Broadcast on March 6<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. West Lafayette is gearing up for spring leaf collection From March 18th to April 26th. The city is asking people to keep leaf piles 12 inches from the curb to allow water to flow into the drains. They also ask you to avoid blocking bike lanes and keep garbage and sticks out of the piles. And yard waste should be on the curb by 7 a.m. on the day of collection and placed in rigid containers or paper yard waste bags. Branches can't be more than six feet long and six inches thick.
- "News Story"—Broadcast on March 7<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Happening today in West Lafayette, the Wabash Township Fire Department will become the home of the 117th Baby Box in the state. Safe Haven Baby Boxes provide a legal and safe way for women to surrender their babies anonymously. There are now 207 locations in the U.S. The company says West Lafayette and surrounding communities will be better protected with the addition of the baby box. A dedication is set for 10:30 this morning.

- "News Story"—Broadcast on March 13<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Eileen Sutz, a Chicago business woman, donated 2 point 45 million dollars to benefit wolves in North America. One of the three organizations to receive part of the donation is Wolf Park in Battle Ground. Wolf Park will receive around 800 thousand dollars from the donation. They plan to improve buildings and exhibit areas to enhance the visitor experience. The goal is to increase opportunities for education about wolves and their role in our environment.
- "News Story"—Broadcast on March 19<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Governor Eric Holcomb vetoed a bill yesterday that defined antisemitism in public institutions of higher learning. Holcomb's office issued a statement saying he vetoed House Bill 10-02 because of confusing language and because it didn't incorporate the entire International Holocaust Remembrance Alliance's definition. At the same time, the Governor signed a proclamation reiterating that Indiana condemns all forms of antisemitism.
- "News Story"—Broadcast on March 20<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Senator Todd Young is renewing efforts to reduce college costs by helping high school students earn college credits. He and Democratic Senator Maggie Hassan have re-introduced a bill that would also apply Advanced Placement and dual-enrollment credits to their college degrees. Young and Hassan say the grant program would result in higher college completion rates, and lower overall college costs.
- "News Story"—Broadcast on March 21<sup>st</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Indiana State Senator Jean (BRO) Breaux has died just days after resigning for health reasons. Breaux said on Monday that she was leaving the Senate to spend more time with family. Breaux was first elected in 2006 in District 34....which is on the east side of Indianapolis. Her main focus in office was to improve mortality rates for the state's black infants and mothers, and improving access to healthy food and addressing poverty, gun violence, and reproductive justice.
- "News Story"—Broadcast on March 22<sup>nd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The City of Lafayette is cracking down on rundown properties and their landlords. Building Commissioner Jason Burks says it's been an initiative since August. The city's issued 59 clean-up, demolition and repair orders over the past six months. That includes an emergency demolition of 1913 Salem Street after squatters took over the home.
- "News Story"—Broadcast on March 22<sup>nd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Jerry Holeman has been promoted to the rank of Lieutenant at the Indiana State Police Lafayette Post. The promotion process included an interview, a written test, and an assessment of his overall work performance. Holeman patrolled White and Carroll Counties and served as a detective and Investigative Squad Leader with the Indiana State Police. He's also been a key investigator in the Delphi double homicide case.

# C. HEALTH AND WELFARE:

"News Story"—Broadcast on January 3<sup>rd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Two homes in Tippecanoe County are left with bullet holes from random gunfire early in the morning on New Year's Day. Multiple shots were fired into two homes on Sorrel drive in Lafayette. One home was hit twice. One bullet hit the side of the house and another went through the wall into the kitchen and lodged itself in a cabinet. Homeowner Jamie Bogan says the shooting scared her family and required a lot of clean up. No one was hurt and no one's been arrested.

"News Story"—Broadcast on January 4<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A 16-year-old boy is recovering after being hospitalized with a gunshot wound. The shooting happened late Saturday night on Charles Street near the Greenbush Payless. Police say a fight broke out during a party at the house. Officers were first called to investigate shots fired and found shell casings in front of the home. A teenager showed up at the hospital later with a gunshot wound to his hand. Nobody has been arrested, and the shooting remains under investigation.

"News Story"—Broadcast on January 8<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Lafayette home is seriously damaged but a man and woman are OK after a house fire. The fire happened just before 9 last night on North 26th Street near Sunnyside Intermediate School. Lt. Mike Brown says two officers first arriving saw flames coming out of the home's front windows. A man and woman inside the house were able to escape and no one was hurt. The fire remains under investigation.

- "News Story"—Broadcast on January 9<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Matt Reum, the man who spent six days trapped in his wrecked pickup truck in Porter County, is on the road to recovery. After being found by two fishermen, Matt was flown to the hospital in critical condition. He began showing signs of progress and even posted a photo on social media from his hospital bed in South Bend. Matt's leg has been amputated above the knee. He's in rehab and showing improvement every day, and he is thankful for the support from people across the country.
- "News Story"—Broadcast on January 16<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Temperatures are dangerously low right now in Greater Lafayette. Outages have been reported in many cities across Indiana, and if your power goes out during these freezing temps, you need to be ready. You can prepare your house by leaving cabinet doors below your sink open. Let the faucet drip as frozen pipes could go unnoticed for days. Keep a close eye on space heaters and make sure to plug them directly into the wall.
- "News Story"—Broadcast on January 18<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. What caused a fire at Lafayette Interior Fashions and Lafayette Venetian Blind yesterday morning is still under investigation. A company spokesperson says there was a small fire in an inventory storage area due to a small machinery malfunction in the roof of the storage area. None of the building structure was on fire. The fire was called in around 7:30 yesterday morning at 3000 Klondike Road in West Lafayette. The building was evacuated and no one was hurt.
- "News Story"—Broadcast on January 18<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A fire in Monticello yesterday afternoon leaves a home with significant damage. The fire happened at a mobile home near Lake Shafer. Investigators say a man who lived in a trailer on East Honey Creek Drive was using a heat gun to thaw his pipes. We're told he went to take a shower and the mobile home soon caught fire. Two cats died but no one else was hurt. A few nearby homes were also damaged by the flames.
