

PRE-FILING ANNOUNCEMENT

On September 26, 2007, WGGB-TV was granted a license by the Federal Communications Commission to serve the public interest as a public trustee.

Our license will expire on April 1, 2015. We must file an application for renewal with the FCC on December 1, 2014. When filed, a copy of this application will be available for public inspection at www.fcc.gov. It contains information concerning this station's performance during the last eight years.

In the case of unlocked logs:
 Both pairs of bookends and piggy backs are combined.
 Only the first member of a rotation group is shown, this may differ from what eventually is aired.
 In the case of locked logs both pairs of bookends and piggybacks are shown, each with their own AUR.
 The counts for each group indicate the number of spots where it was possible to establish an equivalent AUR.
