- Payment is the in advance of breadcast unless otherwise specified, but in no event, less than 48 hours prior to broadcast time. Payment times be made during normal business hours, 9am-5pm Monday through Friday.
- 2. The Station reserves the right, in its sole discretion, to cancel this contract at any time upon default by the Programmer for non-payment of broadcast time, or for other material breach of contract. If any of the tenns and conditions of this contract is breached by the Programmer, any finiture or refinal by the Station to enforce its right shall at an way constitute a waiver of the Station a rights, or a condonation, and such rights may be enforced at any time during the term of the contract.
- In the avent of termination by the Station for any of the reasons stated in paragraph (2), the Station shall be estitled to retain the security deposit in liquidated changes, plus recover any other additional duranges suffered by the Station as result of Programmar's breach of the contract.
- 4. In the event the Programmer breaches the contract or fails or rufuses to perform to accordance with the terms and conditions of the contract, the Station shall have, it its discretion, the right to enforce the contract for the entire discretion as agreed upon and will hold the Programmer legally responsible for damages and costs uccurred by virtue of the beauth and loss of profit.
