More potential victims of the cop who allegedly brutally beat a great grandmother on the side of the road have come forward, MailOnline can reveal.

A number of people have contacted pressure group Los Angeles Urban Policy Roundtable since sickening footage of Marlene Pinnock being repeatedly punched in the head by a Highway Patrol officer went viral.

The new witnesses say they recognize the cop from the video as someone they have had aggressive run-ins with in the past.

At this stage the claims are unsubstantiated, but sources at LAUPR are determined to thoroughly investigate them in an attempt to determine whether the policeman in question has a history of violence. There has been no suggestion that this is the case up to this point.

According to the **LA Times**, the officer in question has been placed on an 'administrative assignment' out of the field following the attack on Mrs Pinnock, 51, which took place on the side of an LA highway a week ago.

But news he is on full pay, and the California Highway Patrol's refusal to publicly name him has infuriated Mrs Pinnock's family and civil rights campaigners.

And if the claims that he has a history of aggressive behavior prove correct, the anger is likely to grow even stronger.

A LAUPR source told MailOnline: 'We have received emails from people who say they recognize the policeman from the video.'

'They have said they have been stopped by him in the past and he was very aggressive towards them. Obviously these claims are unsubstantiated at the moment, but we would be foolish not to check them out.

'At this stage it is impossible to say whether they are valid or not. For all we know this officer could have an exemplary service record up to this point.

'But if they are legitimate it will raise some incredibly tough questions for the California Highway Patrol. This is why we need to know the identity of the officer in question. We need to be able to check his record to see if he has a history of this kind of behavior. His identity should be a matter of public record.'

A passing driver videotaped the incident showing the CHP trooper pinning her down and repeatedly punching her in the face.

The victim's family have hired Los Angeles attorney Caree Harper to represent them in the case against the California Highway Patrol.

Harper said her clients want the authorities held accountable for 'beating a great-grandmother in broad daylight.'

Mrs Pinnock has been named locally, but the lawyer declined to identify her or answer questions about what she was doing along the edge of one of the city's busiest freeways.

'We want the focus to be what he was doing to her, not what she was doing' prior to the confrontation, said Harper.

'She was getting beat like an animal. No one should ever be beat like that.'

Speaking on Saturday Mrs Pinnock's daughter Mayisha Allums told **KTLA**: 'He punched and pound and pound on her, the only thing she could do was block her face.'

As of Monday Mrs Pinnock was in an undisclosed hospital where she was undergoing a mental health evaluation.

The California Highway Patrol has vowed to carry out a thorough investigation - but authorities claimed the trooper in question simply stopped her for her own protection.

CHP Assistant Chief Chris O'Quinn said at a news conference that the woman was endangering herself and people in traffic, and the officer was forced to restrain her.

O'Quinn added that the woman had begun walking off the freeway but returned when the confrontation occurred.

Passing motorist David Diaz recorded the uniformed officer as he jabbed Mrs Pinnock at least 11 times in the head Tuesday.

'The most animalistic, most brutal way to subdue someone is to pound someone's head into the concrete with really big blows to the head,' Diaz told ABC7.

'There was no weapons - it's obviously excess force,' he continued.

'He starts really letting loose... He starts pounding down on her face really hard. He doesn't try to grab her hands first.

On Monday Los Angeles civil rights activists met with California Highway Patrol Asst. Commissioner Ramona Prieto to discuss the incident.

The Rev. William D. Smart Jr., head of the Los Angeles chapter of the Southern Christian Leadership Alliance, attended the meeting and he told The LA Times he is 'enraged' by the video.

He added: 'We're very angry. Our community is highly upset over this - that a black woman was being hit that way, treated that way. There's a rage in our community right now.'

A second meeting is scheduled for Tuesday. Lawyers and campaigners will make a string of demands of the CHP.

Most importantly, they will insist that the officer in question is names immediately, so checks can be made into his background.

They will also call for a quick and thorough investigation and a review and revamp of officer training with the aim of avoiding any similar, brutal incidents in future.

Professor Becomes First Black Woman to Get High Court Media Credential *Female-owned media company also a pioneer in facilitating Supreme Court coverage*

Gloria Browne-Marshall has made *the* boss move of boss moves, recently becoming the first black woman to get credentials to cover the U.S. Supreme Court. **What's The 411 Networks**, the company for which Browne-Marshall is a correspondent, is also the first black-owned company to receive such credentials.

Browne-Marshall is reporting on the oral arguments for cases **Kiobel v. Royal Dutch Petroleum** and **Mohamad v. Palestinian Authority**.

Both cases focus on corporate immunity issues, with the question of whether corporations should be held liable for acts of torture committed under their watch.

“My mission is to report on the U.S. Supreme Court in a manner that is accessible to the general public and of assistance to scholars at large,” says Gloria Browne-Marshall, author and associate professor of constitutional law at John Jay College. “I applaud What’s The 411 Networks for its willingness to cover the actions of the U.S. Supreme Court, as not enough attention is paid to the third branch of government. The general population knows the least about the workings of the U.S. Supreme Court; yet its rulings become the law of the land.”

Ruth J. Morrison, founder of **What’s the 411 Networks**, says she’s “delighted to have created a media company that facilitated this momentous occasion.”

“Decisions from the United States Supreme Court affect the lives of all citizens, immigrants, and in these particular cases, people and corporations beyond our borders. And, truth be told, the U.S. Supreme Court is the most powerful branch of government because all too often, its rulings stand without Congressional intervention,” she added

California police officer savagely beats great-grandmother

A California Highway Patrol (CHP) officer savagely beat an unarmed woman on a freeway onramp July 1 in Los Angeles, California. The assault was captured on video by an onlooker and shared widely on social media. The beating comes amidst a nationwide escalation in police brutality and a push by the state to militarize the domestic police force.

In the video, a CHP officer tackles a woman to the ground, forces himself on top of her, and begins punching her repeatedly. The woman tries to protect herself, but the officer begins to target her face directly, landing repeated full-blown punches to her head.

The shooter of the video footage, David Diaz, told *CBS News* that there were at least fifteen punches thrown by the officer, the majority of them hitting the woman's face while the officer sat on top of her. Diaz remarked that the officer, who he described as a strong and big man, could have easily killed the woman.

The woman, whose age and name have not yet been released, was identified by her family as a "great-grandmother." Though the extent of her injuries is unknown, she is currently in the hospital.

The CHP claimed that the officer had been dispatched after receiving a call about a woman who was on the interstate 10 freeway. According to Diaz, the woman had begun to get off the freeway before being tackled and beaten. Assistant Chief of the CHP, Chris O'Quinn, also acknowledged this fact. Diaz told the *Associated Press* in a phone interview that the woman was walking off the freeway when the officer began shouting at her. According to Diaz, the woman turned away from the officer and walked back onto the edge of the freeway. According to Diaz, the CHP officer "agitated the situation more than helped it."

"He grabs her and she kind of shuns him back - a very natural instinct. Of course he is stronger than her so he grabs her, throws her down." Diaz continued, "With every punch, it's bouncing her head off the concrete."

According to other eyewitness reports, the woman "looked terrified... she looked just gone." The same witness said the woman appeared to be barefoot and was carrying around several bags. Several news sites have suggested that she was homeless. In Los Angeles many homeless people live next to freeway onramps.

Attorney and family spokesman Caree Harper held a press conference outside of the hospital where the woman is receiving treatment. She said, "We want the focus to be what he was doing to her, not what she was doing." Harper continued, "She was getting beat like an animal. No one should ever be beat like that."

After the repeated punches to her face, an off-duty cop ran up to the scene. The officer then handcuffed the woman. Despite the extensive bashing of the woman's face, the CHP did not report any injuries whatsoever in their police report. The woman was then taken for a 72-hour mental examination under custody. O'Quinn told a press conference that he could not say why the officer responded in the way he did because it had not yet been evaluated. O'Quinn, however, defended the officer. He stated that the officer was more knowledgeable about freeway conditions than the "citizen." "The most dangerous thing we face is traffic," he said, suggesting that the officer was justified in brutalizing the woman for her own good. An investigation into the incident is underway.

This police beating comes amid an escalation of violence in the United States from police forces. In May an Atlanta SWAT team critically wounded a one-year-old toddler with a flash grenade. In the same month three police officers killed an unarmed man, who was backing away from them, in a migrant farm worker community in Salinas, California. In April a man was shot to death as he fled from police in Long Beach, California, again, unarmed.

Just this past week a police officer in Indiana was caught on video pushing a paraplegic man out of his wheelchair and onto concrete, claiming that the man had driven over his foot.

In January of this year the CHP was forced to pay \$250,000 in damages to a pregnant woman who was abused by several officers. The woman was pulled over for talking on her cell phone; the police said she was trying to resist arrest in 5-mile-per-hour rush hour traffic. Four or five officers forced her, violently, to the ground with guns drawn. She was then kicked and hogtied. All of the involved officers remain on the force.

Cop in Chokehold Arrest Death Stripped of Badge Amid Growing Outcry

There is growing outrage following the death of a man who had a heart attack and died in police custody after officers put him in a chokehold, a tactic prohibited by NYPD policy. Sheldon Dutes reports

Officials say an eight-year veteran of the NYPD has been stripped of his badge and gun because of his use of a chokehold while arresting a Staten Island man who later died in police custody.

Authorities said Saturday that Officer Daniel Pantaleo has been placed on modified assignment pending further investigation into the arrest of 43-year-old Eric Garner, which was captured on cellphone video showing the chokehold, a tactic prohibited by NYPD policy.

Officials said another officer involved in the arrest, a four-year veteran of the force who has not been identified, has been put on administrative duty but has not had to surrender his gun and shield.

On Sunday, the Office of the Chief Medical Examiner seemed to deny published reports hinting at preliminary autopsy results.

"At this time, no determination has been made by the Medical Examiner's office as to the cause and manner of death of Eric Garner," the office said in a statement. "The cause and manner of death are pending further studies, and no findings will be released until the investigation is complete.

Pastor and activist Reverend Herbert Daughtry was born January 13, 1931, in Savannah, Georgia to Emmie Cheatham Williams and Bishop Alonzo Austin Daughtry. When he was one year old, his family moved to Augusta, Georgia. His parents separated shortly after, and his mother returned to Savannah. Daughtry moved back and forth between Savannah and Augusta as a child. His father was heavily involved in the church and Daughtry was raised in a household dominated by this religious upbringing.

When Daughtry was around eleven years old, his family moved north to Brooklyn, New York, and shortly after to Jersey City, New Jersey. Daughtry had trouble adjusting to the interracial classes in Jersey City and returned to take classes in Brooklyn. As a black child from the South, Daughtry found himself a frequent target of derision from his peers, both black and white. In response, Daughtry became regularly disruptive in school, and eventually fell into a decade-long struggle with gambling, crime and drug use. In 1950, Daughtry, hoping to get clean, joined the army, but remained strung out on heroin and was discharged after only a year.

In 1953, Daughtry was imprisoned for armed robbery and assault charges. While in prison, he experienced a religious conversion that changed his life. When he was released, Daughtry returned to the church, becoming a fourth generation minister in his family.

In 1958, he became pastor of the House of the Lord Church in Brooklyn, and was named national presiding minister a year later, a post he has held ever since. In 1982, Daughtry founded the African People's Christian Organization, which sought to create an African Christian nation by highlighting both African origins and biblical teachings. Two years later, Daughtry became a special assistant to Reverend Jesse Jackson during his presidential campaign and accompanied him on his trip to the Vatican to advocate for a firmer stand on human rights. In 1991, Daughtry participated in Mayor David N. Dinkins' delegation to South Africa, and met with Nelson and Winnie Mandela. Reverend Daughtry has published several books. His 1997 book, *No Monopoly on Suffering: Blacks and Jews in Crown Heights and Elsewhere* dealt with the 1991 crisis in ethnic tensions in that neighborhood. He also published *A Seed Planted in Stone - The Life and Times of Tupac Shakur*, a book that follows his relationship with the slain rapper, who joined Daughtry's congregation when he was only eleven years old. In 2003, Daughtry led a delegation of multi-faith protesters to Iraq, in a last-ditch effort to preserve peace in that nation. Daughtry lives in Brooklyn, New York, with his wife Karen

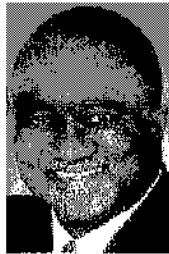
