Dear Ladies and Gentlemen:

Tribune Broadcasting Company (“Broadcaster”) provides SPRING CITY CABLE TV (“Operator”) with this notice pursuant to Section 325(b) of the Communications Act of 1934, as amended, and Section 76.64(f)(2) of the Rules and Regulations of the Federal Communications Commission. Broadcaster is the ultimate owner of the television stations identified in Attachment A hereto (each, a “Station”).

For the period January 1, 2015 through December 31, 2017, Broadcaster and each Station hereby elect RETRANSMISSION CONSENT with respect to each such Station’s digital signal on each of Operator’s multichannel video programming distribution systems (each, a “System”) in each such Station’s respective market, as identified in Attachment A, including, but not limited to those Systems identified in Attachment B. 


