This request for information and FOIA inquiry and Complaint is being filed against KSFG FM 104.1 In Springfield Missouri. **First of all I am invoking the 100 Page Free request pursuant to Freedom of Information Act (FOIA), 5 U.S.C. §552.** My request is based upon the following FOIA rule as I am a NON Commercial Requester, **non-commercial requesters are entitled to up to 100 pages of free copying and up to 2 hours of free search time.** I would also request any documentation on this FCC Licensed Station be provided under a Fee Waiver in that Citizen Participation in Listener Call In Programs that are disseminated and advertised as Public Participation should be governed by the Free Speech Dictates of the 1st and 14th Amendments of the US Constitution. The mandates of Missouri's Free Speech Laws as well apply : *Missouri Constitution* Article I BILL OF RIGHTS Section 8 August 28, 2004 **Freedom of speech--evidence of truth in defamation actions--province of jury.**

Section 8. That no law shall be passed impairing the freedom of speech, no matter by what means communicated: that every person **shall be free to say, write or publish, or otherwise communicate whatever he will on any subject**, being responsible for all abuses of that liberty; and that in all suits and prosecutions for libel or slander the truth thereof may be given in evidence; and in suits and prosecutions for libel the jury, under the direction of the court, shall determine the law and the facts.

First I would like to ask for information concerning **WHO KSFG's License is Issued To ?**

Second I would like to know **who is there registered agent who would receive Federal Court Process ?**

Third I would like to know **when the stations license is up for renewal and the Public Service Record of the Station is up for review ?**

Forth, I would also like to know of the existence of and ask for a copy of, what the formal Policy of the FCC is on Licensed Broadcasters that conduct Public Call In Programs, that engage in **BASELESS and UNWARRANTED Censorship Practices** as they concern the Free Speech Rights of the persons that call in to participate in Programs that are **FRAUDULENTLY promoted and Deceptively advertised as being PUBLIC PARTICIPATION ?**

Fifth, I would like to know IF the FCC condones, encourages or ignores **CENSORSHIP Practices and ABUSIVE and OPPRESSIVE screening of Citizens that call into Pubic Participation Call in Programs that are licensed to use the Public's Airwaves ?**

My issue with Mr. Vincent David Jericho and the Program Producers and Station Management of KSFG , or what would be more **formally a COMPLAINT** is directed at their **SECRETIVE** tactic of Cutting Off Participants, later **TOTALLY BARRING THEM** from participation, while **INSULTING** Callers and **Ridiculing**, and then **CUTTING OFF** individuals with views that are **Not In Accordance With the Stations Political and Moral Ideology.** This would be more formally known as **CONTENT BASED Discrimination and Censorship.** I feel the Citizens of the United States have a **PARAMOUNT** interest in the Freedom Of Speech Issues under States Constitutions as well as the Federal Constitution 1st and 14th amendment needing to fully understand the **Expression Freedoms Practices and Policies of the FCC as it relates to their OBLIGATIONS to promote the Public Policies and Laws of the United States.** Obviously censorship for **VILE or OBSCENE** language or promoting **RACIST or HATE Speech or Conduct** would have some weight and legitimacy **BUT** to engage in **BLATANT CENSORSHIP** is quite another story.
