In an effort to address important community issues of economy, education, health, political and others, WCRQ FM. offers the below as part of our regular formatted programming.

WCRQ FM airs "Happening in your community", an updated daily feature promoting local area community fundraisers, events and cancellations at 7:45am, 12:45pm and 4:45pm Monday through Friday and 7:45am and 12:45pm Saturday and Sunday.

Additionally, WCRQ FM airs free public service announcements for area non-profit organizations in excess of one hundred minutes per week, and often teams for live local broadcast of fundraising and awareness events.

WQDY/WALZ HELD OUR ANNUAL TURKEY A THON ON OCTOBER 8TH. WE ASK PEOPLE TO COME SPEND \$12 FOR A TURKEY. ALL MONEY DONATED IS USED TO BUY GIFT CARDS FROM LOCAL GROCERY STORES, AND THE GIFT CARDS ARE GIVEN TO WASHINGTON COUNTY FOOD PANTRIES TO MAKE SURE THEIR SHELVES ARE STOCKED FOR THE HOLIDAYS.

THE ANNUAL EVENT WAS PROMOTED THROUGH A SCHEDULE OF OVER 300 PROMOS ON OUR NETWORK OF STATIONS, REMINDING PEOPLE ABOUT THE TURKEY A THON AND GIVING THEM DIFFERENT OPTIONS TO MAKE A DONATION. ON OCTOBER 8TH WE AIRED A LIVE ALL DAY BROADCAST FROM A CALAIS BUSINESS FROM 7 AM UNTIL 5 PM. WE ALSO HAD PEOPLE STATIONED AT 6 OTHER LOCATIONS THOUGH OUT WASHINGTON COUNTY, COLLECTING DONATIONS FOR THE TURKEY A THON EVENT. AT THE END OF OUR 10 HOUR BROADCAST, WE HAD COLLECTED OVER \$39,000.00 FOR OUR LOCAL FOOD PANTRIES TO HELP LOCAL FAMILIES.

THIS EVENT HAS CONTINUED TO GROW OVER THE PAST 17 YEARS. WE HAVE VARIOUS SCHOOLS, CIVIC ORGANIZATIONS, AND BUSINESSES ALL HELPING BY RAISING MONEY OR VOLUNTEERING AT ONE OF OUR LOCATIONS.

CHIEF KEN CLARK OF CALAIS FIRE – EMS CAME INTO THE STATION TO RECORD A PUBLIC SERVICE ANNOUNCEMENT TO HELP THE COMMUNITY UNDERSTAND SMOKE DETECTORS. HE WANTED TO EXPLAIN THE DIFFERENT SOUNDS A SMOKE DETECTOR MAKES AND WHAT EACH ONE MEANS. WITH COLD WEATHER COMING SOON AND PEOPLE GETTING READY FOR WINTER, HE WANTED TO REMIND THEM IT IS THE PERFECT TIME TO CHANGE THE BATTERIES IN THEIR SMOKE DETECTORS OR EVEN THEIR ENTIRE UNIT IF IT IS AN OLDER ONE.
