The text to be used for the announcements accompanies this agreement. Scheduling announcement air times may be changed due to unforeseen circumstances and events beyond WONC's control. Any announcements not aired at their scheduled time will be rescheduled for another appropriate time and date.

It is agreed that credit for such underwriting shall be given by WONC in compliance with all applicable Federal Communications Commission rules and regulations including, but not limited to, Section 399B of the Communications Act of 1934 (as amended) and Section 73.503, Subpart C, Title 47 of the Code of Federal Regulations.

WONC certifies that its underwriting agreements do not discriminate on the basis of race or ethnicity and that all such agreements held by WONC contain nondiscrimination clauses. WONC does not discriminate in the sale of underwriting acknowledgements and will accept no underwriting which is placed with intent to discriminate on the basis of race, ethnicity, gender, or sexual orientation.
