The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC quidelines.

2 Description of and Field Strength at Monitor Points:

Direction 85° True North: Turn left upon leaving driveway of transmitter location and proceed east 2.5 miles to the intersection of county roads. Turn left and proceed north 0.3 mile to a red post on the right side of the road along a fence line. The monitor point is on the side of the road near the post. Distance from transmitter is 2.5 miles. The field strength measured at this point should not exceed 60.4 mV/m.

Direction 119° True North: Turn left upon leaving driveway of transmitter location and proceed east 1.5 miles to the intersection of county roads. Turn right and proceed south 0.8 mile to a red post on the right side of the road along a fence line. The monitor point is on the north side of a concrete culvert on the right side of the road. Distance from transmitter is 1.9 miles. The field strength measured at this point should not exceed 27.0 mV/m.

Direction 130° True North: Turn left upon leaving driveway of transmitter location and proceed east 1.5 miles to the intersection of county roads. Turn right and proceed south 1.5 miles to the intersection of county roads. Turn left and proceed east 0.3 mile to a red post at a fence corner on the right side of the road as the road turns to the right. The monitor point is in the middle of the road opposite the post. Distance from transmitter is 2.5 miles. The field strength measured at this point should not exceed 48.7 mV/m.

The Praise Network, Inc. requests waiver of 47. C.F.R.
