

## ABOUT DAN



**Dan Barrett, a long-time conservative activist as well as both a local and Republican leader, has filed to run for the open 13th Congressional House seat. The Republican primary is June 7. Early voting starts May 26.**

Dan serves as a Davie County Commissioner. He has governed as a conservative, including implementing “zero-based budgeting” and transitioning Davie County Hospital from the public to the private sector. Wake Forest Baptist Health is now investing over \$100 million to build a new hospital in Davie.

Dan also serves on the Davie County Hospital Board of Trustees, Davie Domestic Violence Task Force, and Davie Social Services Board. He has previously served on the Senior Services Committee and the Northwest Piedmont Council of Governments.

Dan is regarded as one of the leading employment attorneys in the state and has worked with businesses to make them run more efficiently. He will use his 30 years experience working with businesses to begin to ‘right size’ the bloated federal bureaucracy and make it more responsive to our citizens.

Dan has “worked in the trenches” for the NCGOP for many years, including service as Precinct Chairman and on the NCGOP Executive, Resolutions, Plan of Organization and Personnel committees. From 2007 until 2014, and again in 2016, he served as Chairman of the 5th Republican Congressional District, which includes parts of 4 of the 5 counties in the 13th. Under his leadership, the 5th District has supported Republican candidates at the local, state and federal level. In recognition of his service, Dan was elected to the NCGOP Hall of Fame in November of 2015.

Dan ran a grassroots campaign for governor in 2004 and captured public attention in his 582 mile walk across North Carolina to meet voters face to face. The Raleigh News and Observer described his campaign as, “He Walks Conservative Line.” In honor of his work on behalf of conservative grass roots causes, Dan was named State Co-Chair of Americans for Prosperity.

In announcing his campaign for Congress, Barrett stressed the importance of experienced and effective conservative representation in Congress. “Too often, people go to Washington and forget their constituents. My record demonstrates that I will stay true to core conservative beliefs. I will never forget that I represent the citizens of my district. I will listen to those I represent and work on their behalf. My focus will be to unify, rather than divide.”

Dan and his wife, Kathleen, live in Advance. They have two children, Daniel (23) and Rebekah (18).
