Pollack/Belz Communication Company, Inc. ("PBCCI"), the licensee of KLAX-TV, Alexandria, LA, FCC Facility ID 52907, hereby requests retransmission consent on DISH Network in the Alexandria, LA Designated Market Area ("DMA").

Section 338 of the Communications Act of 1934, adopted as part of the Satellite Home Viewer Improvement Act of 1999 ("SHVIA"), requires a satellite carrier to carry upon request all local broadcast television stations' signals in markets in which the satellite carrier provides at least one local television broadcast signal ("Local-into-Local Service"). Broadcast stations are required to elect retransmission consent by October 1, 2011, for the January 1, 2012 to December 31, 2014 carriage period.


