#### “HOLLYWOOD TARGET FOLO” – EAST HOLLYWOOD

Target planned to build a nearly 200,000-square-foot structure—with 163,000 square feet set aside for a Target store and the rest devoted to other retailers—that is, until a group known as the La Mirada Avenue Neighborhood Association filed a lawsuit saying the proposed building did not adhere to local planning guidelines. A judge agreed with the group (whose representatives may or may not live in the neighborhood) and snatched away Target's construction permits in August of last year—months into construction. Target and the city appealed, and the building has continued to sit silently in its depressing, embryonic state ever since. The Planning Department is hosting a meeting on Friday morning at City Hall (Room 1020, 10 a.m.) that could free the store from the lawsuit's clutches. The city is looking to amend planning guidelines for the area detailed in the Vermont/Western Transit Oriented District Specific Plan, which would allow taller buildings in the area. The hearing is a first step, then a report will be filed, then a recommendation, and the whole planning commission will weigh in.

#### - "SHERMAN OAKS FATAL HIT N RUN" –SHERMAN OAKS

A \$50,000 reward is being offered for information that leads to the suspect involved in a hit-and-run crash that killed a woman in Sherman Oaks early Sunday. Los Angeles Police Department officials said the collision happened on Moorpark Street and Matilija Avenue around 2:30 a.m. when the 19-year-old victim was crossing the street. The woman was crossing to get to her friend's house after coming home from a restaurant. The friend was ahead of her and was on the sidewalk when the victim was struck by what police describe as a maroon or red sedan with tinted windows. Police said the suspect returned to the scene after the crash, rolled the window down and looked at the body before fleeing. Officials said the victim was not using a crosswalk but said the suspect should have stayed at the scene." The issue here is that the person who was involved in the traffic collision did not stop to render aid, call 911," said Bill Bustos, an LAPD detective. "Unfortunately, that person chose to leave, becoming a felony crime." Officials said the reward is the city's response to the hit-and-runs in the area. The woman has been identified, but her name is not being released until her family is notified, according to the coroner's office.

Ben Carson slammed CNN's reporting into his past as a "bunch of lies" in a combative interview on Friday as new reporting surfaced that he fabricated part of his biography. "This is a bunch of lies, that is what it is," Carson said on CNN's "New Day" when Alisyn Camerota asked about the report by Scott Glover and Maeve Reston in which they spoke to people Carson grew up with. "This is a bunch of lies attempting to say I'm lying about my history, I think it's pathetic, and basically what the media does is they try to get you distracted." Later that day, Politico published a story that Carson fabricated his story of having been offered -- and having rejected-- a scholarship and admittance to the storied West Point military academy. Carson's campaign told Politico that Carson's claim he had been accepted was in fact false, saying while Carson was a top ROTC student and met with Gen. William Westmoreland, he didn't pursue admittance to West Point.

### “LAX MILITARY TESTS MISSILE LAUNCH” – LAX

The Pentagon has confirmed that a bright, mysterious object that coursed across the night skies in Southern California and beyond on Saturday night was a pre-planned missile test-fired from a U.S. Navy submarine. Navy Strategic Systems Programs conducted scheduled Trident II (D5) missile test flight at sea from USS Kentucky, an Ohio Class SSBN, in the Pacific Test Range off the coast of Southern California,” officials said in an emailed statement from the U.S. Department of Defense. “The tests were part of a scheduled, on-going system evaluation test,” it continued. The missile was not armed. The widespread sighting caused rampant speculation after hundreds of witnesses reported the unexplained moving light shortly after dusk.

#### “OBAMA HOLIDAY TRAVEL SECURITY”– LAX

There is no specific and credible evidence that a Paris-style terrorist attack is being planned for the United States this holiday weekend, President Obama said Wednesday after meeting with national security aides. "As we go into Thanksgiving weekend, I want the American people to know that we are taking every possible step to keep our homeland safe," Obama told reporters after his meeting, adding that U.S. military, intelligence, and law enforcement officials are "working overtime" this Thanksgiving. As officials bolster security at the nation's borders and airports, Obama urged Americans to go about their Thanksgiving activities as usual, but also to be "vigilant" about unusual activity. "If you see something suspicious, say something," Obama said. "That's always helpful."

The national security team briefed Obama "on our homeland security posture in the wake of the tragic attacks in Paris and as we enter the holiday season," the White House said in a statement.

On December 2, 2015 Rizwan Farook and Tashfeen Malik, a married couple, opened fire at a holiday party at the Inland Regional Center in San Bernardino. Fourteen people were killed and 22 injured, most of them county employees. Both attackers were killed in a gun battle with police. Farook, who was born in the U.S. and worked for the county, and Malik, a Pakistan national, had an arsenal of ammunition and pipe bombs in their Redlands home.

**- "SAN BERNARDINO NUTS AND BOLTS" – SAN BERNARDINO**

A mass shooting at the Inland Regional Center in San Bernardino that left 14 dead and 21 others injured was being investigated as an act of terrorism, the FBI announced Friday. Syed Farook is seen in a photo released by the California DMV on Dec. 3, 2015. "As of today, based on the information and the facts as we know them, we are now investigating these horrific acts as an act of terrorism," Dave Bowdich of the FBI said at a Friday morning news conference. Bowdich added that federal investigators have uncovered evidence that pointed to extensive planning ahead of the deadly attack. The declaration came two days after Syed Farook, 28, and Tashfeen Malik, 28, stormed into the center, spraying a room full of holiday partygoers with bullets. Fourteen victims were killed in the attack and 21 were injured. Farook and Malik, who were married, were killed in a police shootout later that day. When asked if the pair had communicated with anyone the FBI was watching, Bowdich confirmed that there were telephonic connections between at least one of the individuals and other subjects involved in the investigation. He declined to elaborate further. Earlier in the day, three U.S. officials told CNN that Mailk had declared her loyalty to the leader of ISIS on Facebook, posting it as the massacre occurred.

The suspected San Bernardino attackers left behind 12 pipe bombs and more than 2,000 rounds of ammunition at their home, police said Thursday, a day after the nation's deadliest gun massacre since Sandy Hook. Federal officials said the guns used by the couple suspected of the massacre that killed 14 people and wounded 21 at a social services center in the California city were purchased legally in the United States. The attackers had purchased their two handguns, but their two assault-style rifles were purchased by someone who is now under investigation, San Bernardino City Police Chief Jarrod Burguan told reporters. The shooters wore black tactical gear, but did not have ballistic vests, he added.

#### "SYED FAROOKS SISTER" – RIVERSIDE

As investigators sort through evidence picked up at the San Bernardino shooting suspects' Redlands home, family members say they are in disbelief. "I can never imagine my brother or my sister-in-law doing something like this. Especially because they were happily married, they had a beautiful 6-month-old daughter. It's just mind boggling why they would do something like this," suspected gunman Syed Rizwan Farook's sister Saira Khan told CBS News' David Begnaud in an exclusive interview. Saira and her husband Farhan Kahn share the heartache felt by their community and their country. They can't believe someone so close to them could do something so horrific. "There are people who can't fathom how a mother and father could drop their 6-month-old baby girl off and then go commit mass murder," Begnaud said. "Yeah, we can't either," Saira responded. "Does it make you angry?" Begnaud asked. "Of course it makes me angry," Saira said. "Absolutely. It makes us very upset and angry that how you can leave a 6-month-old daughter," Farhan added. "And he put us in this predicament," Saira said. U.S. officials tell CBS News that 28-year-old Farook started searching for a wife using an online dating website. He met Tashfeen Malik and they became engaged in 2013 after he traveled to Saudi Arabia during the annual pilgrimage known as the Hajj. Farook returned to Saudi Arabia in July 2014 to bring her to the U.S. She passed a Homeland Security counterterrorism screening as part of the vetting process, and officials tell CBS News Farook was not on any U.S. terror watch lists. Christian Nwadike was shocked when he learned the man accused of gunning down over a dozen people turned out to be the coworker he sat only feet from for five years. He said Farook was different after he returned from Saudi Arabia. "Do you believe that he was radicalized?" Begnaud asked him. "Yes, by the wife. I think he married a terrorist," Nwadike said. "He married a terrorist?" "Yes," Nwadike responded.

**“SAN BERNARDINO OBAMA AND FBI”– SAN BERNARDINO**

The San Bernardino terrorists communicated through “direct private messages” and there is “no evidence of posting on social media,” FBI Director James Comey said Wednesday. ### "LAUSD THREAT INVESTIGATION" – WEST LAKE

Los Angeles Unified School District students returned to their classes on Wednesday, one day after an emailed threat of violence that prompted an unprecedented district wide closure was deemed to be "not credible." Police had been expected to step up and increase patrols around LAUSD schools as the district's campuses reopened. At Colfax Avenue Elementary School in Valley Village, multiple patrol cars and law enforcement personnel were spotted on and around campus as school got underway, video from the scene showed. "Always a good idea," one father said when asked about the heightened security. "I'm comfortable with it ... I feel safe as a parent." The threat against the nation's second-largest school district was sent to a school board member Monday evening. The Los Angeles Police Department was notified that night about the "specific" threat, which involved explosive devices and firearms, LAPD Chief Charlie Beck said. Out of an abundance of caution, LAUSD Superintendent Ramon Cortines made the decision to close all schools for the day while plant managers and law enforcement personnel conducted thorough searches of all the district's campuses.

The Office of City Attorney Mike Feuer announced today he is taking two significant actions to address the nearly two-month old Aliso Canyon gas leak in Porter Ranch. First, Feuer is asking a court to issue a Temporary Restraining Order to enhance and hasten the relocation of families affected by the leak. His Office also is seeking to depose, under penalty of perjury, key Southern California Gas Company employees. "It's time Porter Ranch residents had direct and complete answers about all facets of this leak, including what caused it, how to stop it, and what will be done to assure it never happens again," said Feuer's Chief Deputy, James P. Clark. "They should also receive better, quicker, and completely adequate relocation assistance."
