ARTICLES OF ORGANIZATION

I hereby form a limited liability company under the provisions of Chapter 12 of Title 13.1 of the Code of Virginia (1950), as amended, and to that end set forth the following:


FIRST: The name of the limited liability company is WLGN, LLC.

SECOND: The initial registered agent of the limited liability company shall be Gentry Locke Rakes & Moore, LLP, a Virginia limited liability partnership, and the post office address of the initial registered office shall be at the law offices of the initial registered agent, 800 SunTrust Plaza, 10 Franklin Road, S.E., Post Office Box 40013, in the City of Roanoke, Virginia 24022-0013.
