WSJS PROGRAMS THAT ADDRESS COMMUNITY ISSUES

WSJS is a news-talk station that airs a variety of regular programs that deal with issues affecting our community and our listeners. The station airs no less than eight hours a day of programs that deal with issues of politics, economy, human relations, morality, and other general topics affecting the community. Following is the weekly lineup of issues oriented programs and a brief description of each:

Regular Programming Monday - Friday

1. America in the Morning: (Monday-Friday, 5:00 a.m. - 6:00 a.m.)
Nationally syndicated AM news program hosted by Jim Bohannon. Local news, traffic, and weather are infused into the program clock.
2. The Triad's First News: (Monday-Friday, 6:00 a.m. – 10:00 a.m.)
Locally-produced morning news and information show, focusing on local news, weather, and traffic, with interview segments throughout the show; hosted by J.R. Snider. The bulk of this daily program is news, weather, traffic and other information to help listeners get their day started. Program participants engage in conversation about the headlines of the day and accept listener reaction by way of phone calls. The hosts go in-depth with interviews and listener phone calls about issues that affect the Triad and the Triad's reaction to national and international news and events
3. The Herman Cain Show: (Monday-Friday, 10:00 a.m. – 12:00 p.m.)
Herman Cain uses his experiences as a successful businessman and as a former presidential candidate to connect the headlines to your bottom line in his daily nationally syndicated program.
4. WSJS News at Noon (Monday-Friday, 12:00 p.m. – 1:00 p.m.)
A live, local news hour that features the latest in local, regional, and national news. There are also tech, entertainment and financial features and interviews with local newsmakers.

5. The Dave Ramsey Show (Monday-Friday, 1:00 p.m. – 3:00 p.m.)
Nationally syndicated talk show. Dave Ramsey is a personal money management expert, who teaches others how to be financially responsible, so they can acquire enough wealth to take care of loved ones, live prosperously into old age, and give generously to others.
6. The WSJS Afternoon Show w/ Bob Campbell (Monday-Friday, 3:00 p.m. – 6:00 p.m.)
A live, local afternoon talk show that features the hot topics and issues of the day. The show is caller-driven as the host(s), offers their unique perspectives as well.
7. The WSJS Evening News: (Monday-Friday, 6:00 p.m. – 7:00 p.m.)
The WSJS Evening News is packed with a variety of information for our listeners. The highlights are news from the North Carolina News Network, Triad traffic, AccuWeather, sports reports, and other features like Garage Pass and Bill O'Reilly's Talking Points.
8. The Clark Howard Show (Monday-Friday, 7:00 p.m. – 10:00 p.m.)
A nationally syndicated program, hosted by Clark Howard, that features all consumer-based information. There are tips on how to save money, get the best deals, and ways to protect yourself from consumer fraud.
9. The Jim Bohannon Show (Monday-Friday, 10:00 p.m. – 1:00 a.m.)
A nationally syndicated talk show, hosted by Jim Bohannon, that is news and content driven by the stories of the day.
10. Overnight America: (Monday-Friday, 1:00 a.m. – 5:00 a.m.)
A Nationally syndicated overnight radio program covering the current events, news, and pop culture stories of the day. Hosted by Jon Grayson.
11. PRN Nascar Shows (Monday and Wednesday, 9:00 pm)
Fast Talk Live and the Pit Reporters highlight the week that was in NASCAR and previews the upcoming race. It also features guests from the world of stock car racing.
12. MRN NASCAR Show (Tuesday, 7:00 pm)

NASCAR Live is a live one-hour talk show hosted by Eli Gold that recaps the week in NASCAR as well as previewing the next week's race.

Saturday Regular Programming

13. The Yard Sale. (Saturdays, 6:00 a.m.-8:00 a.m.)
Hosts take calls from listeners, who are allowed to list items for sale on air, and on the WSJS Website, wsjs.com.

A locally-produced paid programming discussing personal financial wealth and investing.
15. Real Estate Radio (Saturday, 9:00 a.m.-10:00 a.m.)

Locally produced show, hosted by Erik Anderson
This program's purpose is to help our listeners complete their own "do it yourself" projects. Erik takes calls from listeners asking questions about various home improvement projects.
17. Freedom Financial (Saturday 11:00 a.m. – 12:00 p.m.)
Nationally-produced paid radio program discussing personal financial wealth and investing.
18. Play It Again Weekends (Saturday 1:00 p.m. – 7:00 p.m.)
WSJS plays a rotation of classic hits from the last few decades.
19. The Cigar Dave Show (Saturday, 7:00 p.m. – 9:00 p.m.)
A lifestyle program, hosted by Cigar Dave, on cigars, spirits, and a leisurely lifestyle.
20. The Wine Crush (Saturday, 9:00 p.m. – 10:00 p.m.)
A lifestyle program, hosted by Laura Lawson, about the popular wine industry.
21. State Government Radio (Saturday 10:00 p.m. – 12:00 a.m.)
News programs that cover North Carolina State Government, Education, Economic Development, and Local Government. Its goal is to give in depth

coverage of North Carolina politics. At 10:00, *Carolina Newsmakers*. Followed at 11:00 by *People in Politics*.

Sunday Regular Programming

22. Religious Programs (Sunday 5:00 a.m. – 12:00 p.m.)
Focus on the Family, Day One, Music and the Spoken World, Home Moravian Church, Centenary Methodist Church.
23. Focus on the Family (Sunday 8:00 a.m. – 9:00 a.m.)
A faith-based talk show about issues concerning families, hosted by Dr. Jim Daly.
24. Meet The Press (Sunday 12:00 p.m. – 1:00 p.m.)
The NBC political interview show which has been on the air for nearly 60 years.
25. Play It Again Weekends (Sunday, 12 a.m. – 5 a.m., 1:00 p.m. – 12:00 a.m.)
WSJS plays a rotation of classic hits from the last few decades.
