





# Townsquare Media, Texarkana Political Disclosure Statement

## 2018 Political Campaigns

- A. Townsquare Media operates five frequencies...**(1) 100,000 watt station on 102.5 FM and (1) 50,000 watt station on 106.3 FM and (1) 11,500 watt station on 95.9 FM and (1) 7,700 watt station on 93.3 FM and (1) 1,000 day/ 500 night watt station 790 AM.**
- B. All classes of time are detailed on the Townsquare Media Candidate In Window Political Rate Card that is attached.
- C. The Townsquare Media Political Rate Card is a Lowest "UNIT" card based on 60-seconds or 30-seconds.
- D. All rates are gross. Candidates earning the LUR (Lowest Unit Rate) and not represented by an agency will receive the net rate (85%).
- E. Only "legally qualified candidates" are allowed the LUR (Lowest Unit Rate). These candidates have publicly announced his or her intention to run for office, are qualified under applicable law to hold the office and have qualified for a place on the ballot or are actively running as a write-in candidate.
- F. The LUC applies during the political window: 45 days before a primary, and 60 days before the general election.
- G. A candidate "use" is a candidate appearance in the announcement by an identifiable voice. Only "positive" appearances by candidates are "uses".
- H. All political announcements must contain sponsorship identification. A list of the officers of any entity will be required for inclusion in the political file.
- I. News programs are not available for political ads.
- J. Program length commercials are not available to local or state candidates, issues or PAC Advertisers
- K. Local and state candidates, issues and PAC schedules are restricted to one per hour or no more that 3 per day part from 5am to 7pm Monday through Friday and limited to one per hour in all other hours on all other days.
- L. All political, PAC and issues schedules are payable cash in advance.
- M. All schedules and copy must be in the station 24 hours in advance of airing for Tuesday through Thursday schedules and by 12noon Friday for schedules on Saturday through Monday.
- N. Rates and information are available for packages that require specific schedules across multiple day parts and days.
