Here's a schedule of Newsmakers programs set to air on KOAM during the month of July:

Saturday, July 5 NMK-03-14 Tuskegee Airman

This program features an interview with a man who was a member of the Tuskegee Airmen during World War Two. He shares his experiences as one the first African American pilots trained to fly during the war.

Saturday, July 12 NMK-03-18 Joplin Parks & Recreation

This program features an interview with Joplin Parks & Recreation Director Jerry Calvin. He talks about the newly-completed work at the Ewert Aquatic Center and plans to continue renovations at other pools and parks.
