On Friday, September 5, 2008 KOAM & KFJX News Director Kristi Spencer & Promotion Manager Vance Lewis attended a Community Issues Forum at the invitation of the United Way of Southwest Missouri. This meeting of community leaders was the culmination of two years of research & investigation by a panel of local experts. The panel identified several issues, or problems, in the Newton & Jasper County, Missouri region of the market. Of the many issues identified the panel focused on the three (3) major problems facing the general population in the market: 1) Education. Helping Children, Youth & Adults Achieve Their potential. 2) Income. Promoting Financial Stability and Independence, & 3) Health & Safety. Improving people's health & safety. The panel also identified Measurement Areas for each of the issues & suggested the Indicators to let them know how the area was doing in addressing each of the issues. Each of the 3 Main issues were also mentioned by many viewers in the KOAM & KFJX Community Ascertainment on-line questionnaire filled out by viewers in the market. (See related entry). As part of the Forum people were urged to pick an area for a more in-depth discussion as part of a break-out session. News Director Spencer attended the Education group & Promotion Director Lewis attended the Health & Safety discussion. During the 3rd Quarter of 2008 KFJX & KOAM conducted a community ascertainment of important issues. Viewers were asked to share their thoughts, concerns & opinions about specific issues facing them or their families in the Joplin, MO/Pittsburg, KS television market. The Viewer Survey was conducted via the stations web sites. One Hundred Fifteen (115) surveys were returned to KFJX & 330 surveys were returned to KOAM. Of those, the top 3 issues were (1) The Economy, (2) Health Care, & a 3rd-place tie between the (3) Government & (3) Illegal Drug Use. A complete summary of the survey is attached to this report. On Monday, May 11, 2009 KOAM-TV & KFJX-TV donated 2 backpacks, 12 light-up pens, 3 caps, 6 mugs/cups, 6 coasters, 8 pens/stands, to be used in a charity event called "Holden's Hope." The website provides this information: On September 29, 2004, Holden James was born on his Great-Grandmother Janie's 75th birthday. Holden was greatly anticipated by his big sister Addisyn Frances as well as his mom and dad. He was a durable 10 lbs. 5 oz and 22 inches long (at 38 weeks gestation.) He arrived as an emergency c-section, after several hours of a failed induction of labor. He was absolutely perfect. Tons of blond hair, beautiful pink skin, his cleft in his chin, ten fingers, ten toes. Our first son was all we imagined. We began our lives as a family of four. Holden was a sweet, happy baby. Always smiling, laughing and watching his big sis play, even in tremendous ear pain. Holden had his first double ear infection at three months. Holden and he had his first set of tubes at 9 months of age. He also had his adenoids removed. His ear infections disappeared and we had less trips to the doctor. At 11 months Holden started attending daycare with big sister Addisyn. He was never healthy. Upper respiratory infections, colds, strep throat, runy noses and even pneumonia. In May 2006 Holden had his second set of tubes, adenoid growth removed and a frenectomy. Two weeks later he became a big brother to Gabriel Patrick. In June 2006 Holden fell and hit his head, he was rushed to the ER and we were told no damage was detected. His eyes began crossing shortly after. He had a CT scan and it showed no damage from the fall

and we were referred to a pediatric ophthalmologist. We also had concerns about Holden's back. He has a lump on his spine and a xray showed no mass or injury. We were referred to an orthopedic doctor at Childrens Mercy. He had also failed his hearing test following his surgery in May. On October 10th, Holden had an ortho appointment with Dr. Nigel Price. After an intense evaluation Dr. Price told us he thought Holden might have a condition called Mucopolysaccharidosis. Essentially Holden was lacking an enzyme that breaks down cells and they begin to store in organs, skin and tissue. On Oct. 13th it was confirmed through urinalysis that Holden did have MPS. On Oct. 16th we met with genetics and had a blood test. They determined Holden's liver and spleen were enlarged. Oct. 20th we were told Holden has MPS VI, Maroteaux-Lamy. The rarest form of MPS, only 1100 cases world wide. And the only type that does not affected the brain, the silver lining in Holden's diagnosis. There is no cure for MPS only treatments. A bone marrow transplant or Enzyme Replacement Therapy. On Dec. 1st Holden underwent a tonsillectomy, bronchoscopy, muscle eye surgery and a port-a-cath was placed. Holden received his first Enzyme Replacement Therapy of Naglayzme on Dec. 20, 2006. He will continue to have ERT, every week for the rest of his life or until a cure is found. Our goal with Holden's website and fundraiser is to spread awareness. We intend on getting children diagnosed earlier. Creating a support network for families affected by MPS. Raising money for research. Educating people about MPS and all the different types. We feel blessed that Holden is the rarest of rare and it is our purpose in life to help others. Children's Haven is a United Way Agency. Beth Claybrook is also a volunteer member of the Children's Haven Board of Directors. Many may be surprised to learn that Jasper County, MO has rates nearly double the state average for child abuse and neglect. In fact, while the rate is slowing in other parts of the state, it alarmingly continues to increase in Southwest Missouri. Children's Haven addresses this issue by providing free crisis care to any child, regardless of socio-economic categories or geographical boundaries, when parents are struggling with increased stress. Our vital role is as a safe haven for vulnerable children. As utilities are shut off, eviction notices posted, layoffs announced, Children's Haven is a safety net to our community. Station staff learned Children's Haven needs on a regular basis the following items: Pajamas, Underwear, Gas cards, Cereal, Diapers, Socks, Sippy cups, Trash bags, Stamps, & Pull-ups, And other items currently needed: New bed pillows, Tupperware with lids, Heavy-duty dust buster, Dining room chairs, Meat and fresh fruit, Twin bed mattress-cover protectors, Plastic pillow protectors, Weather/tornado radio, Vacuum sweeper, Small CD/radio players, & Cleaning supplies. Children's Haven is a safe, home-like environment for children to stay while their families seek the help they need to alleviate their family crisis. We care for infants through teens so all sizes and colors are needed to provide for these children. The stations currently air a public service announcement for Children's Haven titled "Give 'Em 5" which asks viewers to donate their time, talents or financial resources. 06/02/09 **48 HOURS MYSTERY - "Deep Secret"** - On June 21, 1977, eighteen-year-old Jeffrey Klee of Coral Springs, Florida, went out drinking with his best friend, David Cusanelli -- and never returned home. When police questioned Cusanelli, he told them that Jeff had dropped him off and then had headed home himself that night. Eventually investigators assumed that Jeff had run away. Thirty years passed. Then, in 2008, Klee's van was discovered in a Coral Springs canal which was being dredged for stolen vehicles. It contained Klee's skeletal remains and some personal possessions. Just two weeks prior to this discovery, Danna Holmes, a Coral Springs resident, told police that, in the year 2000, an inebriated man in a Coral Springs bar told her that he had accidentally killed his best friend. When she was shown a photo lineup to identify that man, she picked out David Cusanelli. Police interrogation of Cusanelli and his brother Carl eventually elicited the admission that David Cusanelli had gotten into a fight with Klee over Ginny Healy Spence, and that Klee had sustained an accidental injury to his head and died -- after which the Cusanellis pushed the van, containing Klee's body, into the canal. Because there is no evidence to suggest homicide, no charges were made against the Cusanellis. Also, according to 1977 Florida law, there was then a three year statute of limitations for manslaughter charges. The Klees cannot even sue in civil court for wrongful death -- the statute of limitations has also run out on that. The Florida legislature recently defeated a proposal to eliminate the statute of limitations in wrongful death cases. - 06/06/09 **48 HOURS MYSTERY: "Lady In The Harbor"** - A report on the September 2006 murder of aspiring actress Barbara Mullenix, whose body was discovered in the water at the Newport Harbor Yacht Club in California. She had been stabbed fifty-two times. An initial suspect was her ex-husband, Bruce Mullenix. Despite their divorce, Bruce had agreed to let Barbara and their 17-year-old daughter Rachael move into his small Huntington Beach apartment, a situation that worsened when Barbara would drink and become verbally abusive. But Bruce was soon ruled out as a suspect because he had been out of town on a business trip. Investigators' attention then turned to Rachael and her 21-year-old boyfriend, Ian Allen, who were nowhere to be found after the murder. When they were finally apprehended and questioned, Ian admitted to killing Barbara, and Rachael was also accused of the murder. Both Ian and Rachael were tried separately. Each was found guilty of first degree murder, and each was sentenced to 25 years to life. - 06/09/09 **48 HOURS MYSTERY: "The Preacher's Wife"** - In April 2006, Matt Baker, a pastor from Waco, Texas, returned home to find his wife Kari unconscious, with an empty bottle of Unisom and a suicide note beside her. Paramedics arrived within minutes, but it was too late. Based on the note, the empty bottle of sleeping pills, and the fact that Kari was described as still struggling with the loss of her daughter Kassidy seven years ago, police ruled it a suicide. In a county with no medical examiner, police described the case over the phone to a justice of the peace, who determined that no autopsy was needed. Kari's parents, Jim and Linda Dulin, had no choice but to believe Matt. However, Linda's sisters, Nancy, Kay, and Jennifer, and niece Lindsey believed otherwise. Dubbed "Charlie's Angels", they began their own investigation. After uncovering a possible motive, Linda hired Bill Johnston, a dogged former federal prosecutor, had her daughter's body exhumed and autopsied, and filed a wrongful death suit against Matt. Five months after Kari's death, the justice of the peace declared that her death was no longer classified as a suicide and police subsequently arrested and charged Matt with murder. Believing Matt would be tried in criminal court, Linda dropped her wrongful death suit. After six months, the district attorney still hadn't taken Matt's case to a grand jury -- a requirement under Texas law. Linda eventually refiled the wrongful death suit, shortly before attorney Guy James Gray filed a successful motion to dismiss Matt's criminal case, as a grand jury indictment had not been returned within 180 days. Matt Baker is no longer charged with any crime, though the district attorney continues to investigate and could refile criminal charges. There is no statute of limitations for murder. (C: Erin Moriarty - P: Lisa Freed, Gail Abbott Zimmerman) (OAD: 05/10/08). **Update for this rebroadcast:** On March 25, 2009, a grand jury indicted Baker for the murder of his wife, after a surprise witness -- Vanessa Bulls, a girlfriend of his -- came forward and testified. He will go on trial in September. **Graphic postscript:** Baker was released from jail on \$250,000 bond, pending trial. He's again living in Kerrville, Texas, with his parents and daughters.

- 06/13/09 **48 HOURS MYSTERY: "Did the Doctor Kill the Doctor?"** - a report on the October 1993 murder of Dr. Linda (Lin) Goudey in Stoneham, Massachusetts. At the time she was dating Dr. Timothy Stryker, who depending on whom you believe, is either a calculating murderer or an innocent man. Goudey and Stryker had been dating but friends believed they were ready to break up, even though they had planned to vacation together. Less than two weeks before the trip, witnesses say they heard the couple arguing; and it was the last night Goudey was seen alive. Four days after she was last seen at the hospital, Goudey was found face down, wrapped in a blanket in the back of her car, in a remote corner of the hospital parking lot. The medical examiner determined it was murder and Stryker became the number one suspect. Nothing police found at the scene pointed directly to Stryker, but it was what they didn't find at the scene that did: her tote bag, the jacket she was wearing and her briefcase were in Stryker's possession. Soon after, Stryker got himself an attorney and the investigation stalled. Goudey's family eventually filed a wrongful death suit. Finally, in 2006, after many delays, the suit finally went to a civil court trial where a jury believed Dr. Stryker killed Dr. Lin Goudey and ordered him to pay Lin's family \$15 million. Nobody was surprised that Stryker said he would appeal, but everyone was surprised when he and his lawyer announced they had found a brand new witness. After being questioned by the police, the witness, Craig Pizzano, admitted that Stryker had put him up to it. Stryker was arrested for perjury. This trial hasn't begun yet, but Goudey's family hopes that eventually Stryker will be charged with murder. (C: Richard Schlesinger - P: Deborah Grau) (OAD: 10/25/08). **Update for this rebroadcast:** On April 16, 2009, Timothy Stryker pleaded guilty to multiple counts of perjury and was sentenced to four years in prison. His wife Micael has filed for divorce. The homicide investigation continues. Stryker's medical license was immediately revoked after he pled guilty to perjury.
- 06/16/09 **48 HOURS MYSTERY: "Kidnapped: Shawn Hornbeck's Incredible Story"** - On October 6, 2002, eleven-year-old Shawn Hornbeck was kidnapped while riding his bicycle in his home town of Richwoods, Missouri. Over the course of the next four and a half years, he was held captive and sexually abused by his abductor, Michael Devlin. Threatened with death and the death of his parents, he took on the life Devlin dictated, posing as his son and even making friends with neighbors. Devlin wielded such terror that Shawn never revealed his real identity to anyone, despite numerous opportunities to ask for help. Then, in January 2007, Devlin abducted another youth, Ben Ownby. With the help of a witness to that abduction, the FBI was able to trace Devlin's car and confront him. When they went to Devlin's apartment, they found both Ben Ownby and Shawn Hornbeck. At his hearing, Devlin pleaded guilty. He was sentenced on multiple counts to 72 life terms and an additional 170 years in prison. Among those interviewed are: Shawn Hornbeck; his parents, Pam and Craig Akers; FBI agent Lynn Willett; and Dr. Marylene Cloitre, New York University psychologist and trauma specialist. 06/20/09 **48 HOURS MYSTERY: "Into Thin Air"** - a report on the disappearance of Jeanette Louise Zapata, who mysteriously vanished without a trace from her home in Madison, Wisconsin on October 11, 1976 -- leaving behind her daughter Linda, and two other children. In the midst of a divorce at the time of her disappearance, she had been married for seventeen years to an engineer, Eugene Zapata. Their marriage had been troubled -- Jeanette discovered that Eugene had sent nude photographs of her to a swingers magazine and oftentimes his behavior towards her around their children was sexual and provocative. Due to his stalking-like behavior, she also had a restraining order against Zapata. Though Officer Greg Martin found Zapata's behavior strange, the results of his lie detector test were inconclusive. With no physical evidence, the case stalled. Eugene Zapata moved back into the house he had once occupied with Jeanette and acted as though nothing had happened. He explained to the children that Jeanette had simply taken off because she was stressed. In November 2004, Jeanette's best friend, Peggy Weekly -- who never believed that Jeanette would abandon her three children -- contacted police in Madison to reopen the case. Assigned to the case was Detective Marianne Flynn Statz, who after a preliminary investigation, was convinced that Jeanette had been killed and that the right suspect was Eugene. She contacted Linda Zapata, who expressed her own doubts regarding her father's innocence and agreed to help police with their case. After a thorough investigation, Eugene Zapata was arrested for the murder of Jeanette. His trial began in September 2007, but ended in a hung jury. Prosecutor Bob Kaiser was ready to go back to court and try Zapata again, when Zapata surprised everyone and agreed to answer questions regarding Jeanette's disappearance, but only if prosecutors would reduce the charge from murder to reckless homicide. His daughter Linda agreed. According to Eugene, he had argued with Jeanette the morning of October 11, 1976 and when her back was turned, hit her on the head with a paperweight and then strangled her twice. Then he began a grisly thirty year odyssey with her body: burying it, exhuming it, reburying it, and eventually he cut her body into pieces and took it to a land fill. Eugene Zapata was sentenced to five years for reckless homicide. Linda Zapata has been cut off from her immediate family: despite Eugene's plea, her brother and sister no longer speak to her. 06/23/09 **48 HOURS MYSTERY: "Picture Perfect"** - On June 9, 2008, 30-year-old Travis Alexander, a successful businessman and devout Mormon, was found murdered in his Mesa, Arizona home. He had been shot and then repeatedly stabbed. For a little more than a year, he had been involved with Jodi Arias, an aspiring photographer whom he had met at a business conference. She adopted his Mormon beliefs, which forbid premarital sex -- but they did become sexually involved. Although they supposedly ended their relationship when Jodi found out that Travis was interested in some other girls, Jodi then moved to Mesa. Police investigation of the murder scene recovered a digital camera with electronically dated, sexually explicit photos Travis and Jodi had taken of themselves -- and photos of Travis during the time he was being killed or soon after. When confronted by police, Jodi claimed that two masked intruders had broken in to Travis' home and murderously assaulted him -- but that she was able to escape. She did not call anyone for help, and told no one of the assault. Five days later, Travis was found dead by his roommates. Further police investigation resulted in the arrest of Jodi Arias on charges of first-degree murder. Her trial will take place sometime in 2010. Includes interviews with Jodi Arias; Chris and Sky Hughes, friends of Travis Alexander; Samantha and Steve Alexander, Travis' sister and brother; Travis' friends Taylor Searle, Brint Hiatt, and Aaron Mortenson; Esteban Flores, detective, Mesa Police Department. - 06/27/09 **48 HOURS MYSTERY: "An Invisible Enemy"** - a follow-up to "An Invisible Enemy" (OAD: 12/08/07). In January 2007, Cynthia Sommer was convicted of murdering her Marine Sgt. husband Todd in February 2002 with a lethal dose of arsenic. But ten months after her conviction, she was granted a new trial because of questions about the validity of the lab tests that found arsenic in some of Todd Sommer's tissue samples but not in others. His tissue samples were now sent to another lab to be tested for arsenic -- and none was found. Because of this, the prosecution concluded that there was a reasonable doubt; murder charges against Cynthia Sommer were dropped, and the case was dismissed. However, Todd Sommer's death is still officially listed as a homicide, and the court left open the possibility that Cynthia Sommer could be charged again. Duross O'Bryan; Matthew Miller of Forbes Magazine; Bill Werde of Billboard magazine, who compares Jackson to Elvis Presley; (5) Tim Kash (MTV News) reports how Michael Jackson influenced a new generation of musicians who grew up long after his rise to superstardom - from Chris Brown to Beyonce to Ne-You, to Usher to Justin Timberlake. Madonna, Britney Spears and Janet Jackson have all danced on video with synchronized dancers, but Jackson did it first: he turned the music video from a promotional tool to an art form. Includes interviews with musicians Usher, Justin Timberlake, J.C. Chasez, Patrick Stimp, David Cook. (6) Correspondent/Anchor Katie Couric concludes with Michael Jackson's legacy - how his music defined the era from 1969, on through the decades of his superstardom, to 1993 -- when his life began to unravel.
