**48 HOURS: “Who Shot the Tech Exec?”** – a report on the robbery, kidnapping and murder of Tushar Atre, a successful tech-executive-turned-cannabis-entrepreneur in Santa Cruz, CA. Atre had a home in Pleasure Point, an affluent surfing community, and the Summit property: 60 acres in the Santa Cruz mountains where he could legally grow cannabis for research. Grainy surveillance video from October 1<sup>st</sup>, 2019 captured what happened on Atre’s street, from the moment figures entered the neighborhood and walked toward his house, to minutes later, when Atre is seen running and then tackled; he is repeatedly stabbed and eventually pushed into a BMW that the suspects stole from his driveway. Houseguests called 911 and later told detectives they heard the intruders demanding to know the location and combination of Atre’s safe. Six hours after the abduction, police located the white BMW and Atre’s body. Investigators learned of disgruntled employees, due to Atre’s confrontational management style, as well as his habit of withholding people’s pay. On May 19<sup>th</sup>, 2020, the Santa Cruz Sheriff’s office had four suspects in custody: 23-year-old Joshua Camps, 22-year-old Kurtis Charters, 22-year-old Stephen Lindsay, and 19-year-old Kaleb Charters. The latter two had worked for Atre and, when initially interviewed by detectives two months after the murder, admitted they once had a bitter pay dispute with him. Cell phone data bolstered the investigation and except for Lindsay, all of the suspects eventually admitted their involvement. Jamie and his wife, Jennifer, set out from their Oak Cliff neighborhood in Dallas, TX for an early morning dog walk on October 9<sup>th</sup>, 2020. Moments after they left home, Jamie was shot dead; Jennifer was unharmed. The murder stunned their friends and neighbors and the community rallied around Jennifer, raising more than \$60,000 in a GoFundMe account to help her and her daughter make up for Jamie’s lost income; they also provided meals for the grieving family. Investigators learned that starting in April 2020, Jennifer had been in constant contact with a man she dated in high school, Darrin Lopez. Darrin drove the same make and model as the gunman’s getaway truck in Jamie’s murder; text messages between Darrin and Jennifer, cell phone data and GPS coordinates further linked him to the crime. Darrin was arrested on January 11<sup>th</sup>, 2021, in Dickson, TN and charged with a federal gun crime and, at the state level, charged with murder; he pleaded not guilty to both charges. On February 24<sup>th</sup>, Jennifer was arrested on obstruction of justice charges. Along with other evidence, prosecutors discovered an email account in Jamie’s name, in which Jennifer pretended to be Jamie, in order to taunt Darrin. In September 2021, Jennifer was charged with murder-for-hire. On February 7<sup>th</sup>, 2022, Jennifer appeared in a Dallas courtroom and pleaded guilty to one count of use of interstate commerce in the commission of murder-for-hire. In exchange for the guilty plea, prosecutors agreed to take the death penalty off the table and recommended a life sentence. **On-screen text graphic:** Jennifer Faith is scheduled to be sentenced on May 26. The investigation uncovered a troubled marriage, suggestions of a pending split, and declining finances. Eighteen months after Leslie’s death, her husband was charged with her murder. The defense maintained the Neulander’s had a loving marriage and Leslie had died from injuries sustained in the shower fall. Prosecutors say it was murder and the doctor covered up the crime. The science of blood spatter and the 911 call for help became focal points in the trial. Jenna testified in her father’s defense, but Robert Neulander was found guilty. The Rudolfs were getting ready to head back home after a safari vacation in Zambia in October 2016 when Bianca suffered a fatal gunshot wound to the chest. The couple were experienced hunters. Larry, a successful dentist with several offices near Pittsburgh, PA, told local authorities that he was in the bathroom of the couple’s two-room cabin when he heard a shot and found his wife dead in the next room. Larry said his wife was packing up a shotgun in a soft-shell gun case; he first told a local hunting scout that his wife had died by suicide, but later told investigators that the gun must have accidentally fired. After two days of investigating, Zambian police closed the case, calling it an accident. There were questions early on about how Bianca could have accidentally shot herself in the chest with such a long-barreled weapon. Larry had his wife’s body quickly cremated in Zambia, which led a friend of Bianca’s to doubt this was an accident. Soon after Bianca’s death, the friend called the FBI. According to an FBI complaint, she also said Larry was having an affair with Lori Milliron, who managed the dental offices, and that Larry had been verbally abusive to Bianca; the friend also told the FBI that the couple fought over money. It took investigators five years to investigate the case. In December 2021, Larry was arrested for the murder of his wife; he maintains his innocence. Lori was arrested in February 2022 and faces seven federal counts. **On-screen text graphic:** The joint trial of Lawrence Rudolph and Lori Milliron is scheduled to begin in July. **48 HOURS: “The Dexter Killer”** – a reedited and updated rebroadcast of 48 HOURS MYSTERY: “Screenplay for Murder” (OAD: 02/11/12; Rebroadcast: 07/10/12), a report on Canadian filmmaker Mark Twitchell, whose obsession with the *Showtime* television series “Dexter” turned to reality and led to murder. His film, “House of Cards”, was about a male serial killer who created a fake online profile as a woman, lured men from a dating website to his garage -- and then killed them. Police became interested in Twitchell when they were investigating a missing persons case, 38-year-old computer enthusiast John Altinger, and were led to the garage where he had just wrapped shooting his movie. A Facebook page where he compared himself to the serial killer “Dexter” and the discovery of a secret journal, which was essentially a blueprint for murder, allowed Edmonton police to eventually link Twitchell to the 2008 murder of Altinger and to the attempted murder of 33-year old Gilles Tetreault -- both of whom had answered an online dating ad. In March 2011, Twitchell went on trial for the murder of Johnny Altinger; he was sentenced to 25 years to life. **UPDATE:** Twitchell began correspondence with journalist Steve Lillebuen before he was convicted in 2011. Lillebuen wrote a book on the case; he sold the rights to a film company. In 2023, Twitchell will be eligible to apply for early parole. Tetreault, who escaped from him nearly 14 years ago, is worried that Twitchell could come after him. Records revealed Barry’s cell phone pinging all around the Morphew home on Mother’s Day weekend 2020, which he maintained was because he was chasing and shooting at chipmunks. Also discovered in the couple’s dryer was a plastic cap to a syringe used to load a tranquilizer dart; no working tranquilizer rifle was found in the home, but Barry admitted to being an experienced tranquilizer dart gun shooter. Tests revealed the cap had Suzanne’s DNA on it, not Barry’s. Investigators also uncovered DNA on the glovebox of Suzanne’s Range Rover, which traced back to an unknown male connected to three sexual assaults. Even though Suzanne’s body was never found, police relied on the circumstantial evidence they gathered, Barry’s suspicious behavior and contradictory statements, scratches seen on his left arm when Suzanne disappeared, the vehicle forensics evidence and Suzanne’s disturbing texts, and arrested Barry in May 2021 for first-degree murder and other charges; Barry pled not guilty. In September 2021, a judge ruled there was probable cause to go to trial. Suzanne and Barry’s daughters – Mallory and Macy – stand firmly behind their father. **04/30/22 UPDATE:** Judge Ramsey Lama replaced Judge Patrick Murphy. Barry Morphew’s homicide trial was set to begin on April 28<sup>th</sup>, 2022. In April 2022, Judge Lama ruled that prosecutors repeatedly had missed deadlines and had failed to turn over important information in the discovery phase. On April 19<sup>th</sup>, 2022, as a pre-trial hearing was about to begin, District Attorney Linda Stanley filed a motion to dismiss the murder charges against Barry Morphew without prejudice, meaning the case could be refiled at a later date. In her motion for dismissal, DA Stanley told the judge that officials believe investigators are close to discovering the location of Suzanne Morphew’s body. Defense attorney Iris Eytan denies Barry has any involvement in his wife’s disappearance. **48 HOURS: “Chasing Catherine Shelton: Part 1”** (10:00 – 11:00p) – For nearly three decades, controversial Harris County, TX attorney Catherine Mehaffey Shelton, now disbarred, has been dogged by mysterious circumstances surrounding the deaths of various men in her life. Never charged with murder, she has been called a murderer, a stalker, a crazy lawyer and more. In 2003, Jenna Jackson produced an edition of 48 HOURS MYSTERY which mainly focused on one of the murder cases linked to Shelton; Jackson has been tracking Shelton ever since. Shelton’s life, as well as her proximity to dead or injured men, has perplexed investigators for decades. Starting in the 1970s, one of Shelton’s former boyfriends, Dr. George Tedesco, was bludgeoned to death and ex-boyfriend Ferris Bond’s apartment was allegedly set on fire. In January 1980, Shelton shot ex-boyfriend Gary Taylor in the back; she admitted to that but claimed self-defense. Tommy Bell, named with Shelton in a lawsuit was found with a bullet in his head; authorities said he was playing Russian roulette by himself. In the years to come, Shelton’s conviction for shooting Taylor was set aside, but she was linked to three more deaths: a young man discovered dead and naked in one of her homes; another man shot dead in his driveway; and another man who died while he was staying with her. Shelton maintains she had nothing to do with any of these incidents. For this broadcast, Jackson and her team reinvestigate many of the allegations against Shelton. In January 1980, Shelton shot ex-boyfriend Gary Taylor in the back; she admitted to that but claimed self-defense. Tommy Bell, named with Shelton in a lawsuit, was found with a bullet in his head; authorities said he was playing Russian roulette by himself. In the years to come, Shelton’s conviction for shooting Taylor was set aside, but she was linked to three more deaths: Chris Hansen, a young man discovered dead and naked in one of her homes; Michael Hierro, shot dead in his driveway; and Sam Shelton - no relation to Catherine, who died in 2017 while he was staying with her. Catherine signed his name on a lease application and has been charged with a felony: fraudulent use of identifying information. Shelton maintains she had nothing to do with any of these incidents. The Disappearance of Jennifer Dulos"** (9:00 – 10:00p) - a report on the disappearance of a Connecticut woman and the possible involvement of her estranged husband and his girlfriend. On May 24<sup>th</sup> 2019, Jennifer Dulos dropped her children off at their New Canaan, CT school, but could not be located afterwards. Declared a missing person, police quickly located her SUV at a park near her home. Inside, they found blood that looked as if someone had tried to clean it up. Investigations focused on Jennifer's estranged husband, Fotis Dulos, with whom she was in a bitter divorce and custody battle with. Police obtained data from his cell phone, then located security camera footage for the various locations he visited the day of Jennifer's disappearance. The footage showed Fotis driving around with his girlfriend, Michelle Troconis, dumping trash bags around Hartford, CT. The bags were recovered and contained items including zip ties, ponchos and women's clothing, all covered in traces of Jennifer's DNA. On June 1<sup>st</sup>, Fotis and Michelle were arrested, but without a body, police could only charge them for tampering with or fabricating physical evidence and first-degree hindering prosecution. After being released on bail, Michelle cooperated with police investigations and eventually admitted that Fotis had not been with her the morning of Jennifer's disappearance, as he had previously stated. On January 7<sup>th</sup>, 2020, Michelle and Fotis were arrested for conspiracy to commit murder. Police eventually identified a pickup truck belonging to one of Fotis' workmen that was spotted travelling from his home to New Canaan the morning of May 24<sup>th</sup>. A search of the truck turned up a bloodstain on the seat, which matched Jennifer's DNA. When Fotis did not turn up for a court date later that month, emergency responders were dispatched to his home where they found him unconscious from a suicide attempt. He died two days later. The state of Connecticut is moving forward with Michelle's trial. The broadcast also includes footage from a 2019 visit to Fotis' home around Christmas, with him and his family, just 10 days before he was arrested for murder, and an interview with his attorney, Norm Pattis, on the day his client died. **On-screen text graphic:** The children are being raised by Jennifer's mother in New York City. **48 HOURS: "Please Don't Tell"** (10:00 – 11:00p) – a report on the case against Vincent Simmons, who was released from a Louisiana prison earlier this year after serving 44 years. In 1977, Simmons was convicted of two counts of attempted aggravated rape of identical 14-year-old twins, Karen and Sharon Sanders, who lived with their grandparents in Marksville, LA. Simmons was sentenced to 100 years in prison. The Sanders sisters say their cousin, Keith Laborde, was driving them when he gave Simmons a ride. They claim Simmons directed Laborde to a desolate area of Little California Road and then forced him into the trunk; he then raped them. The Sanders sisters also say Simmons warned them not to tell anyone about what had happened and they initially intended to keep it a secret, but Karen Sanders decided to confide in a family member. The police soon found out and Simmons was arrested, convicted and sentenced to prison. The sisters don't doubt that they picked the right man out of the lineup. Simmons' attorney, Justin Bonus, believes the twins are lying to protect Keith Laborde. Laborde's cousin, Dana Brouillette, told a private investigator and swore in an affidavit in 2020 that Laborde admitted to her that Simmons was never with them that night. Instead, she said in the affidavit that Laborde told her "he had consensual sex with one of the girls and locked the other in the trunk." Laborde denied ever having sex with them. This year, Simmons was released after a judge vacated his conviction after finding he didn't get a fair trial. The court did not rule on his innocence or guilt, and the district attorney declined to retry him. **On-screen text graphic:** Vincent Simmons intends to go back to court to seek compensation for wrongful imprisonment. Under Louisiana State law, if he is unable to present clear and convincing evidence of his innocence, he is entitled to nothing. **48 HOURS: "Death by Text"** - an updated rebroadcast on the death of Conrad Roy III and the case against Michelle Carter, who is scheduled to be released from jail next week. Prosecutors say she influenced Roy, via text messages, to kill himself. On July 12, 2014, Conrad Roy died of carbon monoxide poisoning after sitting in his truck with a gas-powered water pump running in the backseat. Prosecutors say Roy was driven to kill himself through hundreds of incessant messages from Carter, who was more than 30 minutes away at the time he died. Carter was later charged with involuntary manslaughter. Her defense team maintains Roy decided to kill himself on his own. As seen through his own videos, Conrad Roy talked about his own struggles with social anxiety, depression and thoughts of suicide. His mother Lynn Roy also talks about the death of her son and the pain she lives with. Though they lived an hour apart in Massachusetts, the couple communicated almost exclusively via texts, online and by phone. The prosecution maintained Carter could have done something to stop Roy. The heart of the case is the question of whether Carter's texts and messages pushed Roy to take his life, or would he have done it anyway. Prosecutors argued Carter played on Roy's mental health and her actions were reckless; she knew what she was doing and just wanted attention. The defense maintains Carter had her own psychological problems and was involuntarily intoxicated by the antidepressant drug Celexa: she was enmeshed in the delusion that it was a good thing to help him die. The prosecution hoped the judge paid attention to the text Carter sent to her friend a week after his death, in which she admitted she could possibly go to jail. After three days of deliberation, the judge rendered his verdict, completely rejecting Carter's defense and finding her guilty. At sentencing, Michelle Carter could receive twenty years behind bars. The Roy family knows words have power, and they can forever change lives. UPDATE for the 08/05/17 updated rebroadcast: Nearly seven weeks after being convicted, Michelle Carter, arrives for sentencing. The prosecution asked that Carter serve 7-12 years in prison. Her attorney requests probation. Judge Lawrence Moniz sentences Michelle Carter to fifteen months behind bars – a sentence that does not please the defense, who will appeal the conviction. Her attorneys request to stay the jail sentence. The judge grants the stay, meaning Michelle will be out on probation until the appeal makes its way through the Massachusetts court system. Neither Michelle nor her family, have reached out to the Roy family. UPDATE for the 01/18/20 updated rebroadcast: In February of 2019, Michelle Carter's conviction was upheld and she began serving her 15-month sentence. Her lawyers appealed to the U.S. Supreme Court. This week, the court declined to hear her appeal. Lynn Roy's focus now is on changing laws. In 2016, Robert Kennedy, Jr., Michael Skakel’s cousin, released “Framed: Why Michael Skakel Spent Over a Decade in Prison for a Murder He Didn’t Commit”, which repeated Skakel classmate Tony Bryant’s 2003 allegations that his friends Burton Tinsley and Al Hasbrouck murdered Martha Moxley. In 2018, the Connecticut Supreme Court vacated his murder conviction and ordered a new trial. But in 2020, prosecutors said they would not retry him. They knew each other for just 13 days before they got married; she was 24-years-old and he was 54-years-old, a widower and father to Eva Benefield. Over the four years they were married, there were strained relationships, allegations of abuse and poisoning, and a failed ballet studio for unconventional dancers in Charleston. At the time of the shooting, Ashley Benefield was living in a home in Florida owned by her mother. The couple had separated, but then reunited. Investigators found no evidence that Ashley was acting in self-defense; no weapons were near Doug’s body and Ashley only had an old and very minor scratch on her body. However, the night of the shooting, Alicia told police they lived in fear of Doug and claimed they sought help, but nobody would help them. Faith Brown, Ashley’s attorney, told police that Ashley created an escape plan to get away from Doug once and for all. In November 2020, Ashley was charged with second-degree murder. She has never given any kind of a statement to law enforcement. Alicia has custody of her granddaughter. Original on-screen text graphic: Ashley remains free on bond. **48 HOURS: "The Killing of Cowboy Ray Green"** – a report on the death of horse and competitive cowboy action shooting enthusiast Ray Green by his wife and questions regarding her claim of self-defense. On May 28<sup>th</sup>, 2014 police conducted a wellness check at the home of Ray and Danielle "Dani" Green, in Dillsboro, IN. The sheriff's department was contacted by Ray's mother Betty, after she received a call from Dani, who claimed Ray was killed by a German Shepherd dog. Dani told sheriffs Ray had left for work as a trucker, even though his rig was on the property. She permitted a search, except for a large padlocked toolbox that attracted flies and "smelled of decay". After obtaining a search warrant, Detectives Tom Baxter and Pete Tressler found Ray's body in the toolbox. Dani changed her story and claimed she killed Ray in self-defense after years of domestic abuse. She participated in a recorded reenactment of the events surrounding Ray's death for detectives and claimed after she exited the bathroom in the early morning hours of May 26<sup>th</sup>, Ray stated he would kill her and reached for a gun. They struggled and both fell on the bed; Dani accidentally shot Ray in the chest. Still scared, Dani left the room to reload and returned, then shot Ray in the head. Ray's death was ruled a homicide and Dani was arrested. Investigators searched Dani's computer and discovered her search history, along with flirtatious correspondence between Dani and George Mann, a mutual friend from when Ray and Dani lived in Palm Beach County, FL. Investigators believed Dani intended to murder Ray so she could begin a new life elsewhere. Dani went on trial in August 2015; her attorney, Delmar Weldon, claimed self-defense and included a deposition from "Carol", who claimed to have witnessed injuries, as well as angry outbursts from Ray. After eight hours of deliberation, Dani was convicted of murder and sentenced to 60 years in prison. **On-screen text graphic:** An appeal by Dani has been denied. **48 HOURS: "A Sister's Fight for her Brother"** (10:03 – 11:03p) - a report on Lauren Pettit's continuing support of her brother, Brandon Pettit, following his arrest, trial and conviction for the murder of their parents. At 3AM on August 8<sup>th</sup>, 2013, a fire in the Modesto, CA home of Scott and Janet Pettit engulfed their bedroom. Investigators soon discovered that the couple had been shot seven times and the fire was set to cover up their murder. Police's attention soon turned to Brandon, Scott and Janet's son. A week after their deaths and following two interrogations, he was arrested. While Brandon had an alibi for the time of the murder, police believed he paid a friend, Felix Valverde, to commit the act. A search of Felix's home produced Scott and Janet's wallets, a case of ammunition, and seven spent shell casings hidden in a planter. Brandon confessed to giving Felix \$100 in the days after his parents' death, but maintained it was to help him with bills. Brandon and Felix were set to stand trial together. However in August 2020, Felix was declared incompetent to stand trial. Brandon's trial began September 1<sup>st</sup>, 2020. Prosecutors built a case around financial motive, saying that Brandon had given Felix the keys to Scott and Janet's home so that he could commit the murder and Brandon could receive an inheritance. Pettit family friend Mike Anderson testified that Brandon tried to sell Scott's classic Corvette soon after his death. High school friend Sarah Wilson detailed her communications with Brandon, who had promised his parents would buy a \$1 million house for the two of them in Georgia. The jury also heard from Susan Sanchez, Brandon's ex-girlfriend and mother of their daughter, who testified Brandon told her he wanted his parents dead and that Felix could make her ex-husband "disappear" in exchange for money. Brandon's sister Lauren testified in his defense. She countered the financial motive and that the Corvette was already in Brandon's name. Robert Winston, Brandon's defense attorney, brought up that the Pettit home had electronic locks and suggested Felix likely ended up with keys after he took their wallets, where spares were kept. Additionally, they brought up the large dog door at the rear of the home, which was large enough to allow an adult to enter. Finally, Winston questioned the police's interrogation of Brandon. A clinical psychologist testified that because of Brandon's Asperger's syndrome, which falls under autism spectrum disorder, it was unclear if Brandon truly understood the questions asked of him. After a day and a half of deliberation, the jury returned with a guilty verdict. Brandon was given the maximum sentence: two life terms without the possibility of parole. **On-screen text graphic:** Brandon has written Sarah Wilson multiple times from jail insisting he is innocent. **48 HOURS: “The Life and Death of Nikki Kuhnhausen”** (10:02 – 11:02p) - a report on the murder of Nikki Kuhnhausen, who disappeared June 6<sup>th</sup>, 2019 after connecting with a man in a Snapchat rendezvous. Her murder continues to impact LGBTQI (lesbian, gay, bisexual, transgender, queer and intersex people) communities. The murder of Kuhnhausen illustrates the real-life dangers and struggles many in the transgender community face every day. Kuhnhausen, age 17, vanished from Vancouver, WA in June 2019, just hours after meeting and exchanging messages on Snapchat with David Bogdanov, then 25. Bogdanov also seemingly disappeared. Four months later, Bogdanov claimed phone problems when he met with police and told them the last time he had seen Kuhnhausen was when he asked her to get out of his car, after she told him she was transgender. Bogdanov told police he had no idea where Kuhnhausen went after she left him. On December 7<sup>th</sup>, 2019, six months after she disappeared, Kuhnhausen’s body was discovered by a hiker on Larch Mountain. Bogdanov was arrested on December 17<sup>th</sup>, 2019 after cell tower data placed his phone where Kuhnhausen’s body was found. Prosecutors and investigators say Bogdanov killed Kuhnhausen in a hate-filled rage after learning she was transgender. At his August 2021 trial, Bogdanov said he killed Kuhnhausen in self-defense when she reached for his gun. He testified that he panicked after realizing she was dead and dumped Kuhnhausen’s body at Larch Mountain. Bogdanov was found guilty of murder in the second degree and malicious harassment, a hate crime. He was sentenced to the maximum 19 and a half years for murder, with 12 concurrent months for the malicious harassment charge. His work at CSI was so unique it inspired the hit CBS primetime series, **BULL**, starring Michael Weatherly, currently in its 6<sup>th</sup> season. Based on Dr. McGraw's professional life, he also serves as Executive Producer, writer and co-creator.

Also in primetime, Dr. Phil recently partnered with Richard Linklater and Bill Guttentag to executive produce the new docuseries **THAT ANIMAL RESCUE SHOW**, now streaming on CBS

All Access. He also stars in and executive produces the new hit primetime series on CBS, **HOUSE CALLS with Dr. Phil**. Additionally Dr. McGraw is in pre-production on two projects in partnership with Tyler Perry: a movie and a docuseries.

His podcast, **PHIL IN THE BLANKS** – with all-new, original interviews – debuted in January 2019 and quickly rose to the #1 podcast on Apple iTunes. In spring 2019, McGraw launched a second podcast – a true crime series – **MYSTERY AND MURDER: ANALYSIS BY DR. PHIL**, which debuted at #1.

Dr. McGraw is the author of nine #1 *New York Times* best sellers, published in 39 languages with more than 50 million copies in print. He is extremely entrepreneurial, working closely with his oldest son Jay, they have created a revolutionary telemedicine system to deliver medical and psychiatric care via smart phone or computer. "Doctor on Demand" (DOD) has taken the telemedicine industry by storm and was voted the most innovative and disruptive new technology at the 2015 Consumer Electronics Show.

Dr. McGraw and his wife, Robin, are well-known for their tireless philanthropic work particularly in the advocacy for children and families. In 2003, Dr. McGraw established the Dr. Phil Foundation, now known as *When Georgia Smiled, a Robin McGraw and Dr. Phil Foundation* a nonprofit charitable organization funding many worthy projects benefitting disadvantaged children and families and battling the epidemic of Domestic Violence. He and his wife have also supported many charitable organizations including the Court Appointed Special Advocates (CASA) by devoting countless hours to CASA's recruitment project and generating an increase of \$100 million of volunteer services in just one year.

Dr. McGraw is frequently invited to testify as a content expert on Capitol Hill before Congress on high-profile topics, including the overmedication of children in the foster care system, the growing epidemic of Type 2 diabetes, cyberbullying, opioid addiction, and domestic violence. Dr. McGraw is also regularly called upon for his expert opinion on current events by major national and international news outlets as well.

Dr. McGraw earned a doctoral degree in clinical psychology from the University of North Texas, followed by a post-doctoral fellowship in forensic psychology from the Wilmington Institute. Dr. McGraw was a licensed psychologist in the state of Texas where he practiced clinical psychology until moving to California to launch **DR. PHIL**.

An avid tennis player, golfer and scuba diver, Dr. McGraw lives in Dallas, Texas with his wife, Robin. The couple, married 45 years in August 2021, are totally devoted to their family, including sons Jay and Jordan, Jay's wife, Erica, and Jordan's wife, Morgan Stewart. They are the ridiculously proud grandparents of Avery Elizabeth, London Phillip and Row Renggli McGraw.
