- 17. THE ALLEGED COVER-UP IN A "RAPE CASE" AGAINST THE FRANKFORT POLICE DEPARTMENT WILL BE ALLOWED TO CONTINUE AS FEDERAL JUDGE SARA EVANS BARKER RULES THAT A MOTION TO DISMISS IS DENIED TO ROBERT HESSION, JASON ALBAUGH AND TROY BACON.
- 18. THE CLINTON COUNTY COMMISSIONERS APPROVED THE HIRING OF HWC ENGINEERING OUT OF INDIANAPOLIS AS THE ENGINEERING FIRM FOR THE Conagra road project.

- 19. FRANKFORT MAYOR CHRIS McBARNES ANNOUNCES THAT THE CSX RAILROAD TRACKS ON STATE ROAD 28 WEST SHOULD BE FIXED THIS SUMMER AND THAT HE HAS CONVINCED THE INDIANA DEPARTMENT OF TRANSPORTATION TO FIX STATE ROAD 28 WEST. INDOT IS EXPECTED TO RESURFACE THE ROAD THIS SUMMER BEFORE THE PROJECT STARTS IN AT LEAST TWO YEARS.
- 20. THE CLINTON COUNTY REPUBLICAN PARTY SUFFERED A HUGE LOSS WITH THE PASSING OF FORMER CLINTON COUNTY CENTRAL COMMITTEE CHAIRMAN BEVERLY BUSH, WHO DIED MARCH 29 AT ST. VINCENT HOSPITAL IN INDIANAPOLIS FOLLOWING A STROKE. SHE WAS 85.
