

1. A 'MISCOMMUNICATION BETWEEN RELATIVES' IS BEING BLAMED FOR A THREAT OF A POSSIBLE SHOOTING OF TEACHERS AND STUDENTS AT LOCAL AND AREA SCHOOLS. ALL SCHOOLS IN CLINTON COUNTY WERE PLACED ON LOCKDOWN AFTER THE THREAT WAS RECEIVED.
2. HISTORY WAS MADE IN FRANKFORT AS THE BICENTENNIAL TORCH RELAY CAME TO DOWNTOWN FRANKFORT IN FRONT OF NEARLY 500 FOURTH-GRADE STUDENTS FROM THE COUNTY PLUS A HUGE CROWD OF ADULTS. MAYOR CHRIS McBARNES WAS ONE OF 22 TORCHBEARERS FOR THE EVENT.
3. THE CLINTON COUNTY HISTORICAL MUSEUM WILL REMAIN CLOSED UNTIL NEXT SPRING ACCORDING TO MUSEUM DIRECTOR NANCY HART.
4. THE CITY OF FRANKFORT NOW HAS A NEW DOWNTOWN REVITALIZATION PLAN AFTER THE CITY COUNCIL APPROVED THE MEASURE.
5. THE CLINTON COUNTY CHAMBER BOARD OF DIRECTORS HAS ACCEPTED THE \$280,000 OFFER FROM CLINTON COUNTY TO PURCHASE THE COAPSTICK-DOAN BUILDING AT 259 EAST WALNUT STREET ACROSS THE STREET FROM OLD STONEY.
6. THE FRANKFORT CITY PLAN COMMISSION ELECTED TO TABLE THE CLINTON COUNTY BICYCLE/PEDESTRIAN PLAN UNTIL A JOINT HEARING BETWEEN THE CITY AND COUNTY CAN BE HELD.
7. THE CLINTON COUNTY COMMISSIONERS APPROVED REZONING LAND OUT BY M&K TRUCKING IN ORDER FOR TWO NEW BUSINESSES WHO HAVE EXPRESSED INTEREST IN THAT AREA TO START WORK ON MOVING IN.
8. REPUBLICAN STEVE WOODS WILL BE MOVING FROM HIS POSITION ON THE CLINTON COUNTY COUNCIL TO THE CLINTON COUNTY COMMISSIONERS AFTER HIS VICTORY OVER DEMOCRAT MARK NEHWART FOR THE DISTRICT 1 SEAT IN THE GENERAL ELECTION.
9. AFTER EXTENSIVE DISCUSSIONS, THE CLINTON COUNTY COMMISSIONERS, CLINTON COUNTY COUNCIL AND INDIANA UNIVERSITY (IU) HEALTH HAVE AGREED ON THE TERMS OF A MASTER LEASE AGREEMENT FOR IU HEALTH TO OPERATE THE FRANKFORT HOSPITAL BEGINNING JUNE 1, 2017.
10. THE NEW SEVEN-PERSON CLINTON COUNTY FAIR BOARD WITH THE FINAL INDIVIDUAL NAMED BY THE CLINTON COUNTY COUNCIL.
11. THE FRANKFORT CITY COUNCIL APPROVED BY A 4-3 VOTE NEW ELECTRIC RATES AND CHARGES FOR THE CITY OF FRANKFORT.
12. ABOUT 175 PEOPLE FILLED THE CLINTON CENTRAL ELEMENTARY SCHOOL GYMNASIUM TO HEAR THE LATEST ROUND OF DISCUSSION ON THE WIND FARM ORDINANCE.
13. THE NEW WESLEY MANOR SOUTHSIDE APARTMENT COMPLEX IS NOW OPEN ON THE SITE OF THE FORMER ELEMENTARY SCHOOL ON ALHAMBRA AVENUE IN FRANKFORT.

14. ROSSVILLE RESIDENTS HAVE GIVEN THE ROSSVILLE CONSOLIDATED SCHOOL DISTRICT THEIR BLESSING ON A \$20 MILLION RENOVATION OF ROSSVILLE HIGH SCHOOL WHICH IS DESIGNED TO AID THE SAFETY AND HEALTH OF STUDENTS AND STAFF.
15. FOR THE PAST 40 YEARS, THE CLINTON COUNTY COURTHOUSE HAS BEEN A SECOND HOME FOR LINDA BRAMMELL, WHO IS RETIRING AT THE END OF THIS YEAR AS CLINTON COUNTY RECORDER. MANY WELL WISHERS FROM FAMILY MEMBERS TO CITY AND COUNTY OFFICIALS TO FELLOW COURTHOUSE WORKERS TURNED OUT FOR A CELEBRATION IN HER HONOR AT THE COURTHOUSE.
16. THE FRANKFORT/CLINTON COUNTY AIRPORT AUTHORITY BOARD VOTED UNANIMOUSLY TO HAVE ITS BUILDING COMMITTEE TO NEGOTIATE WITH THE LOW BIDDER FOR THE PROPOSED TERMINAL HANGAR PROJECT.
17. THE CITY OF FRANKFORT SHOWS OFF ITS NEWLY RENOVATED OLD STONEY STRUCTURE AT AN OPEN HOUSE.
18. THE FRANKFORT PLAN COMMISSION REVERSED ITS DECISION FROM ONE WEEK AGO AND VOTED 4-2 AGAINST THE POTENTIAL MOVE OF THE GOODWILL BUILDING.
19. AFTER 48 YEARS OF DEVOTED AND TIRELESS SERVICE, THE FOUNDERS OF THE RED BARN SUMMER THEATRE, MARTIN AND CAROL ANN HENDERSON, HAVE ANNOUNCED THEIR RETIREMENT. THE HENDERSONS HAVE PUT THE RED BARN IN THE HANDS OF MICHAEL TAYLOR, WHO IS THE PERFORMING ARTS INSTRUCTOR AT FRANKFORT HIGH SCHOOL.
20. THE CITY OF FRANKFORT AND CLINTON COUNTY LOST SEVERAL LONG-TIME COMMUNITY MEMBERS IN DECEMBER SUCH AS REVEREND LEWIS SMITH, BARB SIEGFRIED, RAY RUDD, BILL BEARD, WILBUR HUFFER AND JOE NEAL.
