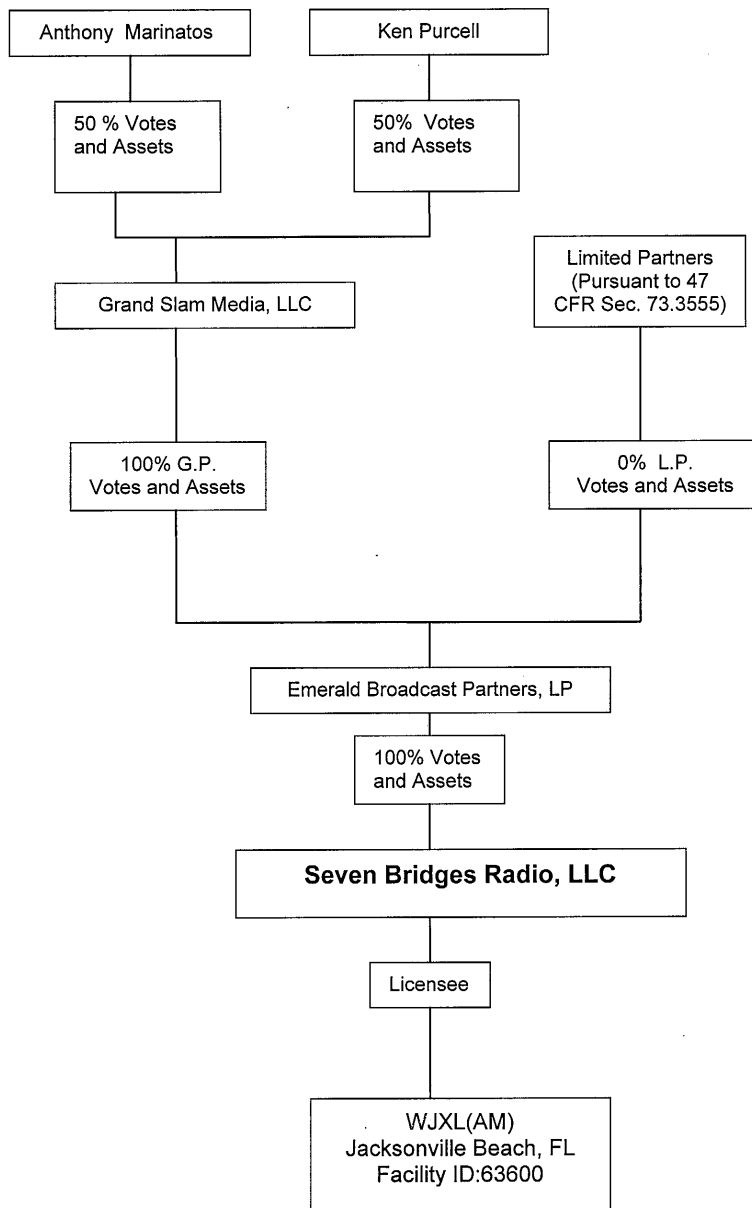

The limited partners in Emerald Broadcast Partners, LP are not materially involved, directly or indirectly, in the management or operation of the media related activities of the partnership as previously certified by Seven Bridges.

Grand Slam Media, LLC is owned by Anthony Marinatos and Ken Purcell. All ownership interests in Grand Slam Media, LLC are held by Mr. Marinatos and Mr. Purcell who hold and vote their respective interests as follows: Marinatos (50%) and Purcell (50%). The preceding parties presently have no attributable interests in any mediums of mass communication, including broadcast stations.
