As you know, on January 1, 2009, Four Points Media Group LLC (“FPMG”) and Comcast Cable Communication, LLC (“Comcast”) entered into a retransmission consent agreement governing the carriage of stations WTVX, WWHB-CA and WTCN-CA on Comcast cable systems (the “Agreement”).
