Dear Ms. Dortch:

America-CV Station Group, Inc. ("America-CV"), hereby requests a change of the PSIP virtual channel identifiers for Stations WJPX, San Juan, WKPV, Ponce, WJWN-TV, San Sebastian, and WIRS, Yauco, Puerto Rico, as discussed below.

America-CV operates four full power television stations in Puerto Rico. Each of the four transmits from a different tower site:

WKPV and WJWN-TV operate as satellites of WJPX, as approved in BALCDT-20091123AKM. WIRS broadcasts separate programming on virtual Channel 42.1 but rebroadcasts the programming of WJPX on virtual Channel 42.2.

The stations as a group offer two separate programming services: the MundoFox television network and ACV's own program service known as "AméricaTévé." ACV wishes to make each service available to the entire island of Puerto Rico, which is one economic market, with a common channel identifier – virtual Channel 24 for MundoFox and virtual Channel 42 for AméricaTévé. To that end, authority is requested to use the following PSIP virtual channel identifiers:

WJPX, WKPV, and WJWN-TV (all the same):

Dot 1 stream = MundoFox, PSIP 24.1.

Dot 2 stream = AméricaTévé, PSIP 42.2

WIRS:

Dot 1 stream = AméricaTévé, PSIP 42.1. Dot 2 stream = MundoFox, PSIP 24.2

This request involves only virtual channel PSIP identification. No change in any RF channel is requested.

The two virtual channels involved – 24 and 42 – already are in use by America-CV on the stations involved in this request, all in the single Puerto Rico market. No other licensee or market is involved, and no new number is being introduced which might cause confusion with any other station. ACV believes that ATSC Standard A/65B permits a group of commonly owned stations in the same market to share the same virtual channel PSIP, which is what we are requesting.

ACV is satisfied that because of the terrain in Puerto Rico, which prevents the signals of most stations from reaching the entire island even though the island is one market, viewers will not receive confusing signals. "Channel 24" will represent MundoFox uniformly throughout the island, and "Channel 42" will represent AméricaTévé. ACV is also comfortable that it can successfully address any potential problem of receivers misinterpreting multiple signals with the same virtual channel.

Thank you for your consideration of this request.
