Re: RT Communications, Inc. ("RT")/KCWC; Retransmission Consent and Carriage

Dear Becky,

Central Wyoming College ("Licensee"), on behalf of the Station identified on Attachment A ("Station"), consents to the retransmission to RT's subscribers, on a non-exclusive basis, simultaneously with its broadcast, in its entirety and without material degradation, of the Station's television broadcast signals (which shall include, for the avoidance of doubt, the HD feed), including program-related material (as defined by the FCC) (but excluding, however, those portions of the signal(s) that are not offered by the Station on a free-over-the-air basis, including any portion thereof that consists of video-on-demand programming or any encrypted video or audio programming, data, or content offered by the Station over-the-air to subscribers on a paid subscription basis). Retransmission of the Station's signal shall be without interruption, additions, insertions, alterations, deletions, or material degradation.

In exchange for the consent granted in this letter, RT agrees to retransmit the Station's signal for the full term under the terms and conditions of this letter agreement to end-user subscribers served by its cable systems providing service within the Station's Designated Market Area, where the Station is "significantly viewed" (as defined by the FCC), and to those subscribers who receive RT's Skitter TV service (or its successor); provided that the subscribers are located in the service areas set forth on Attachment B. Additional service areas may be added to Attachment B upon written notice to Licensee which notice shall include the areas to be served and the intended launch date. Upon notice, Attachment B shall be considered automatically amended to include such service areas.

The initial term of this letter agreement shall begin on the date first set forth on this letter agreement and shall continue for three (3) years. At the end of the initial term, this letter agreement shall continue for successive twelve (12)-month extensions unless a party gives written notice of termination sixty (60) days before the expiration of the initial term or extension, which termination shall be effective at the end of the then-current term. RT may terminate this letter agreement upon thirty (30) days prior notice to Station in the event RT does not provide cable television or Skitter TV service (or its successor).

This letter agreement shall not be assigned by either party without the prior written consent of the other party. A party shall not unreasonably withhold or delay its consent. Notwithstanding the foregoing, a party may assign this letter agreement without consent to a

party under common ownership and control. This letter agreement shall bind and benefit the parties and their respective permitted successors.

Licensee represents and warrants that (i) it is duly organized, validly existing and in good standing under the laws of the State of its formation; (ii) it has the requisite power and authority to execute and deliver this letter agreement and to fully perform its obligations hereunder; (iii) it is not subject to any contractual or other legal obligation which will in any way interfere with its full performance of this letter agreement and is not required to obtain any consents, authorizations, permits, licenses or exemptions in order to fully perform this letter agreement; (iv) it owns the right to grant the rights hereunder free and clear of any and all claims by any third party; (v) it will at all times be authorized by the FCC to broadcast the Signal; (vi) it will at all times provide RT with a good quality signal that complies with all statutory and regulatory requirements; and (vii) the individual executing this Agreement on behalf of Licensee has the authority to do so.

RT represents and warrants that: (i) It is duly organized, validly existing and in good standing under the laws of the State of its formation; (ii) it has the requisite power and authority to execute and deliver this letter agreement and to fully perform its obligations hereunder; (iii) it is not subject to any contractual or other legal obligation which will in any way interfere with its full performance of this letter agreement and is not required to obtain any consents, authorizations, permits, licenses or exemptions in order to fully perform this letter agreement; (iv) it owns the right to grant the rights hereunder free and clear of any and all claims by any third party; (v) it will at all times be authorized under applicable federal, state and local laws to operate the Systems; and (vi) the individual executing this letter agreement on behalf of RT has the authority to do so.

Each party to this letter agreement shall assume the risk of any liability from its own conduct. Neither party agrees to insure, defend, or indemnify the other. Licensee does not waive its governmental immunity by entering into this letter agreement. Licensee specifically retains all immunities and defenses available as a governmental entity pursuant to W.S. § 1-39-101. This letter agreement shall be governed by and construed under and in accordance with the laws of the jurisdiction of the Ninth Judicial District, Fremont County, Wyoming, subject to all applicable rules, regulations, and orders, including without limitation provisions of the Communications Act of 1934, as amended, and regulations of the FCC.

This letter agreement constitutes the entire agreement and understanding between the parties hereto with respect to the subject matter hereof and supersedes all prior or contemporaneous, express or implied, written or oral agreements, representations, and conditions between the parties with respect thereto. Invalidation of any provision of this letter agreement by applicable law shall not affect the validity of any other provision of this letter agreement. This letter agreement may be modified or amended only by a written instrument signed by Licensee or Station and RT. The terms of this letter agreement shall remain confidential.



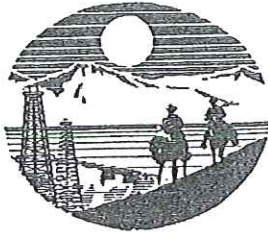

Terms and Conditions

1. Subject to the terms and conditions set forth herein, Bonneville International Corporation, a Utah corporation ("Bonneville"), hereby consents to the non-exclusive retransmission of the Signal, as defined below, of television station KSL-TV, Salt Lake City, Utah (the "Station") by Central Wyoming College ("Licensee") on the above-referenced translator (the "Translator").
2. As used herein, the term the "Signal" shall mean the Station's entire analog broadcast signal, including its primary video, audio, line 21, close-captioned transmissions and materials in the vertical blanking interval and subcarriers and program identification codes on line 22.
3. The retransmission of the Signal by the Translator shall be only on a simultaneous basis with the broadcast of the Signal by the Station and without interruption or delay.
4. The retransmission of the Signal by the Translator shall not be construed as conveying ownership of any of the copyrights of and to the underlying programming transmitted by the Station.
5. Licensee shall not authorize, cause, permit or enable anything to be done whereby the Signal may be recorded, duplicated or otherwise used for any purpose other than simultaneous retransmission by the Translator as provided herein.
6. Licensee shall not make any deletions from, or additions to, the Signal, or broadcast any commercial or other announcements in connection with the retransmission of the Signal by the Translator, or sell the Signal for commercial sponsorship.

7. None of the NBC Television Network ("NBC"), Bonneville or Licensee shall incur any liability hereunder because of Bonneville's failure to deliver the Signal, or Licensee's failure to retransmit the Signal on the Translator.

8. Bonneville's consent to retransmit the Signal on the Translator is limited to such rights as Bonneville may have in the Signal, and neither Bonneville's consent to retransmit nor Licensee's authority to retransmit shall be deemed to require Licensee to retransmit the Signal on the Translator.

9. Licensee shall not charge, nor shall Licensee receive, any compensation for retransmitting the Signal on the Translator.

10. The term of this Agreement shall begin on the date written below and continue until such time as one party gives the other party at least thirty (30) days' written notice of termination.

11. Licensee shall maintain all operating licenses and other authorizations under all applicable laws, rules and regulations, including, without limitation, all licenses issued by the Federal Communications Commission (the "FCC"), as now are or hereafter may be necessary for the Translator to retransmit the Signal.

12. Licensee shall advise Bonneville in writing not less than ninety (90) days in advance of any material increase in the transmission power for the Translator or a material change in the location of the Translator. The retransmission authority granted herein shall terminate, unless Bonneville gives written consent to the retransmission of the Signal by the Translator after such material increase in transmission power or material change in location.

13. The representations and agreements contained herein shall be deemed continuing representations and agreements during the term of this Agreement.

14. Nothing herein shall be construed to hinder or prevent Bonneville or Licensee from complying with their respective responsibilities as a licensee or permittee of the FCC, and this Agreement shall be subject to all applicable federal, state and local laws, rules and regulations, including, without limitation, the Communications Act of 1934, as amended, and the rules, regulations and policies of the FCC.

15. Licensee shall indemnify and hold NBC and Bonneville, and their respective officers, directors, employees, subsidiaries, affiliates, agents and assigns, free and harmless from any costs or expenses incurred in connection with the retransmission of the Signal by Licensee in a manner inconsistent with the terms and conditions of this Agreement.

16. This Agreement constitutes the entire agreement between Bonneville and Licensee with respect to the subject matter of this Agreement, all prior understandings being merged herein. All questions or disputes with respect to this Agreement shall be determined in

accordance with the internal laws of the State of Utah. This Agreement may not be changed, modified, renewed, extended or discharged, except as specifically provided herein or by an agreement in writing signed by the parties hereto.

17. Any notices hereunder shall be in writing and shall be given by personal delivery, overnight courier service or registered or certified mail, addressed to the respective addresses set forth on the first page of this Agreement (the zip code 84180 must be used for notices directed to Bonneville at its street address) or at such other address or addresses as may be specified in writing by the party to whom the notice is given. Such notices shall be deemed given when personally delivered, delivered to an overnight courier service or mailed, except that notice of change of address shall be effective only from the date of its receipt.

18. A waiver by either party of a breach of any provision of this Agreement shall not be deemed to constitute a waiver of any preceding or subsequent breach of the same provision or any other provision.

19. NBC shall be deemed a third party beneficiary of this Agreement insofar as it relates to the retransmission of programming supplied to the Station by NBC.



In the event of a conflict between the terms and conditions of this Agreement and the terms and conditions of the Translator Agreement, the latter shall control.
