



FOX 10 Xtra News airs 1 hour of live news each weekday @ 7PM. In addition, the station produces a 2 hour streaming live news show each weekday @ 10AM, "FOX 10 News Now."

This report highlights the issues that were of greatest importance during the months of July, August, and September 2019.

On the chart that follows we list the stories we covered in these topic areas including the date, specific newscast and on-air format. Here is a key to estimate how much time we allocated to each story:

RDR = reader

Anchor reads script with no video. Typically 20 seconds

VO = anchor voice-over

Anchor reads script with video. Typically 20-30 seconds

VOSOT = anchor voice-over/"sound on tape"

Anchor reads script with video. Story includes sound bite from interview subject.
Usually 45 seconds

LIVE VO = live voice over

Reporter live in the studio or field with extended video and information. Typically 1 minute

LIVE VOSOT = live voice over/"sound on tape"

Reporter live in the studio or field with extended video and sound bite from interview subject. Usually 1 minute, 45 seconds

PKG = reporter package

A self-contained story narrated by an anchor or reporter
An anchor usually introduces the story
Including anchor introductions, stories typically run 1 minute, 30 seconds

LIVE PKG = live reporter including reporter package

Same as PKG above, except a reporter introduces the story live from the scene

MARY ANN MENDOZA SAYS THE SOCIAL MEDIA PLATFORM BANNED HER, CLAIMING SOME OF HER POSTS GO AGAINST TWITTER'S STANDARDS ON HATE SPEECH. MENDOZA SAYS TWITTER WOULD ONLY RESTORE HER ACCOUNT IF SHE DELETED THE POSTS, WHICH SHE REFUSED. PRESIDENT TRUMP TWEETED, DEFENDING MENDOZA. SHE SAYS SHE MAY TAKE LEGAL ACTION AGAINST TWITTER.

THE JUDGE DENIED A TEMPORARY RESTRAINING ORDER FROM IMMIGRANT ADVOCATE GROUPS WHO SUED OVER THE TRUMP ADMINISTRATION'S NEW ASYLUM RESTRICTIONS. NOW THE A-C-L-U IS ASKING A JUDGE TO RULE WHETHER THE SEPARATIONS WERE JUSTIFIED. THE GROUP SAYS ABOUT 20-PERCENT OF THE CHILDREN SEPARATED FROM THEIR PARENTS WERE UNDER THE AGE OF FIVE.

THIS WAS A BIG SHOW OF FORCE, NEARLY 600 ICE AGENTS FANNED OUT ACROSS SEVERAL PLANTS TAKING PEOPLE INTO CUSTODY, BUT AS OF THIS AFTERNOON NEARLY HALF HAVE ALREADY BEEN RELEASED. MICHAEL HURST / U.S. ATTORNEY FOR THE SOUTHERN DISTRICT OF MISSISSIPPI HURST says: "Believed to be the largest single state immigration enforcement operation in our nation's history." THE RAIDS HAPPENING WEDNESDAY IN SMALL TOWNS OUTSIDE JACKSON, WHERE THE WORKFORCE IS LARGELY MADE UP OF LATINO IMMIGRANTS. AUTHORITIES SAY ABOUT 600 AGENTS FANNED OUT ACROSS THE PLANTS, SURROUNDING THE PERIMETERS TO PREVENT WORKERS FROM FLEEING. SOME OF THE CHILDREN OF THOSE ARRESTED - NOW LEFT HOMELESS, AND UNSURE OF WHEN THEY WILL SEE THEIR PARENTS AGAIN. MAGDALENA GOMEZ GREGORIO / FATHER ARRESTED BY ICE, GREGORIO says: "These Hispanic people aren't doing nothing bad. They're not stealing nothing. The immigrants just want jobs inside the company, just get our dads out of there. // My dad didn't do nothing he is not a criminal." CHRISTINA PERALTA / GODMOTHER OF KIDS IMPACTED, PERALTA says: "A lot of people here has no record, they've been here 12 years, 10 years, 15 years with no record, just working, trying to take care of their family." ICE'S ACTING DIRECTOR IS DEFENDING THE ARRESTS. MATT ALBENCE / ACTING ICE DIRECTOR, ALBENCE says: "These are not victimless crimes. Illegal workers create vulnerabilities in the marketplace by presenting false documents to obtain illegal employment." THE DETAINED WORKERS WERE BUSSED TO A MILITARY AIRPORT HANGAR TO BE PROCESSED. NEARLY HALF HAVE ALREADY BEEN RELEASED DUE TO "HUMANITARIAN FACTORS", BUT ARE EXPECTED TO EVENTUALLY APPEAR IN COURT.
8/14/19	7PM	VO	ARGUMENTS IN JOE ARPAIO'S APPEAL HAVE BEEN SET FOR OCTOBER 23RD. ARPAIO WAS CONVICTED OF MISDEMEANOR CONTEMPT OF COURT FOR DISOBEYING A COURT ORDER TO STOP HIS IMMIGRATION PATROLS. HE WAS PARDONED BY PRESIDENT DONALD TRUMP, BUT A JUDGE REFUSED TO EXPUNGE THE CONVICTION SAYING THE PARDON ONLY SPARED HIM FROM BEING PUNISHED.
8/14/19	7PM	VO	A BORDER PATROL MAKING A BIG DRUG BUST. BORDER AGENTS AT THE INTERSTATE 8 IMMIGRATION CHECKPOINT SAY A PHOENIX MAN WAS CAUGHT TRYING TO SMUGGLE MULTIPLE PACKAGES OF METH IN HIS VEHICLE. AFTER BEING ALERTED BY THE CANINE, A SEARCH OF THE VEHICLE FOUND OVER 34 POUNDS OF METHAMPHETAMINE WITH AN ESTIMATED STREET VALUE OF MORE THAN \$78-THOUSAND DOLLARS. THE 54-YEAR-OLD WAS ARRESTED FOR THE TRANSPORTATION OF A CONTROLLED SUBSTANCE.
8/15/19	7PM	VO	CONSTRUCTION ON PARTS OF THE BORDER FENCE IN SOUTHERN ARIZONA ARE ON HOLD. THE WORK IS BEING DELAYED UNTIL OCTOBER BECAUSE THE FEDERAL GOVERNMENT IS STILL WORKING ON THE DESIGN PLANS. THE CURRENT PLANS INCLUDING REPLACING WAIST-HIGH BARRIERS WITH TALLER FENCING IN A WILDLIFE REFUGE, NATIONAL MONUMENT AND CONSERVATION AREA. ENVIRONMENTALISTS SAY THE NEW BARRIERS WILL DAMAGE WILDLIFE HABITAT. THE FEDS SAY THE REPLACEMENT FENCING IS CRUCIAL TO NATIONAL SECURITY.
8/19/19	7PM	PKG	WITH MAJOR OVERCROWDING ISSUES AT BORDER PATROL FACILITIES, THE DEPARTMENT OF HOMELAND SECURITY TOOK ACTION TO BUILD TEMPORARY FACILITIES. INCLUDING THE LATEST, BUILT WITHIN 45 DAYS AND IS NOW IN OPERATION AT A TEXAS PORT OF ENTRY. FOX NEWS' CHARLIE LAPASTORA JOINS US LIVE IN STUDIO AFTER TOURING THE FACILITY WITH BORDER PATROL AGENTS, THE D-H-S SECRETARY, AND OTHER MEDIA MEMBERS...CHARLIE WHERE WAS THIS FACILITY? MARC AND CHRISTINA, RECENTLY GOT BACK FROM THE TORNILLO PORT OF ENTRY, WHICH IS ABOUT 45 MINUTES SOUTHEAST OF EL PASO. THE NEW TEMPORARY HOLDING FACILITY IS NOW IN OPERATION TO HELP RELIEVE OVERCROWDING AT FACILITIES ACROSS THE SOUTHWEST BORDER THAT WERE NEVER DESIGNED TO HOLD SO MANY PEOPLE. THE EL PASO SECTOR ALONE HAS SEEN A 130-PERCENT INCREASE IN SINGLE ADULT APPREHENSIONS COMPARED TO LAST YEAR...SO THE DEPARTMENT OF HOMELAND SECURITY STEPPED IN. McALEENAN says: "We needed to provide additional capacity to manage this flow." THESE FACILITIES AT THE TORNILLO PORT OF ENTRY ARE DESIGNED TO HOLD UP TO 2,500 SINGLE ADULTS. MIGRANTS ARE GIVEN ACCESS TO MEDICAL CARE, ALONG WITH SLEEPING BAGS, 3 MEALS A DAY, CLEAN CLOTHES, A PRIVATE SHOWER, AND LAUNDRY SERVICES...ALL SO THEY CAN MAKE CALLS THEY NEED, INCLUDING SPEAKING TO A CONSULATE OFFICER, THEN MOVING THEM OUT WITHIN 3 DAYS. CHAVEZ says "We are in dire need in the field during this crisis situation... everyday I'm worried we will go back to it tomorrow next week but that's okay because as you can see we're now more prepared with the temporary facility" BECAUSE OF MAJOR OVERCROWDING CONCERNS, THE DEPARTMENT OF HOMELAND SECURITY GRANTED THE FUNDING FOR THE BORDER PATROL TO OPEN THIS NEW FACILITY. ACTING BORDER PATROL COMMISSIONER MARK MORGAN AGREES THE NEW FACILITY IS A TEMPORARY FIX...AND NOT A "DURABLE, SUSTAINABLE SOLUTION." HE THINKS CONGRESS NEEDS TO COME UP WITH A MORE PERMANANT SOLUTION.
