- a) The Maine Land Use Planning Commission (LUPC) is poised to make the biggest proposed policy change in Commission history. Their plan to change adjacency criteria, eliminating the so-called "one mile rule", would open up over 1.3 million acres of the Maine woods to residential subdivisions. 800,000 of those acres would also be opened to commercial development. This would open an unspecified number of class 3 lakes to development.
- b)Opponents say, the policy change would also reverse a 2001 legislative ban on large residential subdivisions of 25 acres (so called, kingdom lots), and would allow subdivisions of up to 14 lots and 30 acres to meet only limited environmental review on approximately 400,000 acres.

Mainers may have a chance in November to vote on a bond issue that would authorize \$15 million to build housing for homeless people in the state: LD 48, "An Act To Authorize a General Fund Bond Issue To Invest in Housing for Persons Who Are Homeless". The plan is to expand a "Housing First" model that has proven successful in Portland to other parts of the state.

We speak with Representative Michael Brennan of Portland, who is also a former mayor of the city and an adjunct professor of social work, the sponsor of LD 48, and Donna Yellen, Deputy Director of Preble St. in Portland- the agency that oversees the "housing first" programs there.
