

AMENDMENT

This AMENDMENT (the "Amendment") is made and entered into this 11th day of October, 2016, by and between WCIU-TV Limited Partnership (an Illinois limited partnership) licensed owner of television station WCIU-TV ("WCIU-TV") and WLS Television Inc., (a Delaware Corporation) licensee of television station WLS-TV ("WLS-TV"). This Amendment incorporates changes to the License Agreement dated December 15, 2014 between the Parties ("Agreement"). All capitalized terms not otherwise defined herein shall have the meaning set forth in the Agreement.

Except as specifically modified herein below, the Agreement shall remain in full force and effect hereunder:

1. Production:



include non-exclusive material, including, but not restricted to, videotape, graphics and news stories and reporters, sports and weather reports, which may also appear on WLS-TV's own newscasts or those of its licensees. Except in connection with major news events and issues of importance to the local community, WLS-TV will use reasonable efforts to control the use of previously canned news content from earlier WLS-TV newscasts that day. WLS-TV covenants that important content will not be held back from the WCIU-TV Newscast news in order to break it at 10:00 pm on WLS-TV.

4. Term:

(ii) The Renewal Term of this Amendment shall be for a period of twelve (12) months, from January 16, 2017 through January 12, 2018; provided, however, that upon the end of the Renewal Term, this Agreement will be automatically renewed for successive twelve (12) month periods, unless by June 1 of the then current Term, or any Renewal Term, either Party provides written notice to the other Party (in accordance with the notice provisions herein provided) that it is terminating the Agreement as of September 1 of the current calendar year, prior to the end of the then current Term.
