# **Issues Report**

Quarterly Issues Program List for Station -- WBOI Jan. 1 - March 31, 2019 Placed in the Public File - April 10, 2019

The station has identified the following issues as significant issues facing our community this quarter:

#### **Section I: Issues**

- **A. Public Health:** Public health matters, from infectious disease to addiction to mental health.
- **B.** Education: Issues related to public school education in our community
- C. Politics and Government: Indiana's legislative session and impact of federal legislation and regulation
- **D.** Criminal Justice: Public safety and the courts
- **E.** Environmental issues: Agriculture, clean water, and land use

### **Section II: Responsive Programs**

The station broadcast programming dealing with each of the above-referenced issues. The programs are outlined below:

#### A. Public Health:

- **"Drug Pricing"** -- (Broadcast on Jan.3 at 6:04a.m. and 7:04 a.m.) Story by Indiana Public Broadcasting reporter Jill Sheridan on increases in drug prices and attempts to deal with it via legislation
- **"Blood Shortage"** -- (Broadcast on Jan. 22 at 4:04 p.m., 6:04 p.m. and Jan 22 at 7:04 a.m.) Story by Indiana Public Broadcasting reporter Jill Sheridan on a statewide shortage of blood donations.
- **"Raise It Rally"** -- (Broadcast on Feb. 19 at 8:04 a.m and 4:04 p.m.) A story by Indiana Public Broadcasting's Jill Sheridan on efforts to raise the state's cigarette tax to help pay for public health programs around Indiana.

**"Lakeland Schools Closure"** -- (Broadcast on March 25 at 4:04 p.m., and March 26 6:04 a.m. and 8:04 a.m.) WBOI Reporter Barb Anguiano covered a decision by a local district to close some elementary schools because of declining enrollment.

#### C. Politics and Government:

#### E. Environmental Issues:
