Below is a list of the station's most significant programming treatment of those issues for the period of OCTOBER 1ST- DECEMBER 31ST 2020

HEALTHCARE- This station chose to address a variety of health issues of continuing importance to our listeners. These issues cover areas of health care ranging from infants to adults.

THE ARTS- This station believes it is important to support the arts and the entities that work hard to bring the arts to this community, whether it be a museum or a theater group.

ENVIRONMENTAL AWARENESS- This station strives, whenever possible, to alert the community to opportunities to make the environment in which they live a better, healthier one.

Public Service Report for 4th Quarter 2020

October 4th

Officials from the Oklahoma State Election Board joined us on the show to discuss the safety and effectiveness of our election process. We answered questions about the legalities involving poll watchers in our state as well as other concerns.

The YWCA joined us to talk about how they are helping survivors of sexual assault by providing education, counseling, and even legal assistance.

October 11th'

We checked in with the experts from the Oklahoma City County Health Department on ongoing testing information as well as updates on vaccines.

Our extended conversation with the Oklahoma State Election Board continues as we ask more questions about voting procedures during the pandemic.

October 18th

Santa Market is a craft fair that happens every December and is taking a few more applications for booth space as they finalize their event. All proceeds from their event go directly to Alzheimers Association for research and program funding.

We address safety of trick or treating with the Oklahoma City County Health Department during the pandemic with possible safe alternatives for a fun and safe holiday.

October 25th

Part one of our conversation with a newly formed organization called No Justice MWC introduces us to a group of young black women who felt moved to unite following the death of George Floyd.

Our exploration of the history of the formation of the Alzheimers Association connection to the Santa Market continues with updated event information.

November 1^s

We meet with Amy Welch from the Oklahoma Society of CPA's with strategies for dealing with job loss and mounting bills during this pandemic.

Part two of No Justice MWC continues with their coat drive information and community outreach efforts.

November 8th

The Oklahoma Blood institute is requesting blood donations, as well as an increased need for convalescent plasma. We discussed the intricacies of the way giving plasma is done.

Again we check in with the Oklahoma City County Health department with information on preventing the spread of Covid 19.

November 15th

The Great American Smokeout is fast approaching and we invited a representative from the Oklahoma Veteran's Administration to discuss their ongoing efforts to assist veterans with programs to help them stop smoking. Tips and tricks for quitting were discussed.

Oklahoma Society of CPA's representative, Amy Welch, came on the program to give us tips for safely shopping online ahead of black Friday.

November 22nd

The Oklahoma City County Health Department Epidemiologist, Eddie Withers, joined us to discuss the dangers of gathering in large groups or traveling for Thanksgiving. We discussed Covid 19 specifics and urged caution for family gatherings.

The Regional Food Bank of Oklahoma brought two representatives in to talk with us about the increased need for food assistance due to the pandemic. They announced a holiday match that will help increase their fundraising through the end of December.

November 29th

Sunbeam Family Services brought two guests in to discuss job openings in their Early Childhood programs. We discussed the increased need for childcare through their organization due to decreased income because of the pandemic. More people qualify for assistance and therefore the need for qualified teachers provides jobs in their organization.

Foster care needs are also on the rise and Sunbeam Family services provides training and support for families who welcome foster children into their homes.

December 6th

Saving money on Christmas presents is more important than ever this year. Amy Welch gives us helpful financial information from the Oklahoma Society of CPA's to help us get through one of the toughest holiday seasons in recent memory.

We discuss what being a foster family is like from someone who is currently helping three foster children who are in the system. Sunbeam Family Services works with the state of Oklahoma to provide the training needed. This foster father talks about his experiences and the rewarding life he has gained.

December 13th

Q space is an organization that helps LGBTQ plus youth come to terms with their differences through support groups, activities and games online during the pandemic. We talk to the director about his forward-thinking group and the latest group information.

Meg Canon, one of the directors at North Care joins us to discuss the need for awareness of substance abuse during the holidays. Drunk driving is a particular subject that we go into in this episode.

December 20th

Amy Welch comes back to the show with information on the Oklahoma Society of CPA's Financial Fitness kit. We discuss tips for approaching the new year with new financial goals.

Sunbeam family services provides help and support for the many Grandparents who are tasked with raising their grandchildren. Support groups, as well as childcare are available through their many programs. We talk about how they can get help with this unique challenge.

December 27th

We deep dive into year-end giving with Amy Welch from the Oklahoma society of CPAs. This year the laws around charitable giving have changed to allow deductions of up to \$300 dollars without itemizations.
