Re: ELECTION of MUST CARRY Status

Dear :

Pursuant to the provisions of the Cable Television Act of 1992 and Section 76 of the rules of the Federal Communications Commission (FCC), the Arkansas Educational Television Network (AETN) – the PBS affiliate network for Arkansas – informs you that your cable company provides service to viewers located within the signal area provided by AETN.

All public television stations are mandated by law to elect the must-carry provision. Thus, AETN once again requests to be carried on your cable system(s) under the must-carry provisions outlined in Section 76 of the rules of the FCC. AETN relinquishes any retransmission consent election in favor of must-carry. Thus, AETN requests the continuation of the same service(s) of the broadcast signal(s) in your service area that you have been using for your cable system(s) in the past.

For your information, AETN broadcasts non-commercial, educational programming via six channels throughout the state:

- KAFT/13 (Fayetteville)
- KEMV/6 (Mountain View)
- KETG/9 (Arkadelphia)
- KETS/2 (Little Rock)
- KETZ/12 (El Dorado)
- KTEJ/19 (Jonesboro)

AETN prefers to be carried as the same channel number on your system as our broadcast channel, if possible. If possible, AETN also prefers to be referred to on-screen, in your channel line-up information and in any correspondence as AETN rather than the specific broadcast channel, except when referring specifically to that channel as might be necessary.

Please contact me if you have any questions or concerns in this matter. Thank you for your assistance in providing AETN's non-commercial, educational, public television programming to your viewers.
