

ASSIGNMENT OF AUTHORIZATION

THIS ASSIGNMENT OF AUTHORIZATION (this "Assignment"), dated as of September 26, 2014, is made and entered into by and between **Max T. Nichols**, an Individual hereinafter (the "Assignor") and **Riverbend Communications, LLC**, an Idaho limited liability company in good standing hereinafter (the "Assignee"), and is made contemporaneously with the acquisition by Assignee of certain assets of Assignor.

RECITALS

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement, dated as of June 3, 2014 (the "Assignment Agreement"), which provides, among other things, for the acquisition by Assignee of certain assets of Assignor;

WHEREAS, Assignor is the exclusive owner of all right, title to, and interest in the Federal Communications Commission FM Translator Broadcast Station Permits (a) K231BY, 94.1MHz, Pocatello, ID (Facility No. 146561); (b) K224EL 92.7MHz, Pocatello, ID (Facility No. 141125); K266BY 101.1MHz, Pocatello, ID (Facility No. 146523), and K290CA 105.9MHz, West Yellowstone, WY (Facility No. 155899).

WHEREAS, Assignor desires to transfer and assign all of its right, title to, and interest in the Authorization to Assignee and Assignee wishes to acquire the Authorization.

AGREEMENT

NOW, THEREFORE, for the consideration specified in the Assignment Agreement and other good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor does hereby grant, transfer, sell, assign, convey and deliver to Assignee all of Assignor's right, title to, and interest in the licenses, permits and Authorization (including renewals or modifications of such licenses, permits and Authorization and applications therefore) issued or granted by the Federal Communications Commission, or any administrative body or licensing authority or governmental or regulatory agency, with respect to the Authorization.
2. Further Assurances. Assignor for itself, its successors and assigns hereby covenants and agrees that, at any time and from time to time forthwith upon the request of Assignee, Assignor will execute, acknowledge and deliver or cause to be executed, acknowledged and delivered, without additional consideration, each and all of such further acts, deeds, assignments, transfers, conveyances, powers of attorney and assurances as may reasonably be required in order to assign, transfer, set over, convey, assure and confirm unto and vest in Assignee, its successors and assigns, title to the Authorization.

The construction permits for K265EW (Fac. Id. 146523) and K290CA (Fac. Id. 155899) expire on January 16, 2017 and October 22, 2016, respectively. Commission rules which became effective on February 16, 1999, have a bearing on these construction permits. See Streamlining of Mass Media Applications, Report and Order, MM Docket No. 98-43, 13 FCC Rcd 23056 (1999). Pursuant to these rules, consummation of the assignment consented to herein will not extend the expiration dates of the permits. The construction permits will be subject to automatic forfeiture unless construction is complete and applications for license to cover are filed prior to expiration.

The FM Translator Licensee must notify the Federal Communications Commission, Office of the Secretary, 445 12th Street, S.W., Washington, DC 20554 of any change in the station that will be rebroadcast. The parties should also notify Robert Gates via email at Robert.Gates@fcc.gov. See 47 C.F.R. §74.1284.

Under authority of the Communications Act of 1934, as amended, the consent of the Federal Communications Commission is hereby granted to the transaction indicated above.

The Commission's consent to the above is based on the representations made by the applicants that the statements contained in, or made in connection with, the application are true and that the undertakings of the parties upon which this transaction is authorized will be carried out in good faith.

The actual consummation of voluntary transactions shall be completed within 90 days from the date hereof, and notice in letter form thereof shall promptly be furnished to the Commission by the seller or buyer showing the date the acts necessary to effect the transaction were completed. Upon furnishing the Commission with such written notice, this transaction will be considered completed for all purposes related to the above described station(s).

FCC Form 323, Ownership Report, must be filed within 30 days after consummation, by the licensee/permittee or assignee.

ADDITIONAL REQUIREMENTS FOR ASSIGNMENTS ONLY:

Upon consummation the assignor must deliver the permit/license, including any modifications thereof to the assignee.

It is hereby directed that, upon consummation, a copy of this consent be posted with the station authorization(s) as required by the Commission's Rules and Regulations.

The assignee is not authorized to construct nor operate said station(s) unless and until notification of consummation in letter form has been forwarded to the Commission.

Special operating conditions or restrictions:

- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 2 Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.

Special operating conditions or restrictions:

- 3 Pursuant to the waiver of 47 CFR Section 74.1233(a)(1) granted herein the permittee/licensee shall be subject to a holding period. From the grant of the construction permit and continuing until the facility has achieved four years of on-air operations rebroadcasting the AM station identified on this authorization, the permittee/licensee may NOT change the station being rebroadcast by this translator. Periods of station silence shall not count toward the fulfillment of this four-year requirement. During this same four year period the permittee/licensee may not assign or transfer the construction permit/license to another party, unless it is to the licensee of the AM station being rebroadcast. Minor modifications of this authorization are permitted, provided the translator will continue to rebroadcast the AM station for which the waiver was granted.

- 4 Since the application proposes to mount its antenna above the co-located existing directional antennas of the following:

K260CD, Idaho Falls, ID (Facility ID No. 146541)
KTHK(FM), Idaho Falls, ID (Facility ID No. 33447)
KFTZ(FM), Idaho Falls, ID (Facility ID No. 18116)

the permittee must submit, with the FCC Form 350, application for license, an exhibit including a statement from the manufacturers of the directional antennas listed above, stating that the proposed antenna will have no adverse effect on the above listed directional antenna patterns.
