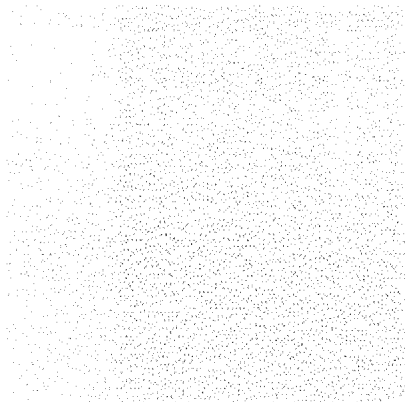

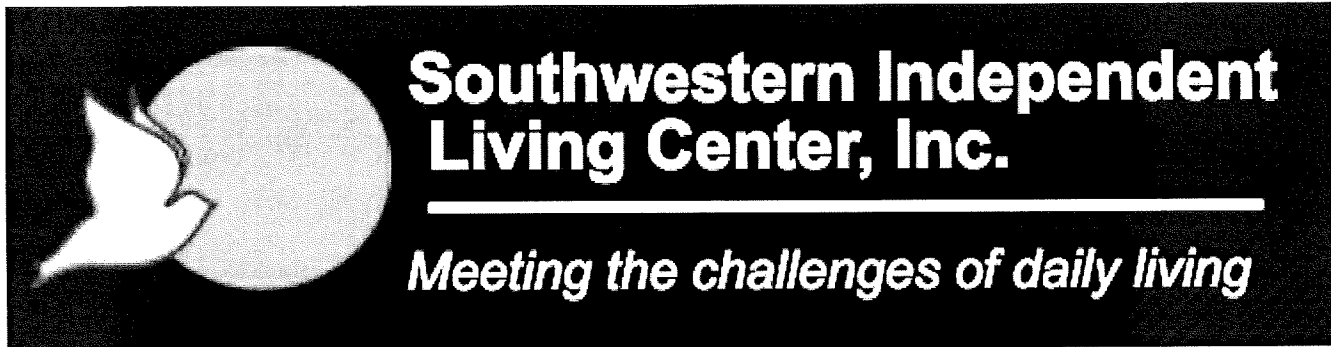

I will also have the EDDY mobile medical unit from Roswell Cancer Center; The Chautauqua Center's mobile medical unit, and Windsong Mobile Mammography unit on site for the public to utilize the day of the symposium!

This year I have 69 service providers ( at this time ) who will be present to assist those who come to the symposium! I also have guest speakers lined up for the days events! The speakers this year are: Jason Delcamp, Superintendent of Brocton Central School, a special guest speaker who will be sharing her life story of abuse, trafficking and survival and life today, PJ Wendel, Tiffany Erhard who will be addressing Medicare scams and issues elders face, Highmark Caring Place – a wonderful organization that assists children who are having difficulty handling and understanding grief after losing someone close to them, The American Heart Association, Therapy Dogs United and NAMI of Buffalo and WNY!

I also have three food trucks for lunch!

Brocton Central School, with some assistance from Fidelis Care, will be offering a free breakfast to all who attend the event!

In his senior year, he captained all three teams he participated on.

Upon graduation, PJ entered SUNY Brockport in the fall of 1988, where he majored in Physical Education/Teacher Certification. PJ was a four-year Varsity letter winner in wrestling for the nationally ranked Brockport Golden Eagles. A two-time NCAA qualifier and eventual All – American his senior year, he captained the team that finished with the schools fifth NCAA Division III National Championship. PJ graduated from SUNY Brockport with a Bachelor’s of Science Degree in Physical Education.

While attending Brockport, PJ joined the Lakewood Volunteer Fire Department, where he continues to serve the village 33 years later. Wendel is one of only three county officials nationwide to be selected to serve on this committee and is the only representative from New York State. While on the committee, he will be a voice for the unserved and underserved rural areas and hopes to help bring broadband opportunities to Chautauqua County and Western New York. In August 2021, PJ was elected to the New York Municipal Insurance Reciprocal (NYMIR) Board of Governors where he serves on the Planning and Development Committee. He was also appointed to the Board of Directors of the County Executives of America in February 2022.

PJ was also an active member of the Western New York Control Room, which was formed by New York State to facilitate a collaborative effort to address the COVID-19 pandemic among the five Western New York Counties (Allegany, Cattaraugus, Chautauqua, Erie, and Niagara.) In 2023, PJ achieved certification from NACO's Professional Development Academy's National Leadership Board for completing their High-Performance Leadership Academy. This leadership program was originally created and taught by General Colin Powell.

In 2023, PJ was re-elected to a 6 year term on the NYSAC Board of Directors where he has served on the Mental Health/Public Health Committee. PJ also has been an active member of the Chautauqua County Republican Party since 2007. He serves as the Chairman of the Town of Busti Republican Committee, where he has actively circulated petitions for the past 12 years. PJ also has been an active member of the Candidate Support Committee, Chairman's Club, and Countywide dinner committee.

PJ lives in Lakewood with his wife, Jennifer, and they have two children-- Sydney and Bohdan.

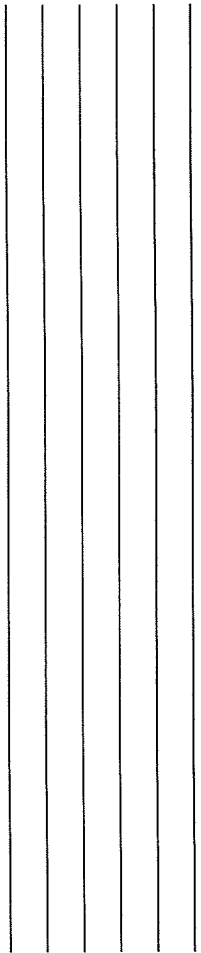
