Dear Mrs. McCoy:

This is in reference to the request filed on November 13, 2023. HFB requests an extension of the STA granted on May 23, 2023, to continue operating to operating with parameters at variance from licensed values based upon the pending 302-AM direct measurement of power LMS file # 0000220932 filed to update all operating parameters.¹ In support of the request, HFB stated that the application was filed to accommodate the new KFRN(AM) duplexing installation as discussed in the new KFRN license LMS file # 0000221067.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and HFB may continue to operate ND with tower #1/tower #2 of the array with 1.25 kW day, and ND at night with 1.0 kW on tower #1 or 1.15 kW on tower #2, or with day and night DA parameters at variance and reduced power if needed based upon the pending 302-AM application 0000220932. HFB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

¹ KLTX(AM) is licensed for DA operation on 1390 kHz with 5 kW day and 3.6 kW night using different patterns.

This authority expires on **May 19, 2024.** ²

These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
