Radio License Holding CBC, LLC ("RLH-CBC") is the licensee of Station KMGA(FM), Albuquerque, New Mexico (Fac. ID No. 11231), which appeared on the list associated with the August 6, 2021, FCC Public Notice that identified stations randomly selected for an EEO audit. KMGA(FM) is part of an Albuquerque, New Mexico station employment unit ("SEU") with commonly-owned stations KKOB(AM), KNML(AM), KKOB-FM, KRST(FM), KDRF(FM), and KBZU(FM), all located in Albuquerque, New Mexico as well as KTBL(AM) located in Los Ranchos, New Mexico.

By way of this email, Cumulus respectfully requests a brief, further extension of time to respond to the FCC's August 6, 2021 EEO Audit Letter ("Audit Letter"). Although great progress has been made, the individual in

the SEU who is most knowledgeable about its EEO performance, and absolutely essential to proper completion of this audit response, has taken very ill. We are awaiting her full recovery so we can carefully review the SEU's draft response together and present a well-organized and thorough reply to the Audit Letter. In order to accomplish this, Cumulus respectfully requests an extension of time until November 5, 2021 to complete its reply.
