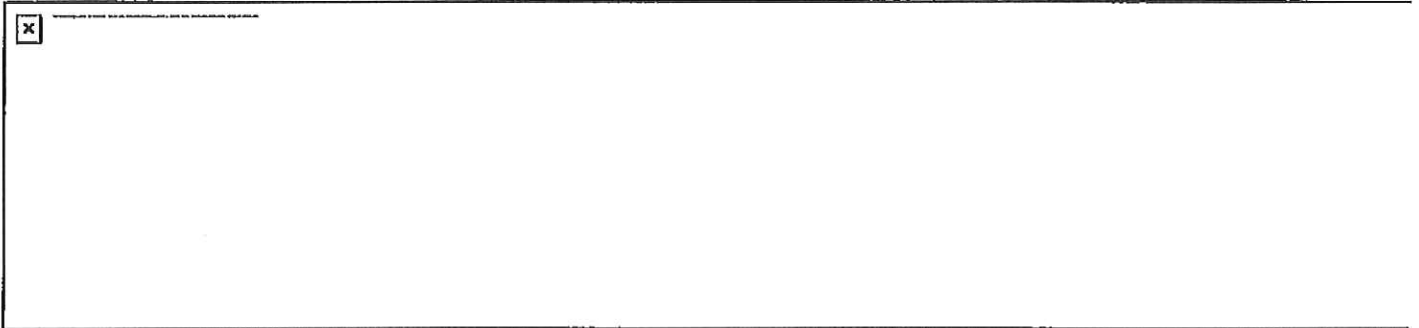

### Q1 Virtual Job Fair Set for Next Month

The NMBA will facilitate a first quarter virtual job fair next month during the week of February 13-17, 2017. This virtual job fair can provide your station with a common-sense approach to a new recruiting tool – the internet. As you well know, outreach initiatives are a major aspect of

the recruitment requirement of the FCC's Equal Employment Opportunity program. While your station works to fulfill the regulatory requirements, the virtual job fair serves as further evidence of your station's outreach effort to educate the public about the positions available at your station, as well as general information about the kinds of careers that are available in broadcasting.

*Here's how it works for you:*

To register, simply send us the call letters of the stations interested in participating and the name and email of a hiring agent at that participating station. Then, post any job openings on the NMBA website.

Beginning the Monday of the job fair, your participating stations promote the event and drive visitors to the site (BroadcastersVirtualJobFair.com). Your station can link to the site from your website and/or send listeners/viewers there directly. Keep any proof of performance for your EEO folder for the event.

During the week of the virtual job fair, your hiring agent will receive applications from visitors to the site via email. In addition, your representative may also be contacted directly by visitors requesting more information about a specific job or about the industry in general via an online comment form (keeping your email address confidential). The station's hiring agent will be responsible for responding to these comments within a reasonable amount of time during the week of the event.

At the conclusion of a successful week, your station will have access to the applications online, statistics about how many people visited the site and a letter of participation that includes any active jobs postings. While this information is archived on the BroadcastersVirtualJobFair.com site, remember to **KEEP THIS INFORMATION IN YOUR EEO FILE.**

*The NMBA would like to remind our member stations that while virtual job fairs are a viable alternative to the old-fashioned job fair held at the community center in town, virtual job fairs should be considered as a supplemental outreach program to educate the public about careers in broadcasting and the qualifications necessary to fill those positions. While participation in a virtual job fair may fulfill the single option of participating in at least four job fairs during their 2-year period, this technology has not been tested with the FCC. Nonetheless, by participating in virtual job fairs throughout your licensing period, you may be able to count some of those events as part of the third prong (supplemental efforts) of the FCC's Options Menu. Keep in mind, of course, that a station should never rely on virtual job fair participation as fulfilling their entire EEO requirement.*

*And, indeed, there are several options for fulfilling those requirements, including participating in activities sponsored by community groups, establishing an intern program, participating in scholarship programs, mentoring, training, etc.*

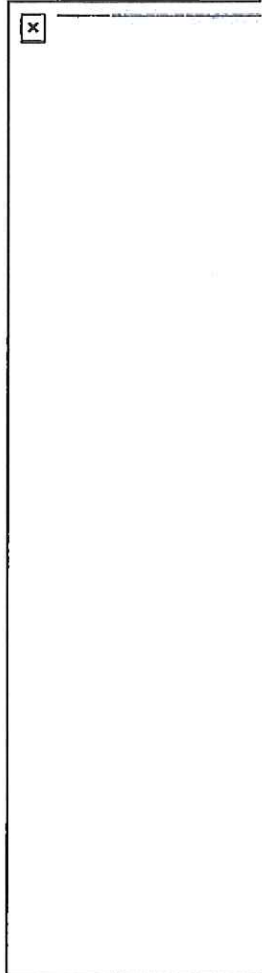

## More Music Licensing News

Recent negotiations between BMI and the RMLC have begun to reach a deal for a new contract that will be effective retroactively to January 1, 2017. The two entities could not come to terms (RMLC was pushing for lower rates) so, they are going to Rate Court.

Rate Court will set an interim rate at some point in the near future. Until that happens, BMI is suspending billing to all radio stations who have indicated they are represented by the RMLC. All stations that have authorized the RMLC to act on their behalf in negotiations with BMI for this round of license negotiations can continue to play BMI compositions after December 31, because the RMLC has submitted a license application to BMI on their behalf and applicants are licensed upon application under the BMI Consent Decree. Any operator who is unsure of a station's RMLC authorization status can contact the RMLC office for confirmation. **In the meanwhile, effective January 1, no payments need be made to BMI by RMLC-represented stations.**

When the interim rate is set, BMI will invoice the stations retroactively to January 1 of this year. When the final license is adopted (could take months or more than a year), billing will be retroactively adjusted again... either up or down, based on the outcome of the Rate Court decision.

The good news is that the market share taken from BMI by Global Music Rights (GMR) can be addressed in the new license fees.

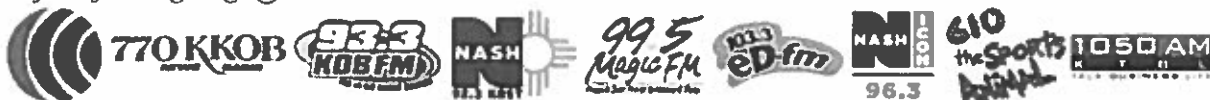
