WKIP provides its listeners with programming and public service announcements that address issues of concern to our local community. Among the issues determined to be of most concern to the community during the preceding calendar quarter were:

- **Artist & Sculpter:** Suprina, a local artist, talks about her sculptures, which often include found object (trash) as part of socially conscious art.
- **Arts:** Melissa Dvozenja-Thomas, of Arts Mid-Hudson, speaks about the upcoming 33rd Annual Dutchess County Executive's Arts Awards, a celebration of social, economic and personal effects the arts have on our community.
- **Community :** Christina Novak, Community Network Liason for Westcop SSVF, talks about the agency, what their mission is, how to volunteer and/or sponsorship opportunities.
- **Community Awareness:** Laleen Ali, Facts Coordinator and Aimee Rubin, 2019 Honor of the March on Brain Injury Foundation, speak about the history of the foundation. Aimee discusses how she was injured, her rehabilitation and recovery and how the Brain Injury Foundation played a part in her recovery. Aimee also spoke about her new role with the Foundation. They also spoke about the upcoming Walk on 9/14/19, how to get involved, sponsor and/or contribute.
- **Community Event:** Mary Albrecht, Committee Chair, and Kathy Kruger, Vendor & Sponsor Chair, of the Pleasant Valley Weekend 2019 discuss how they came to be involved in the event. They also spoke on how the tradition of the event got started and where it's heading now. They spoke about the upcoming event, it's sponsors, vendors and entertainment. Also about volunteering and outreach for the different charities involved.

Their most recent projects included a back-to-school event where hundreds of Dutchess Cty elementary school kids received free backpacks filled with school supplies. She spoke about how her interests and talents have brought her to collaborate with many artists, including Alicia Keys and Rhianna. She has also collaborated with The Poet Gold, with whom she produced a piece on the Newburgh Four, for a Black Lives Matter Collection.
- **Politics:** Dr. Lee Miringoff & Mary Griffith of the Marist Institute for Public Opinion tell how this nationally famous political poll started as-and remains-an essentially educational program for Marist Students. They explain the complexities of polling, including selecting the subject, creating the questions, collecting data, analyzing the data and disseminating the findings to the public.
- **Real Estate:** Valerie Hail, owner of Le Petit Chateau, discusses how she got into the real estate business, how the business has changed and the effects of NY State Bill 56484/A8281 on private real estate owners.
